SUBJECT: Announcement of the May 2019 Software Release

This letter provides detailed information regarding the planned release of systems changes scheduled for May 2019. The updates described in this communication will be included in the May 2019 Plan Communications User Guide v13.1, scheduled for publication on May 31, 2019.

1. Monthly Membership Report (MMR) Data File Updates

In an initiative to supply current information about plan payment, CMS will stop populating information for several outdated/obsolete fields on the MMR Data File. When Medicare Advantage Prescription Drug system (MARx) payment reports are disseminated for July 2019 (scheduled June 21, 2019), the outdated/obsolete fields will be renamed to “Filler” and contain values equal to spaces. Note, the record length (495 characters) and layout will remain the same.

The following MMR Data File fields are outdated/obsolete and will contain values of spaces after this software change is implemented:

1. Field 9 (Age Group)
2. Field 17 (Institutional)
3. Field 18 (NHC)
4. Field 22 (PIP-DCG)
5. Field 31 (Demographic Payment/Adjustment Rate (Part A))
6. Field 32 (Demographic Payment/Adjustment Rate (Part B))
7. Field 41 (Previous Disable Ratio (PRDIB))
8. Field 42 (De Minimis)
9. Field 43 (Concurrent Enrollment)
10. Field 45 (Race Code)
11. Field 48 (Original Reason for Entitlement Code (OREC))
12. Field 49 (Risk Adjustment LAG Indicator)
13. Field 51 (Enrollment Source)

2. Part B Premium Reduction for Employer Group Waiver Plans (EGWPs)

In 2017, CMS began using pre-determined benchmark Part C payment rates for EGWPs. Since EGWPs were no longer required to participate in the bid process when establishing Part C payment rates, they were not eligible to receive Medicare Advantage (MA) Rebates, such as a Part B Premium Reduction.

Beginning in 2020, CMS will give EGWPs the opportunity to offer their members a Part B Premium Reduction.

When an EGWP elects to offer Part B Premium Reduction to their members, they will be required to enter the Part B Premium Reduction amount in the Health Plan Management System (HPMS). In return, the Medicare Advantage Prescription Drug System (MARx) will reduce the monthly Part C payment by the amount of the Part B Premium Reduction.

Plan user will enter the Part B Premium Reduction amount in HPMS on the PBP Data Entry System screen – Section D:

3. Changes to MARx Plan Transaction Processing

In an effort to apply efficient and less complicated security measures within the MARx system, CMS will install changes so that the Enterprise Identity Management (EIDM) User ID is used when sending Batch Input Detail submission files.

On May 13, 2019

- The MARx Batch Input Header Record of the submission file must contain the plan submitter's EIDM User ID

Header record three (H3) error messages have been newly defined as follows:

1. Invalid User ID.
H3 USER ID NOT AUTHENTICATED: USER ID NOT FOUND
2. Inactive User ID.
H3 USER ID NOT AUTHENTICATED: INACTIVE USER
3. File does not contain records, or record length is invalid
H3 FILE DOES NOT CONTAIN ANY RECORDS OR ELSE FILE RECORD LENGTH IS INVALID
4. Header Record is Missing or Invalid
H3 HEADER RECORD IS MISSING OR INVALID
5. Invalid or Missing Header Date.
H3 HEADER RECORD DATE IS MISSING OR INVALID
6. Future Header Date.
H3 HEADER RECORD DATE IS A FUTURE CALENDAR MONTH
7. Header Date earlier than CCM.
H3 HEADER RECORD DATE IS EARLIER THAN CURRENT CALENDAR MONTH

When plans submit a Special Batch Input file which requires CMS review and approval, the **H3 and H4 rows** will contain the following messages:

1. Retro File Detected.

3. Review File Detected.

4. Special File – Invalid

5. Special File - Unknown

H3 SPECIAL FILE DETECTED, TRANSACTION COUNT DOES NOT MATCH APPROVED COUNT.
10. Special File - Undefined Transaction
H3 SPECIAL FILE DETECTED, UNDEFINED TRANSACTION CONTENT IDENTIFIED.
11. Special File - Held for Review
H3 SPECIAL FILE DETECTED, FILE HELD FOR CMS REVIEW.

Resource Access Control Facility (RACF) User Ids for Plan Submitters

Plan users who submit data to MARx will no longer be prompted to enter a (RACF) ID as part of new user registration in EIDM.

Transition Period for Submitting MARx Batch Input Header Record

There will be a transition period (May 13, 2019 – August 31, 2019) when plan submitters can transmit both the current and new MARx Batch Input Detail submission files. After August 31, 2019, plan submitters will be required to submit files using the new format.
