## 1 Introduction

### 1.1 Document Overview

The *Plan Communication Users Guide* (the Guide) provides information to Medicare Managed Care Plans and Prescription Drug Sponsors (both hereafter referred to as Plans) regarding the use of the Centers for Medicare & Medicaid Services (CMS) Medicare Advantage and Prescription Drug Program (MARx) systems.

*The Guide* provides an overview of how Plans exchange data with CMS, describing the input received from the Plans and the report and data files that are sent from CMS in response. It includes information for Plans to reference in establishing connections with CMS.

Information about the enrollment, payment, and premium withhold processes, as well as the different reconciliations and policies, are available in *the Guide*. Web site links are included to assist the user in finding the various *Medicare Managed Care Manual (MMCM)* chapters associated with the functions in *the Guide*. In addition, a section is devoted entirely to the User Interface (UI), including screen shots and instructions. Plans may use the UI to obtain online Medicare eligibility for applicants and to submit certain types of transactions. Information is available online about member enrollment, payment, premium withhold status, and amounts.

## 2 *Establishing Communication with CMS*

---

This section explains the steps necessary for communicating with CMS to submit transactions and receive monthly payments from CMS.

**Note:** Prior to this point, the organization must have established Health Plan Management System (HPMS) access, have an approved contract with CMS, and submitted all required information to allow for Part C and/or Part D transaction processing and payment. Please see the following link for instructions to obtain access to HPMS and to establish Electronic File Transfer capabilities: [Plan Connectivity Data \(PCD\) Module Technical User's Manual](#).

### 2.1 *Getting Started*

To communicate with CMS, a Plan must:

- [Establish an External Point of Contact \(EPOC\)](#).
- [Obtain a user ID and password](#).
- [Establish connection to the User Interface \(UI\)](#).
- [Establish points of contact within CMS](#).
- [Arrange payment](#).

#### 2.1.1 *Establish an External Point of Contact (EPOC)*

1. New Plans must have a valid EPOC. The requirements and processes are available in the following CMS Memo located on the Medicare Advantage and Prescription Drug (MAPD) Help Desk Web site entitled, [Designation of Individuals Authorized Access to CMS Computer Services \(IACS\) Plan User Approver/External Point of Contact \(EPOC\) –ACTION](#). Plans then send an EPOC designation letter by mail to their DPO Representative. **Note:** Registration can take up to two weeks to process. DPO approves all EPOCs who in turn approve the Plan users. EPOCs may not access the system, only approve and remove their users.
2. Once the EPOC is approved, submitters must register for their respective mailboxes. Registered submitters are approved by their Plans EPOC.
3. After the submitter is approved, if Gentran provisioning is needed, a Remedy ticket is created and sent to Enterprise File Transfer (EFT) to provision the submitter.
4. The MAPD Help Desk sends connectivity information regarding the Plan's affected contract(s) to EFT to enable Plan access for exchanging data with CMS systems.

### **2.1.2 Obtain a user ID and password**

Users of the MARx system must obtain a user ID and password. Users request an ID by registering in IACS. IACS is utilized for the registration and maintenance of Plan submitters and representatives. The Plan's EPOC is responsible for approving their personnel in accordance with established IACS policies. Plans may register new Plan users and/or modify Plan user roles by consulting the IACS system at [http://www.cms.gov/MAPDHelpDesk/07\\_IACS.asp](http://www.cms.gov/MAPDHelpDesk/07_IACS.asp), or calling the MAPD Help Desk for assistance at 1-800-927-8069.

### **2.1.3 Establish connection to the User Interface (UI)**

After obtaining a CMS user ID and password, a UI user profile is created. This profile defines the user's tasks and is based on the role(s) the user registered in IACS. Users are assigned one or more roles based on their job responsibilities. One of these roles is marked as the default. When logging on, users may accept the default role or choose one of the other roles to which they are assigned. The profile also defines which contracts users may access.

To access the UI, users must have the following software installed on their workstations:

- Windows 98 or higher
- Microsoft Internet Explorer with Web browser, Version 5.5 or higher
- Adobe Acrobat Reader, Version 4 or higher, for report viewing and display of online help. If the user does not have Adobe Acrobat Reader Version 4 or higher, the user can download a free version at ([www.adobe.com](http://www.adobe.com)).

Also, users must:

- Enable JavaScript in the browser
- Allow pop-ups from the UI site
- Disable script debugging, which is in the Internet Explorer's Internet Options under the Advanced tab
- See section 10 for UI instructions and screen descriptions.

### **2.1.4 Establish points of contact within CMS**

#### **Contact Information**

CMS provides a technical customer support mechanism for all of its external customers. The MAPD Help Desk provides quality support for all connectivity needs, as well as aid in resolving technical application issues. ### **2.1.5 Arranging payment with CMS**

The Automated Plan Payment System (APPS) calculates the final monthly payment for all types of MAPD Plans and prepares the electronic transmittal that is sent to the U.S. Treasury for payment. CMS accomplishes this by collecting Plan banking information and other identifying data from the Plans on the Payment Information Form, when the contract/PBP is activated. CMS enters the data in APPS to identify the financial institutions where the funds are deposited on the payment date. Additionally, CMS must have the Employee Identification Number/Tax Identification Number (EIN/TIN), and the associated name as registered with the IRS, for income reporting purposes to each Plan.

Plans are required to submit a completed Payment Information Form to the attention of their DPO Representative either by fax 410-786-0322 or e-mail. Plans should submit the form prior to initial enrollment to ensure timely payment.

It is the Plan's responsibility to provide CMS with updates to the banking information by submitting changes on a new Payment Information Form. This ensures the timely deposit of monthly payments and accuracy of income reported for the organization. Figure B-1 in Appendix B includes the Payment Information Form.

### ***3 Accessing the CMS Systems for Eligibility Verification***

---

For completing an enrollment request, Plans must verify Medicare entitlement for all enrollment requests either using the Medicare Advantage Prescription Drug System User Interface (MARx UI) online query, described in Section 10 of *the Guide*, the Batch Eligibility Query (BEQ) process, or CMS contractors. This section of *the Guide* describes the BEQ and response process in detail.

#### ***3.1 BEQ Process***

The BEQ Process provides a vehicle for all Plans to submit their batches of queries for individuals to obtain timely verification of Medicare eligibility, Prescription Drug Plan (PDP) eligibility, Low-Income Subsidy (LIS) information, and past drug coverage period information. This allows the Plans to determine the number of uncovered months relating to Late Enrollment Penalty (LEP). Detailed File/Record Formats are provided in Appendix F; detailed Error Code Tables for the BEQ Response File in Appendix I.

#### ***3.2 BEQ Request Processing***

Plans may submit multiple BEQ Request Files to CMS during any CMS business day, Monday through Friday, via Connect:Direct Network Data Mover (NDM) or the Sterling Electronic Mailbox, Gentran. Plan transactions are processed as received and there is no minimum or maximum limit to the number of BEQ Request Transactions that Plans may submit in a day.

The BEQ Request Files should comply with the record formats and field definitions as described in Appendix F. Plans should send BEQ Request Files in flat file structure that conform to CMS naming conventions as described in Appendix K. Detailed BEQ Error Code Tables are included in Appendix I.

CMS recognizes BEQ Request Files by the information supplied in the Header and Trailer Records. Header Record information is considered critical as CMS uses it to track, control, formulate, and route files and transactions through the BEQ process and communicate responses to the Plans.

Each transaction on the BEQ Request File should identify a prospective or current Plan enrollee. Plans may submit BEQ transactions only for individuals who have requested enrollment. Plans may not submit BEQ transactions for individuals who have not requested enrollment.

CMS generates one BEQ Response File for a Plan every time a BEQ Request is processed during a regular business day. This BEQ Response File includes BEQ Request transactions processed by CMS for the Plan for each transaction request. If a Plan submits multiple BEQ Request Files during a regular business day, that Plan receives multiple BEQ Response files, corresponding to each BEQ Request File, during that same business day.

**Note:** BEQ Response Files are not time-stamped, so the Plan must process these files immediately upon receipt.

For Plans using a Connect:Direct data transmission protocol, if a second BEQ Response File is received by the Plan prior to the Plan's processing of a previous one, a Connect:Direct transmission error results and the Plan must manually retransmit the file. Plans may call the Medicare Advantage and Prescription Drug (MAPD) Help Desk for assistance.

Plans can use the Detail Record Sequence Number located in each Transaction, i.e., Detail Record, to track individual Transactions sent to and received from CMS.

### ***3.3 BEQ Response File from CMS to Plans***

#### ***3.3.1 BEQ Response Process***

CMS analyzes a received BEQ Request File to determine the file's acceptance or rejection. CMS processes transactions of an accepted BEQ File, which creates a BEQ Response File. If a BEQ Request File is rejected, a BEQ Response File is not generated.

The system determines if a BEQ Request File is accepted or rejected based on the Request File Error Conditions, as documented in Appendix I. After determining whether a BEQ Request File is accepted or rejected, the BEQ process generates an email acknowledgement of receipt indicating one of the following outcomes:

- If the BEQ Request File is accepted, an email notification informs the Plan that the specific BEQ Request File is accepted and in process.
- If the BEQ Request File is rejected, the email notification informs the Plan of the first File Error Condition that caused the rejection. A rejected file is not returned.

This email acknowledgement/notification is issued to all submitters registered in the Individuals Authorized Access to the CMS Computer Services (IACS) for the Sending Entity contract.

CMS processes all transactions of an accepted BEQ Request File. Each Transaction is uniquely identified and tracked throughout the CMS processing service by the combination of the Contract ID of the Plan, i.e., Sending Entity, File Control Number, File Creation Date, and Detail Record Sequence Number, as provided by the Plan on the BEQ Request File.

When CMS processes a Transaction, CMS first verifies that all critical data is provided and valid on the record. CMS then attempts to perform a Beneficiary Match, in which the beneficiary identifying fields on the Transaction locate a single beneficiary and verify Medicare entitlement. Each Detail Record of the BEQ Response File maintains these four critical fields:

- If all critical data elements are not provided, subsequent processing is terminated for that transaction, including any attempt to locate, i.e., match the Beneficiary on the database and verify Medicare entitlement. The Processed Flag in the BEQ Response Detail Record is set to N and the Beneficiary Match Flag has a space. All Error Return Codes are assigned the appropriate values. See Appendix I.
- If all critical data elements are provided, CMS then attempts to perform a Beneficiary Match, in which the beneficiary identifying fields on the Transaction locate a single beneficiary on the database and verify Medicare entitlement.
- If a Beneficiary Match is found, the Beneficiary Match Flag in the BEQ Response, i.e., Detail Record is set to Y. All Error Return Codes are assigned the appropriate values. The Processing Flag is set to the value Y. See Appendix I.
- If the beneficiary is not matched, the Beneficiary Match Flag is set to N. All Error Return Codes are assigned the appropriate values. Processing Flag is set to the value N. See Appendix G.

If the beneficiary is successfully located on the database tables, CMS performs the following:

- Creates a detail record to return to the Plan in a BEQ Response File as specified in Appendix F;
- Assigns values to the Match Flag fields as defined in Appendix F; and
- Populates the additional Eligibility Query fields of the Response File Detail Record with data for the beneficiary.

**Note:** In this BEQ Response File, CMS provides the two most recent occurrences of LIS information. During an open enrollment period, CMS is unaware whether Plans are submitting queries for 2007 enrollments or 2008 enrollments. Therefore, the BEQ Response File provides the current and future LIS information, so that Plans have the correct information for the year in which they submit the enrollment transaction.

If CMS cannot locate the beneficiary on the database tables or the BEQ Request File Transaction contains critical errors, then CMS performs the following steps:

- Creates a Detail Record to return to the Sending Entity in a BEQ Response File as specified in Appendix F, BEQ Response File From CMS to Plans;
- Assigns values to the Match Flag fields as defined in Appendix F; and
- Does not populate the additional BEQ fields of the Response File Detail Record.

The BEQ Response File is issued to the Plan in the same transmission mechanism that the Plan uses to deliver the BEQ Request file to CMS. This mechanism is available through the Sterling Commerce Gentran Mailbox or through NDM Connect:Direct.

## 4 Transaction Processing

---

CMS systems process daily. Transactions are received until the end of each calendar month. Section 4.1.3 provides an explanation of Current Calendar Month (CCM). Plan-submitted transactions, including beneficiary enrollments Transaction Code (TC) 61; and disenrollments TC 51; enrollment record update TCs 72, 73, 74, 75, 76, 77, 78, 79, 80 and 81; and corrections TC 01 are processed as they enter the system, and payments are calculated separately. Transactions also enter the system throughout the processing month from other sources, e.g. CMS Customer Service Center or staff. For an overview of the methodologies that CMS employs for transaction processing, see the *Medicare Managed Care Manual (MMCM)* Chapter 2 link: [http://www.cms.gov/MedicareMangCareEligEnrol/01\\_Overview.asp](http://www.cms.gov/MedicareMangCareEligEnrol/01_Overview.asp).

At the end of each Current Processing Month, i.e., the Plan Data Due Date, the Medicare Advantage and Prescription Drug (MARx) System also calculates the final beneficiary payments and adjustments, which ultimately result in payments to the Plans for the Current Payment Month (CPM). In addition, MARx assembles the monthly reports.

### 4.1 Transaction Processing

The following steps are taken to process transactions from a Plan:

- Plans submit transaction files using Connect: Direct, Secure File Transfer Protocol (SFTP)/Hypertext Transfer Protocol over Secure Socket Layer (HTTPS). The transaction files are read and loaded into internal tables for processing, or posting.
- CMS processes the submitted transactions, resulting in actions that affect beneficiary enrollment, payment, and status.
- The user receives accepted transactions in the Daily Transaction Reply Report (DTRR). These are annotated with any resultant Transaction Reply Codes (TRCs).
- MARx calculates payments, and/or adjustments, and adds or subtracts the net dollar amount to the contract total for each month. These totals are dynamic and may change each time a transaction is processed for a contract, until the monthly payment operations are concluded and finalized.
- An unaccepted transaction results in either a failed or rejected status.
  - A *failure* results when incoming data is inconsistent with the database rules. A transaction fails during processing when it contains an error that is too severe to attempt to process and store the data in the system. For example, if the contract number is in an invalid format, the transaction is not saved in the database and therefore fails. The transaction is written to the Batch Completion Status Summary (BCSS) and transmitted to the submitter, or user, for review.
  - A *rejection* results when incoming data is of the correct type but is not successfully processed due to some inconsistency that violates an enrollment validation check or rule. For example, if the contract number does not identify a valid contract for the submitter, MARx rejects the transaction. Rejected transactions are reported on the DTRR and transmitted to the submitter, or user.

## **4.1.1 Overview of Enrollment and Payment Process**

### **4.1.1.1 Plan File Processing Responsibilities**

#### **4.1.1.1.1 Election Periods**

The term election includes both Plan enrollment and disenrollment. Enrollment is the addition of a beneficiary to a specific PBP within a Contract Number, such as an H number or an S number, and represents the organization's request for CMS payment. Disenrollment is the end of an individual's enrollment in a PBP and the termination of CMS Plan payment for the individual. Note that for the very limited number of organization types that do not have PBPs, enrollment is within the Contract Number.

A summary of the election periods and the MARx TC that Plans must use for submitted enrollment and disenrollment transactions is provided below. Plans must identify the election period that applies to the action. Table 2 summarizes the relationship between the enrollment election periods and various Plan types.

**Note:** This summary shows the data values for use in MARx; Plans must refer to the appropriate CMS Enrollment policy guidance for definitive information regarding enrollment periods and how to determine if one applies to a beneficiary request for enrollment or disenrollment. Plans are responsible for correctly identifying and reporting the enrollment period applicable to the action submitted. The guidance documents are available at (<http://www.cms.hhs.gov/home/medicare.asp>).

## 4.1.2 Enrollment/Disenrollment Requirements and Effective Dates

### 4.1.2.1 Enrollments

Plans accept enrollment requests from beneficiaries as provided in the CMS Enrollment and Disenrollment guidance applicable to their Plan type. After fulfilling the processes and requirements outlined in that guidance, the Plan must generate and submit the appropriate enrollment transaction to CMS, within the timeframes prescribed by the applicable guidance. Enrollment Transaction Records are batch submitted records with TC 61 as shown in Table 3.

The enrollment effective date reported on the Enrollment Transaction Record is the first day of the month that the beneficiary is enrolled, i.e., that the beneficiary begins receiving benefits from the Plan, and represents the first month for which the Plan is requesting payment. Plans should refer to Table 3 to determine the appropriate TC for the effective enrollment date and Plan type.

The CCM affects the enrollment and disenrollment effective dates for Plans to submit to CMS using the different TCs available, as follows:

### 4.1.2.2 Disenrollments

Plans accept disenrollment requests from beneficiaries as allowed, as provided in Chapter 2 of the *Medicare Advantage Enrollment/Disenrollment Manual*, and as applicable to the Plan type. Once the processes and requirements are fully satisfied, the Plan must generate and submit the appropriate disenrollment transaction to CMS. Additionally, Plans may, under limited circumstances, as provided in Chapter 2 of the *Medicare Advantage Enrollment/Disenrollment Manual*, report involuntary disenrollment actions. Plans should refer to the applicable guidance for more information.

The effective date of disenrollment is reported on the MARx disenrollment transaction as the first day of the month following the month enrollment ended. For example, if a beneficiary disenrolled as of March 31, TC 51 is submitted with April 1 as the effective date. The CCM is the calendar month for which MARx is currently processing transactions. The CCM begins on the first date of the calendar month and continues until the close of business on the end that same calendar month. CMS provides an annual calendar detailing the key dates for MARx processing. Appendix C provides this calendar.

The disenrollment transaction effective dates are limited according to the CCM described above.

Instructions for creating and submitting the transaction and the batch submission file are provided in Appendices F and K. Plans should note that disenrollment requests accepted by the Medicare Customer Service Center are entered into MARx using the TC 54, which only that entity can submit. Plans must include a valid disenrollment reason code on all TC 51 disenrollment transactions submitted. Table 3-5 includes the valid disenrollment reason code values:

No other disenrollment reason code values are valid or acceptable on Plan-submitted disenrollment transactions. Failure to include a valid value does not result in a rejected transaction. Instead, MARx defaults the value to TC 99. CMS may use this information to track compliance or non-compliance with program requirements. CMS-generated disenrollment actions may contain other reason code values as applicable.

Plans normally receive their payment reports the last week of the month, with the actual payment occurring the first day of the following month. The Current Processing Month changes following the close of business on the Plan Data Due Date. For example:

January 10, 20xx is the Plan Data due date, therefore:

- On January 9, 20xx, the Current Processing Month is February.
- On January 10, 20xx, the Current Processing Month is February.
- On January 11, 20xx, the Current Processing Month is March.
- The Current Processing Month remains March until the day following the next Plan Data Due Date. When this occurs in early February, the Current Processing Month changes to the next payment month, which is April, as MARx is no longer processing transactions and calculating payments for the March 1 payment.

#### ***4.1.2.3 Examples of Effective Dates on MARx Transactions***

To allow sufficient time for payment calculations, validation, and information sharing with the U.S. Treasury, MARx creates the payment data files and reports two to three weeks prior to the first day of the month for which the payment is made. This cycle is established via the MARx Plan Data Due Date each month. The timeframe from one Plan Data Due Date to the next Plan Data Due Date represents the Current Processing Month.

All transactions successfully processed for payments by MARx during the Current Processing Month are included in the monthly payment cycle and its associated reports. The Current Processing Month ends on the MARx Plan Data Due Date, i.e., the cut-off date, at 8:00 p.m. Eastern Time. The Plan Data Due Date is typically on or around the 10<sup>th</sup> of each month; however, CMS provides an annual calendar detailing the key dates for MARx processing including the Plan Data Due Date. This calendar is available in Appendix C.

Plans normally receive their payment reports the last week of the month with the actual payment on the first day of the following month. The Current Processing Month advances by one month following the close of business on the Plan Data Due Date.

Transaction processing for enrollment, disenrollment, and cancellations is decoupled from payment calculation, thereby allowing a separate schedule for transaction processing versus payment processing. MARx will accept enrollment, disenrollment and cancellation transaction effective dates based on the CCM in which a transaction is received by MARx for processing, as determined by the time and date stamp assigned by MARx upon acceptance of the transaction for processing. For example:

- January 10, 20xx is the Plan Data Due Date, and January 20xx is the current calendar month therefore:
  - On January 9, 20xx, the CPM is February.
  - On January 10, 20xx (Plan Data Due Date), the CPM is still February until 8:00 p.m.
  - On January 11, 20xx, the CPM is now March.
  - On January 1, 20xx the CCM is January until January 31, 20xx, 8:00 p.m.

- February 8, 20xx is the next Plan Data Due Date, and February 20xx is the current calendar month therefore:
  - On February 7, 20xx, the Current Processing Month is March.
  - On February 8, 20xx, (Plan Data Due Date), the Current Processing Month is still March until 8:00 p.m.
  - On February 9, 20xx, the Current Processing Month is now April.
  - On February 1, 20xx, the CCM is February until February 28 (29 on a leap year), 20xx, 8:00 p.m.

Once the CPM advances to the next month, MARx is no longer processing transactions to include in the CPM payments and begins processing transactions reflected in the next CPM. The CCM always process transactions for enrollments, disenrollments, and cancellations for the month in which the transaction falls, until the end of that month. Transactions with retroactive effective dates received and successfully processed after the Plan Data Due Date generate payment adjustments as necessary for prior months' payment.

For each of the following examples, assume that today's date is May 5 and the next Plan Data Due Date is May 10; therefore the CPM is **June** and CCM is May:

- TC 61 submitted today may have an effective date of April 1, May 1, June 1, July 1, or August 1. Payment adjustments are made on the June payment MMR;
- TC 51 submitted today may have an effective date of April 1, May 1, June 1, July 1, or August 1. Payment adjustments are made on the June payment MMR.

For each of the following examples, assume today is now May 15, which is after the next Plan Data Due Date, i.e., May 10 in this example. Therefore the CPM changes to **July** and the CCM remains May:

- TC 61 submitted today may have an effective date of April 1, May 1, June 1, July 1, or August 1. Payment adjustments are made on the July payment MMR;
- TC 51 submitted today may have an effective date of April 1, May 1, June 1, July 1, or August 1. Payment adjustments are made on the July payment MMR.

Plans must comply with CMS enrollment and disenrollment guidance requirements for the timely submission of enrollment transactions following the receipt of a valid enrollment request. To meet these submission timeframes, Plans should submit a batch file at a minimum of every week and should strive for more frequent submissions.

#### ***4.1.2.4 Reinstatement of Enrollment/Disenrollment***

Transaction Codes 80/81 removes a prior successfully processed enrollment or disenrollment action submitted by the current Plan and reinstates the beneficiary's enrollment to its prior state when MARx enrollment edits permit. Payments and premiums are also re-calculated and election period rules do not count against the beneficiary.

#### **4.1.2.5 Reinstatement Criteria**

Plans should consider the following criteria when MARx reinstates an enrollment period:

- Prior to beneficiary reinstatement, MARx evaluates the beneficiary and Plan status to ensure all values are within eligibility limits. The beneficiary is not reinstated for any month in which eligibility requirements are not met for the following subject areas:
  - Death of the beneficiary,
  - Medicare entitlement and Part D eligibility,
  - Beneficiary does not meet the health status requirements of the Plan, and
  - Plan is not open and active.
- A reinstated enrollment is not evaluated against the same rules as a new enrollment, such as timeliness of submission, Plan enrollment status, or election periods. The reinstatement qualifications are similar to the qualifications for remaining enrolled. For example, an enrollment is not reinstated when the beneficiary does not have sufficient entitlement or eligibility.
- MARx recalculates all beneficiary payments and premiums.

#### **4.1.2.6 Reinstatement of Enrollment from Erroneous Auto Disenrollments**

Changes to a beneficiary's date of death (DOD) trigger an automatic disenrollment in MARx. Sometimes these changes are reversed or refined by subsequent updates, such that the original disenrollment is no longer appropriate.

The MARx Redesign and Modernization (MARx R&M) initiative establishes a mechanism to automatically reinstate enrollments for beneficiaries who were auto-disenrolled by a report of DOD where there was a subsequent DOD correction that impacts the plan enrollment.

In conjunction with the reinstatement of enrollment, Plans receive appropriate TRCs that contain the information on the updated DOD and reinstated enrollment.

#### **4.1.2.7 Reinstatement Resulting from Erroneous Auto Disenrollment Criteria**

- Changes to the DOD effective date are applicable to auto reinstatement where Plan enrollment is impacted.
- All affected Plans receive a communication concerning reinstated enrollments.
- A reinstatement of enrollment does not exhaust or count against a beneficiary's usage of an election period.
- A corrected DOD that results in an earlier DOD also adjusts the Plan disenrollment.

#### **4.1.2.8 EGHP**

The Plan must set the EGHP Flag field to Y when submitting enrollment transactions for any beneficiary requesting enrollment into an employer or union group sponsored Plan. This includes Direct Contract, 800 series, and individual Plan enrollments. Plans should set this flag to Y for TC 61. Additionally, Plans may directly submit enrollment and disenrollment for EGHP members up to two additional months retroactive to the CCM range. Appendix F provides more details.

#### **4.1.2.9 ESRD Override Enrollment in MA and Cost Plans**

The Prior Commercial Code field is used when an individual with ESRD is eligible to enroll in an MA or Cost Plan, as determined by the Plan, under any one of the exceptions to the ESRD eligibility rule, as provided in the CMS enrollment guidance applicable to the Plan type. It is critical that the Plan include this code in the enrollment transaction to ensure the enrollment is successful. If the Plan omits the code, MARx rejects the enrollment record if there is already an ESRD indicator in the MARx database or MARx receives a retroactive ESRD status.

The Prior Commercial Code is indicated in Position Number 80 on the Enrollment/Disenrollment/Change Transaction record layout. The available code values are 0 through 9 and A through F, with which CMS previously recorded the number of months a beneficiary was enrolled in the commercial part of the Plan. Currently Plans should use code F in the Prior Commercial Months field for all cases.

#### **4.1.2.10 MA/MAPD Plans**

MA/MAPD eligible individuals may not enroll in more than one MA/MAPD Plan at any given time. Individuals enrolled in an MA Plan may not hold concurrent enrollment in a PDP, except for individuals enrolled in an MSA Plan or individuals enrolled in a PFFS Plan that does not offer Medicare prescription drug coverage.

#### **4.1.2.11 Part D Plans**

A Part D eligible individual cannot enroll in more than one PDP at the same time. A Part D eligible individual cannot simultaneously enroll in a PDP and an MA Plan except for an MA-PFFS Plan that does not offer the Part D benefit or an MSA. A beneficiary can enroll in a Part D Plan while enrolled in a Cost Plan but may not also enroll in the Cost Plan's optional supplemental Part D benefit.

### **4.2 Cost Plan Transaction Processing**

Because beneficiaries can choose to enroll in separate or stand-alone PDPs and enroll in or remain enrolled in a Cost Plan, CMS uses PBP-level processing for Cost Plan organizations. CMS performs the following:

- The Health Plan Management System (HPMS) provides available drug and non-drug PBP numbers for Cost Plans to MARx. If the Cost Plan does not have an approved non-drug PBP, HPMS generates a dummy non-drug PBP number of 999 for this Plan. This is unnecessary for drug PBPs, as Cost Plans are required to create drug PBPs.

Beneficiaries who are members of a non-drug PBP of a Cost Plan may elect to obtain Part D coverage through the Cost Plan if it is offered as an optional, supplemental benefit by the Cost Plan or through a separate PDP.

### **4.3 Production Schedule**

The following section describes the processing flows for submitting transactions to and receiving reports from CMS. In general, transaction processing occurs monthly for a CCM until a cutoff date, and ends at the end of each month. At the cut-off date, new transaction processing is suspended. The month-end process performs final summarization of beneficiary level payments to Plan level payments. While CMS reviews monthly payments for approval, Plan transaction processing resumes for the next month. Once CMS approves the monthly payments, reports are distributed to the Plans.

#### **4.3.1 System Interfaces**

##### **4.3.1.1 HPMS**

- HPMS contains complete information about contracts between Plans and CMS. As such, it provides the basis for validating contract, PBP, segment numbers and service areas. Most importantly, HPMS identifies the type of contract and the Payment Bill Option (PBO) code, which is linked to rules for enrollment and payment. HPMS also provides MARx with information about terminations; rollovers; where some or all beneficiaries in one contract automatically move to another contract; payment rates; and rebate amounts. MARx receives reports regarding changes to contract and Plan information. If changes affect payment, MARx calculates a new payment and any appropriate adjustments.

##### **4.3.1.2 Risk Adjustment System (RAS)**

- RAS provides MARx with beneficiary-specific, risk-adjusted factors for calculating Part C and Part D payments. Based on each beneficiary's medical history, the factors reflect claims and encounter data.
- Risk-adjusted factors are calculated annually. They are updated midyear and reconciled within nine months after the end of the year. When these changes occur, MARx automatically recalculates payments and appropriate adjustments.

##### **4.3.1.3 APPS**

- Upon successful enrollment, MARx calculates prospective Plan payment amounts for newly enrolled beneficiaries. At the end of the monthly payment cycle, payments and enrollments are summarized at segment, PBP, and contract levels in different monetary categories and transmitted in files to APPS.
- If CMS finds no problems during month-end payment validation, CMS certifies, or approves, the month's processing and allows APPS to generate a file of payment records. This file is passed to CMS' main accounting system, then to the U.S. Treasury, which initiates wire transfers to the Plans.
- If CMS finds a problem, built-in backup procedures allow reprocessing of all or part of the monthly production run.

#### **4.3.1.4 MBD and Enrollment Database (EDB)**

Many MARx operations require the MBD and EDB beneficiary information such as:

- Entitlement to Medicare Part A, Part B, and Part D.
- Health status, other than institutional and NHC coverage.
- Part C and Part D premium options.
- Address.

MBD notifies MARx when the beneficiary information changes, so that MARx can determine validity of the beneficiary's enrollment and whether payments need adjustment.

#### **4.3.1.5 Social Security Administration (SSA)**

MARx communicates certain Part B, Part C, and Part D data from CMS to SSA, and then communicates SSA's acceptance or rejection of the transactions associated with that premium to the Plans. Transmissions to SSA occur periodically throughout a Current Operation Month (COM). The bulk of these transmissions occur during the COM in a schedule window called the Can Meet Period. Changes in beneficiary status that occur in the period since the last Can Meet transmission window are sent to SSA in the Can Meet Period. Also, in this period, CMS determines special populations to send to SSA. In the COM, but outside of the Can Meet Period, MARx communicates Part B, Part C, and Part D data from CMS to SSA only for Congressional or other high priority cases.

#### **4.3.1.6 Railroad Retirement Board (RRB)**

MARx also communicates Part B, Part C, and Part D information to the RRB. MARx receives and processes transaction requests impacting RRB beneficiaries and forwards them to RRB for processing. After processing the request, RRB informs MARx whether the request is accepted or rejected.

#### **4.4 Transaction Reports**

MARx communicates a transaction disposition through a variety of reports transmitted to the Plan. Upon receipt of a transaction file, BCSS transmits to the Plan representative-transmitter who submitted the file. Following the completion of a batch process, DTRR transmits to the user. DTRR provides a disposition for the transactions submitted daily, along with results from various system notifications and CMS actions.

To allow Plans to automate processing, they receive many of the daily and monthly reports in a data file format. Appendices F and J provide reports and data file details. Plans may correct and resubmit failed and rejected transactions for processing. Plans validate payments at the beneficiary level based on information, i.e., enrollment, disenrollment, cancellation, applicable health statuses, effective at the time of processing. This information is available via the DTRR and several payment reports and data files. Payment reports include the Monthly Membership Detail Report (MMDR) and Monthly Membership Summary Report (MMSR).

##### **4.4.1 General**

CMS provides access to its reports to allow Plans to view their Medicare membership information. In general, these reports allow Plans to compare Medicare membership and payment information with their internal records to assist them in identifying and correcting any discrepancies. Each report is described in detail below. Appendices F and J provides record layouts and examples of the following reports.

##### **4.4.2 BCSS**

Created to insure Plans confirm the status of their transactions submitted to CMS in a timely manner, BCSS is a two- part report that includes an Enrollment Transmission Message File, or STATUS. When a file is received by CMS, a status report summarizes the Plan's submission.

The Plan later receives a BCSS Report with details for the initial status report. Plans begin their enrollment reconciliation process after receiving their BCSS Report. Appendix F.3 provides more information on this file.

##### **4.4.3 Daily Transaction Reply Report (DTRR)**

To assure Plans receive proper payment, the Plan's Medicare membership records must agree with those reported to and maintained by CMS. The DTRR identifies whether a submission for a beneficiary was accepted or rejected, and also provides additional information about Plan membership.

The response for each beneficiary included in the report is called a transaction record. There are two types of records:

- **Reply Records** - indicate the types of CMS action taken on the transactions submitted daily, if transactions were received and processed.
- **Maintenance Records** - indicates existing membership records were updated because CMS has initiated action to change or update.

Upon receipt of the DTRR, it is important that Plans continue to reconcile their beneficiary records with these reports. If Plans encounter potential system problems, they should report them to the MAPD Help Desk. Plans should submit corrected transactions to CMS promptly.

Each record is supplied to Plans for a specific purpose that is defined by the TRC. A three-digit reply code is supplied for each record. The numerical reply code information on the report is the same whether it is a data file or printed report. A remarks column appears at the end of the record in the printed report, which may provide further explanation. Reply code definitions are provided in Appendix I. Appendices F.15 and J.14 provide more information on this file.

#### **4.4.4 MAPD/Cost Plan Full Dual Auto Assignment Notification File**

CMS has directed the following organizations to auto/facilitate enroll Low-Income Subsidy (LIS) beneficiaries from their MA-only Plan into a MAPD Plan or Cost Plan Part D optional supplemental benefit:

- MA organizations that offer MA-only Plans;
- MA PFFS organizations that offer at least one Plan with a Part D benefit; and
- 1876 Cost Plans that offer at least one Plan with a Part D optional supplemental benefit.

**Note:** This file is driven by the Medicare Beneficiary Database (MBD) Application. The organization must first identify LIS beneficiaries in its MA-only Plan or Cost Plan without Part D, e.g., those beneficiaries identified on the LIS bi-weekly report. The organization must then determine the full-dual eligible subsets, which is accomplished by consulting the monthly MA Full Dual Auto Assignment Notification File. The MA Full Dual Auto Assignment Notification File identifies those who held full-benefit dual eligibility at any time during the calendar year. The organization must distinguish between the two populations because the effective date is calculated differently for full dual eligible for whom the organization auto-enrolls versus non-full dual eligible with LIS for whom the organization facilitates enrollment.

For information on the file layout, Plans should refer to Appendix F; for information on this file's naming standards, Plans should refer to Appendix K.

#### **4.4.5 PDP Notification File for AE-FE (including Beneficiary Addresses)**

AE-FEs assign a PDP Notification File, which provides additional early notification to PDPs of beneficiaries receiving CMS AE-FE notices indicating assignment to the user's Plan. Each October, it also provides information on individuals gained and lost due to reassignment. It provides LIS information and immediate access to full name and address data for these beneficiaries. 1-800-MEDICARE Customer Service Representatives (CSRs) should have access to the data on this file so they can answer beneficiary queries prior to the PDP auto/facilitated enrollments. Additionally, this file assists Plans in expediting the submission of the 4Rx records for these beneficiaries.

PDPs may receive this file daily throughout the month. This file only contains assignments, not confirmation that MARx processed AE-FE transactions for beneficiaries. Plans must still check DTRRs to determine whether the assignments were accepted or rejected as actual enrollments into their PDP. These reports offer two ways for Plans to differentiate between the full and non-full dual eligible beneficiaries assigned to them. One option is the monthly PDP notification file and the DTRR, Enrollment Type = **A** for auto-enrollment or **C** for facilitated enrollment. A second option on the DTRR is TRC 117 = Auto-enrollment, and TRC118 = Facilitated enrollment.

For information on the file layout, Plans should refer to Appendix F; for information on this file's naming standards, Appendix K.

If a current member elects to obtain Part D through the Cost Plan, the Plan submits a TC 61 to move the member from the non-drug PBP to the drug PBP, including the valid election type and Part D premium-related information. If a current member elects to obtain Part D through a PDP while remaining in the Cost Plan, the Cost Plan submits no transactions. When the PDP submits a TC 61 to enroll the beneficiary, CMS does not disenroll the member from the Cost Plan.

If a current member enrolled in the Part D benefit of the Cost Plan requests to drop Part D, i.e. move from the drug PBP to the non-drug PBP, the Plan submits a TC 61 transaction to move the member and includes the valid election type that permits the disenrollment from Part D.

- If a new member elects to enroll in the non-drug portion of the Cost Plans, the Plan submits a TC 61 with a non-drug PBP number. The number 999 is used if the user does not have a non-drug PBP approved in HPMS.
- If a new member elects to enroll in the drug portion of the Cost Plans, the Plan submits a TC 61 with the drug PBP number, election type, and Part D premium-related information.

The following clarifications related to election periods also impact Cost Plans. In two of the three scenarios, the user must specify an election type:

- Enrollment into a Cost Plan's non-drug PBP from FFS or a non-MA Plan does not require the specification of an election type. The beneficiary does not utilize an election when enrolling in non-MA or non-Part D Plans.
- Enrollment into a Cost Plan's non-drug PBP requires that the member specify whether they are enrolled in an MA or MAPD. This occurs because the beneficiary must utilize an election to disenroll from the latter Plan types. At the time of enrollment, the Cost Plan may need to query the beneficiary if they are currently enrolled in an MA Plan.
- Enrollment into, or disenrollment from, a Cost Plan's drug PBP always requires the specification of a Part D election type of AEP, IEP, or SEP. The beneficiary must request enrollment during an enrollment period.

#### **4.4.6 Monthly Full Enrollment File Data (FEFD)**

FEFD provides Managed Care and Prescription Drug organizations with their official membership list on record with CMS. This invaluable tool reconciles Plan membership records with CMS records. Plans receive FEFD with their other monthly reports. Appendix F.16 provides more information on this file.

#### **4.5 Agent Broker Compensation Cycles**

For Plan enrollments, MARx established a status of initial or renewal as well as a six-year compensation cycle. This status provides Plans with the information necessary to determine how to pay agents for specific beneficiary enrollments. Plans pay agents an initial amount or a renewal amount as provided in the CMS agent compensation guidance.

Based on the qualification rules, year 1 is the initial year and years 2 through 6 are the renewal years. Plans are responsible for using this information together with their internal payment and enrollment tracking systems to determine if an agent was used and the amount to pay the agent.

The Agent Broker Compensation Report Data File is generated and sent to Plans along with the first DTRR of each calendar month and reports the following:

- All new enrollments, whether retroactive, current, or prospective, with 6-year broker compensation cycles.
- All changes to existing and prior enrollments as a result of retroactive enrollments and disenrollments.
- Increments to cycle-year counts each January 1<sup>st</sup>.

Plans can re-order the Agent Broker Compensation Report Data File via the User Interface (UI). The detailed file layout for the Agent Broker Compensation Report Data File is located in Appendix F as report #29.

- The file naming convention for this data file is located in Appendix K.

## 5 Payment Process and Calculations

---

The capitation payments provided to Medicare Advantage (MA) and Medicare Advantage and Prescription Drug (MAPD) sponsors calculate and pay monthly. These estimated payments are based on system information at the time the monthly payment is made. Part C payments are finalized annually with the final reconciliation of risk adjustment data. Part D payments are finalized annually with the final reconciliation of prescription drug event data.

As changes to beneficiary or Plan data are received, adjustments are made to monthly payments. Changes cause a recalculation of one or more payment components. The adjustments are processed retroactively to the change effective date and reported to the Plans on the monthly payment reports.

**Note:** Policy dictates that the actual payment adjustments are generally limited to the three-year period preceding the current payment month. This limitation is known as the 36-Month Rule.

The 36-Month Rule specifically states that retroactive corrective payment adjustments, both positive and negative, are limited to a three-year period. This period precedes the month of receipt of any data that would indicate a change in the calculated plan payment for a specific beneficiary or Plan payment component. These changes could include demographic adjustments such as age, sex or county of residence, or other indicators that reflect Medicare payment levels, such as End Stage Renal Disease (ESRD) or Medicare Secondary Payer (MSP) status. The three-year limitation ensures consistency with other Medicare payment limitations, and applies to payments for all types of Managed Care Organizations (MCOs).

### 5.1 Part C Payments

This section provides an overview of Part C payment calculation. Part C payments are paid to an MCO in exchange for providing Medicare Part A and/or B coverage to Medicare beneficiaries enrolled in the MCO.

An overview of the methodologies that CMS employs to reimburse all types of Medicare Advantage (MA) Plans is available at the *Medicare Managed Care Manual (MMCM)* Chapter 8 link: <http://www.cms.gov/manuals/downloads/mc86c08.pdf>.

Before the payment process begins, the beneficiary initiates the enrollment application; the Plan checks the eligibility of the beneficiary, and then transmits an enrollment transaction to CMS. If the enrollment transaction is accepted, CMS calculates the Part C payment. If CMS rejects the enrollment, the Plan is notified. The Plan must correct the rejected information, if possible, and resubmit the transaction.

The calculation of Part C payments varies by, and is separately described for, the following:

- [Beneficiaries electing Hospice Coverage.](#)
- [Beneficiaries with End Stage Renal Disease \(ESRD\).](#)
- [Aged or Disabled Beneficiaries enrolled in an MA Plan.](#)
- [Aged or Disabled Beneficiaries enrolled in a Program for All-Inclusive Care for the Elderly \(PACE\) Plan.](#)
- [When Medicare Secondary Payer \(MSP\) Status applies.](#)

This section does not describe Part C payment for beneficiaries enrolled in Cost Plans, Healthcare Prepayment Plans, Chronic Care Demonstrations, and Medical Savings Account (MSA) Plans. Please refer to the following reference table for calculating Part C Payments.

**5.1.1 Part C Payments for Beneficiaries electing Hospice Coverage**

Traditional Medicare Fee-for-Service (FFS) provides Medicare Part A and B benefits for a beneficiary electing Hospice coverage. If the beneficiary is already enrolled in an MA Plan at the time of election, the Part C payment to the MA Plan is only for extra benefits provided by the Plan that are not provided by FFS.

The Part C payment is equal to the MA rebate, excluding any MA rebates for Part B premium reduction and Part D basic premium reduction; otherwise, it equals zero.

- Part C Payment = Total MA Payment (#66) = Total MA Payment Part A (#64) + Total MA Payment Part B (#65).
- Total MA Payment Part A (#64) = MA Rebate Part A Cost Sharing Reduction (#56) + MA Rebate Part A Other Mandatory Supplemental Benefits (#58) + MA Rebate Part A Part D Supplemental Benefits (#62).
- Total MA Payment Part B (#65) = MA Rebate Part B Cost Sharing Reduction (#57) + MA Rebate Part B Other Mandatory Supplemental Benefits (#59) + MA Rebate Part B Part D Supplemental Benefits (#63).

### **5.1.2 Part C Payments for Beneficiaries with ESRD**

Medicare Part A and B benefits for beneficiaries with ESRD are provided by their Plans. The applicable monthly payment rates are set by CMS and remain outside the bidding process. Beneficiaries in Dialysis or Transplant statuses are paid State rates. Beneficiaries in Functioning Graft Status receive payment using CMS benchmark county rates.

For beneficiaries with ESRD enrolled in an MA plan where an MA Rebate for Part B Premium Reduction or MA Rebate for Part D Basic Premium Reduction is applicable, beneficiaries receive these rebate benefits through their enrollment in the Plan, despite the fact that the Part C risk-adjusted payment is not based upon the Plan's bid. The risk-adjusted portion of the Part C payment is therefore reduced by the MA Rebate premium reduction benefits to make room to provide the required rebate benefits.

For beneficiaries with ESRD enrolled in a PACE plan, the Part C Payment calculations are exactly the same as if enrolled in an MA Plan, except MA Rebates are not applicable.

- Part C Payment = Total MA Payment (#66) = Total MA Payment Part A (#64) + Total MA Payment Part B (#65).
- Total MA Payment Part A (#64) = RA Payment Part A (#33) - MA Rebate Part A for Part B Premium Reduction (#60) - MA Rebate Part D Basic Premium Reduction (Part A portion) (#72).
- RA Payment Part A (#33) = Part A Monthly Payment Rate (#89) \* RA Factor A (#24).
- Total MA Payment Part B (#65) = RA Payment Part B (#34) - MA Rebate Part B for Part B Premium Reduction (#61) - MA Rebate Part D Basic Premium Reduction (Part B portion) (#72).
- RA Payment Part B (#34) = Part B Monthly Payment Rate (#90) \* RA Factor B (#25).

### **5.1.3 Part C Payments for Aged or Disabled Beneficiaries enrolled in an MA Plan**

Calculation of Part C Payments for Aged/Disabled Beneficiaries in an MA Plan depends upon the relationship of the plan's A/B Bid to the applicable CMS Benchmark.

#### **5.1.3.1 Plan's A/B Bid Equal to CMS Benchmark**

- Part C Payment = Total MA Payment (#66) = Total MA Payment Part A (#64) + Total MA Payment Part B (#65).
- Total MA Payment Part A (#64) = RA Payment Part A (#33)
- RA Payment Part A (#33) = Part A Monthly Payment Rate (#89) \* RA Factor A (#24).
- Total MA Payment Part B (#65) = RA Payment Part B (#34)
- RA Payment Part B (#34) = Part B Monthly Payment Rate (#90) \* RA Factor B (#25).

**5.1.3.2 Plan's A/B Bid Less than CMS Benchmark (MA Rebate Applies)**

- Part C Payment = Total MA Payment (#66) = Total MA Payment Part A (#64) + Total MA Payment Part B (#65).
- Total MA Payment Part A (#64) = RA Payment Part A (#33) + MA Rebate Part A Cost Sharing Reduction (#56) + MA Rebate Part A Other Mandatory Supplemental Benefits (#58) + MA Rebate Part A Part D Supplemental Benefits (#62).
- RA Payment Part A (#33) = Part A Monthly Payment Rate (#89) \* RA Factor A (#24).
- Total MA Payment Part B (#65) = RA Payment Part B (#34) + MA Rebate Part B Cost Sharing Reduction (#57) + MA Rebate Part B Other Mandatory Supplemental Benefits (#59) + MA Rebate Part B Part D Supplemental Benefits (#63).
- RA Payment Part B (#34) = Part B Monthly Payment Rate (#90) \* RA Factor B (#25).

**5.1.3.3 Plan's A/B Bid Greater than CMS Benchmark (Part C Basic Premium Applies)**

- Part C Payment = Total MA Payment (#66) = Total MA Payment Part A (#64) + Total MA Payment Part B (#65).
- Total MA Payment Part A (#64) = RA Payment Part A (#33) - Part C Basic Premium Amount Part A (#54).
- RA Payment Part A (#33) = Part A Monthly Payment Rate (#89) \* RA Factor A (#24).
- Total MA Payment Part B (#65) = RA Payment Part B (#34) - Part C Basic Premium Amount Part B (#55).
- RA Payment Part B (#34) = Part B Monthly Payment Rate (#90) \* RA Factor B (#25).

**5.1.4 Part C Payments for Aged or Disabled Beneficiaries enrolled in a PACE Plan**

Part C Payment calculations for Aged/Disabled Beneficiaries in a PACE Plan are based upon monthly payment rates set by CMS which, like ESRD, remain outside the bidding process. MA Rebates and Part C Basic premiums are components of bid-based payments and do not apply. Aged/Disabled Beneficiaries enrolled in a PACE Plan who reside in a community setting also receive a Frailty Factor Adjustment in addition to the normal Risk Adjustment.

- Part C Payment = Total MA Payment<sup>1</sup> (#66) = Total MA Payment Part A (#64) + Total MA Payment Part B (#65).
- Total MA Payment Part A (#64) = RA Payment Part A (#33).
- RA Payment Part A (#33) = Part A Monthly Payment Rate (#89) \* (RA Factor A (#24) + Part C Frailty Score (#81)).
- Total MA Payment Part B (#65) = RA Payment Part B (#34).
- RA Payment Part B (#34) = Part B Monthly Payment Rate (#90) \* (RA Factor B (#25) + Part C Frailty Score (#81)).

### **5.1.5 Part C Payments When Medicare Secondary Payer (MSP) Status Applies**

Medicare is a secondary payer for Aged or Disabled beneficiaries with employer-provided health insurance, or for beneficiaries with ESRD, during the coordination of benefits period. When MSP Status applies, the risk-adjusted portion of the Part C Payment is reduced to account for the coverage that the employer provides for Working Aged or Working Disabled beneficiaries, or that the health plan provides for beneficiaries with ESRD.

The MSP Reduction Amount is an additional Part C payment adjustment that is applied after all other calculations described in the previous sections are completed.

For Part C Payments involving an MA Rebate, the Rebate is ignored in computing the MSP Reduction Amounts:

- Part C Payment = Total MA Payment (#66) = Total MA Payment Part A (#64) + Total MA Payment Part B (#65).
- Total MA Payment Part A (#64) = Total MA Payment Part A (#64) - MSP Reduction Amount Part A (#83).
- MSP Reduction Amount Part A (#83) = RA Payment Part A (#33) \* (1 - MSP Factor (#82)).
- Total MA Payment Part B (#65) = Total MA Payment Part B (#65) - MSP Reduction Amount Part A (#84).
- MSP Reduction Amount Part B (#84) = RA Payment Part B (#34) \* (1 - MSP Factor (#82)).

For Part C Payments involving a Part C Basic Premium, the Premium is subtracted from the RA Payment before computing the MSP Reduction Amounts:

- Part C Payment = Total MA Payment (#66) = Total MA Payment Part A (#64) + Total MA Payment Part B (#65).
- Total MA Payment Part A (#64) = Total MA Payment Part A (#64) - MSP Reduction Amount Part A (#83).
- MSP Reduction Amount Part A (#83) = (RA Payment Part A (#33) - Part C Basic Premium Amount Part A (#54)) \* (1 - MSP Factor (#82)).
- Total MA Payment Part B (#65) = Total MA Payment Part B (#65) - MSP Reduction Amount Part A (#84).
- MSP Reduction Amount Part B (#84) = (RA Payment Part B (#34) - Part C Basic Premium Amount Part B (#55)) \* (1 - MSP Factor (#82)).

## 5.2 Part D Payments

### 5.2.1 General

This section provides an overview of Part D payment calculation. MCOs receive Part D payments in exchange for providing Medicare Part D coverage to Medicare beneficiaries. For information on the methodologies that CMS uses to reimburse Prescription Drug Plans (PDPs) and the importance of their role in the success of CMS payment efforts, see *MMCM* Chapter 17 at <http://www.cms.gov/manuals/downloads/mc86c15.pdf>.

Before the payment process begins, the beneficiary initiates the enrollment application. The Plan checks the beneficiary’s eligibility, and then transmits an enrollment transaction to CMS. If the enrollment transaction is accepted, CMS finalizes the accepted enrollment and notifies the Plan, which then notifies the beneficiary. If CMS rejects the enrollment, the Plan is notified and must correct the rejection reason. With an accepted enrollment transaction, CMS calculates the Part D payment.

Several Part D Payment components are estimated amounts subject to a cost-based annual Part D payment reconciliation; these results are reflected on the Plan Payment Report (PPR) and not on the Monthly Membership Report (MMR). The estimated payments are:

- Part D Low-Income Cost-Sharing (LICS) Subsidy.
- Part D Reinsurance Subsidy.
- Part D Coverage Gap Discount Amount<sup>2</sup>

Please refer to the following reference table for calculating Part D Payments:

### **5.2.2 Calculation of the Total Part D Payment**

The Total Part D Payment (#77) for a beneficiary is the sum of the following amounts; no individual payment includes all components:

- Part D LIPS (#35).
- MA Rebate Part D Basic Premium Reduction (#72).
- Part D Direct Subsidy Amount (#74).
- Part D Reinsurance Subsidy (#75).
- Part D LICS Subsidy (#76).
- PACE Part D Premium Add-on (#79).
- PACE Part D Cost Sharing Add-on (#80).
- Part D Coverage Gap Discount Amount (#86).

### **5.2.3 Calculation of the Part D Direct Subsidy**

The Plan's Part D bid is reported on the MMR and shown below as the Part D Monthly Payment Rate. The Part D Basic Premium Amount reported on the MMR, and included in the formula below, is not necessarily the same as the premium paid by the beneficiary but an amount specifically calculated for use in this payment formula.

**Note:** It is possible for the Part D Direct Subsidy calculation to result in a negative amount for an individual beneficiary.

- Part D Direct Subsidy Amount (#74) = (Part D Monthly Payment Rate (#91) \* Part D RA Factor (#67)) - Part D Basic Premium Amount (#73).

### 5.3 Part D Creditable Coverage and Late Enrollment Penalty (LEP)

Medicare-eligible beneficiaries are legally required to have prescription drug coverage, either from a Medicare PDP or a non-Medicare equivalent insurer that provides drug coverage. If a Medicare-eligible beneficiary does not have prescription drug coverage after Part D eligibility is established, an LEP is assessed against the beneficiary. The penalty is added to the Part D premium once the beneficiary is enrolled in a Medicare PDP.

To establish whether or not a beneficiary is assessed an LEP, Plans must determine the number of months in which a Medicare-eligible beneficiary did not have creditable drug coverage for a continuous period of 63 days or more, and report this as the Number of Uncovered Months (NUNCMO) to CMS. CMS calculates the LEP by multiplying a percentage, currently 1 percent, of the national base beneficiary Part D premium for the current coverage year by the total NUNCMO, regardless of the year(s) in which those months occurred. This calculation occurs annually because the percentage and the base beneficiary Part D premium changes each year. Chapter 4 of the *Medicare Prescription Drug Benefit Manual* provides more details: <http://www.cms.gov/manuals/downloads/mc86c04.pdf>.

Plans report the NUNCMO to CMS by including it on an enrollment, Transaction Code (TC) 61 or separately on a TC 73 if the determination is made after the enrollment transaction is submitted. If there are no uncovered months to report, Plans must place a Y in the creditable coverage field and 000 in the NUNCMO field. If there are uncovered months to report, Plans place an N in the creditable coverage field and the applicable number in the NUNCMO field.

An R value in the creditable coverage field resets a NUNCMO value to zero as of the transaction effective date. This could occur, for example, if the beneficiary has a new Part D Initial Enrollment Period (IEP) or if the beneficiary becomes Low-Income Subsidy (LIS) eligible. The Plans cannot use the R value to correct existing NUNCMO data. The outcome of the Reset action is two distinct periods of NUNCMO; the original period with an end date, followed by the new Reset period where the NUNCMO value was reset to zero going forward. A U value in the creditable coverage field reverses a previously submitted R, or Reset, only. Each of the above values is associated with the effective date of a Part D enrollment period. Only the R value is associated with a date within a Part D enrollment period.

The table below summarizes the actions Plans should take to submit NUNCMO data:

## **5.4 Payment Reports**

### **5.4.1 General**

CMS reports contain Plan Medicare membership and payment information as indicated in CMS systems for that current payment month (CPM). In general, these reports allow Plans to compare Medicare membership and payment information with the Plan's internal records to assist Plans in identifying and correcting any discrepancies. Each report is described in detail below. Appendices F and J provide record layouts and examples of the following reports.

### **5.4.2 Monthly Membership Report (MMR)**

The MMR is available in both print image and the data file format. Created monthly, the MMR provides information to Plans for reconciling the Plan Medicare membership and payment records to CMS records. This report does not reflect the deduction of the Balanced Budget Act of 1997 (BBA) user fee or any bonus payments. The Plan Payment Report (PPR) indicates that amount.

The print image report is actually three reports: two detailed and one summary.

- The print image report provides beneficiary-level detail for Part C payments. A second print image report, containing beneficiary-level Part D payment detail, is available for MAPDs and PDPs. Finally, a detail data file for both Part C and Part D payments and a summary data file are also available.
- The print image summary report presents a summary of the payments and adjustments applicable to the Plan's Medicare membership. For example, this format indicates the total number of beneficiaries that received a hospice, ESRD, or institutionalized payment.
- The MMR total amount should match the PPR total payment. The MMR reflects RA information. Since all Plans are 100 percent risk-adjusted, the RA payment method is reflected on the MMR. The report continues to display beneficiary-level status and also includes RA factor and payment rate information. Both the print-image and the downloadable data file contain this data. Appendices F.9, F.10 J.5 and J.6 contain more information on this file.

### **5.4.3 Plan Payment Report (PPR)**

The PPR is also referred to as the Payment Letter, and displays the payment amount wired by the U.S. Treasury to the Plan's bank account each month, including the Part A/Part B and Part D payment amounts. The PPR contains the total number of members and the amount paid for those members for the upcoming month, prospectively. The report also shows Plan-level adjustments for that payment amount.

This report itemizes the final monthly payments to the Plans. Produced by the Automated Plan Payment System (APPS) when final payment is calculated, CMS makes the PPR available to Plans as part of the month-end processing.

The PPR includes Part D payments and adjustments, the National Medicare Education Campaign (NMEC), and COB User Fees and premium settlement information. Appendices F.26 and J.12 provide more information on this file.

#### **5.4.4 Low-Income Subsidy (LIS)/Late Enrollment Penalty (LEP) Report**

LIS/LEP Report contains members that:

- Are eligible for LIPS;
- Must pay an LEP and elect to directly pay Plans the premiums, i.e., Direct Bill.

**Note:** The premium amounts withheld from SSA benefits for LIS members are provided on the separate Monthly Premium Withhold Extract. CMS retains the LEP obtained from these members electing premium withhold prior to passing these premiums to the Plans. CMS offsets the LEP for directly billed members from the Plans' monthly payments.

The LIS/LEP Report is beneficiary-level and contains payments for the upcoming month as well as any applicable adjustments. Appendix F.17 provides more information on this file. The MMR reports the LEP subsidy amounts to Plans.

#### **5.5 Reconciliation of Plan Data with CMS Data**

Plans are responsible for providing CMS with timely and accurate information regarding the beneficiaries' enrollment, disenrollments, special membership status, and State and County Code (SCC) changes. CMS is responsible for providing Plans with timely and accurate reports to verify membership and payment information.

During their monthly reconciliation process, Plans should verify their membership and payment information. To ensure a complete and accurate reconciliation, Plans must understand and review all CMS-provided reports. The Appendices contain all provided reports and their data. It is required that all Plans are familiar with all of these reports and their impact on the accuracy of beneficiaries' information.

CMS provides 15 reports for Plans to use to verify information. Some reports have very specialized data, such as the Bonus Payment Report, with limited use in the overall reconciliation effort. However, the reports listed in this section are the most useful in the reconciliation process; they allow Plans to compare Medicare membership and payment information. Plans should use the Daily Transaction Reply Report (DTRR) to reconcile their beneficiary records with the Monthly Membership Detail Report (MMDR), which is beneficiary specific.

The PPR includes contract/PBP payment information and contract/PBP payment adjustment information. Therefore, when reconciling report data, Plans must compare the beneficiary level payment on the MMR with the contract level payment information on the PPR.

To complete the final month-end reconciliation, Plans should reconcile the DTRRs with the MMR, PPR, Monthly Premium Withholding Report (MPWR) Data File, and LIS/LEP. Plans must submit certification of enrollment monthly, to attest to the completion of reconciliation of membership and payment reports. The MARx Monthly Schedule lists certification due dates. Plans with specific reconciliation questions should contact the Division of Payment Operations (DPO) Central Office (CO) contact person. The DPO contact list is in Appendix B.

## **6 Premium Withhold Process**

---

Beneficiaries may elect to withhold their Part C and Part D premiums from their monthly Social Security and Railroad Retirement Board (RRB) benefit if the benefit amount equals or exceeds their premiums.

The premium withhold process relies on data reported by the Plans and on an interface between the Social Security Administration (SSA), RRB, and CMS. Processing begins when Plans submit premium information for new members on the enrollment transaction and for current members on the Premium Payment Option (PPO) Change Transaction Code (TC) 75.

Appendix F, Table F.7.4.4 provides the PPO Change (TC 75) Detailed Record Layout.

Plans report the Part C and Part D premiums as applicable and the premium withhold option selected by the member. Current options are SSA Withholding, RRB Withholding, or Direct Bill, i.e. self-pay.

Appendix F, Section F-11, details the Monthly Premium Withholding Report Data File (MPWR) layouts.

The Part C premium amount reported by the Plan to CMS includes additional premium amounts for any optional supplemental benefits selected by the member. TC 78 is used to submit Part D premium amounts. The Part D premium amount reported is the base premium or the base plus enhanced premium, depending on the beneficiary's Plan election.

Appendix F, Table F.7.4.7, provides the Part C Premium Change (TC 78) Detailed Record Layout.

During processing, the Medicare Advantage Prescription Drug System (MARx) compares the submitted Part D premium to the amount assigned to the Plan Benefit Package (PBP) by the Plan bid information in the Health Plan Management System (HPMS). If it does not match, MARx changes the submitted amount to the HPMS premium amount and notifies the Plan with a Transaction Reply Code (TRC) 181. For Part C premiums, the presence of optional supplemental benefit premiums precludes MARx from identifying the exact amount. Therefore, MARx edits the Part C premium using a range defined by the lowest Part C premium amount, which starts at zero for the PBP, and the highest Part C premium amount, which is the sum of all available optional supplemental premiums for the PBP that the member could elect. As long as the submitted Part C premium falls within this range, it is accepted unchanged. If it is not within this range, MARx changes it to the lowest possible Part C premium for the PBP and notifies the Plan with a TRC 182.

If the beneficiary elects the direct bill, i.e., self-pay option, the Plan receives payment directly from the member. If the beneficiary elects SSA premium withhold, CMS transmits this information to SSA. Monthly, SSA withholds premiums and sends them to CMS, which verifies the premiums and passes payment to the Plans. If SSA is unable to deduct a member's premium from their benefit check due to insufficient funds or some type of data issue, CMS notifies the Plan with a TRC 144, which instructs the Plan to bill the member for the premiums.

Appendix I Table I-2 lists current TRCs.

**Note:** SSA may reject withholding requests due to insufficient funds even if the premiums are relatively low due to the difference in the timing of the payment cycles between SSA and CMS. This difference often requires SSA to process a withholding request with premiums due for two or three months. Additionally, SSA limits premium withholding to \$200 a month per beneficiary, which can also impact SSA's ability to accept and process premium withholding for a member.

### **6.1 *Low-Income Premium Subsidy (LIPS)***

If a member is determined eligible for LIPS and elects the withholding option, SSA withholds the non-subsidized amount, if any, and CMS pays the subsidy to the Plan. If the member elects the direct billing option, the Plan bills the non-subsidized amount, if any, to the member and CMS pays the Plan the subsidy. The Monthly Membership Report (MMR) reports the LIPS payments to the Plans. Appendix F contains MMR detail and summary file layouts.

### **6.2 *Late Enrollment Penalty (LEP)***

For members assessed an LEP, their premium includes the penalty. If the member elects the withholding option, SSA withholds the penalty amount and CMS retains it. Plans can view the amounts on the Monthly Premium Withhold Report Data File (MPWR). If the member elects the direct billing option, the Plan bills the premium amount that includes the LEP and CMS deducts the LEP from the Plan payment. Plans can view the amounts on the LIS/LEP Report. Appendix F contains this file layout.

### **6.3 *All or Nothing Rule***

The all or nothing rule means that the beneficiary may deduct their entire premium amount due, i.e., the sum of Part C and Part D premiums for one Plan, from their monthly SSA benefit. Partial deductions are not allowed. When the benefit amount is insufficient to cover the entire premium amount, SSA rejects the withhold request and notifies CMS. CMS notifies the Plan of the insufficient benefit amount and rejection of the withhold option, and instructs the Plan to change the member to direct bill, i.e., self-pay, for the full amount of premiums due and for subsequent monthly premiums. MARx notifies the Plan with a modified TRC 213, Exceed Safety Net Amount, for transactions rejected due to the \$200 safety net.

#### **6.4 *Single Payment Option Rule***

The single payment option rule requires that both the Part C and Part D premiums are either direct bill or withhold as a member may only elect one payment option. This rule applies to a single Plan enrollment. For beneficiaries legally enrolled in two different Plans, they may elect two payment options. Examples:

- Beneficiary enrolls in a Medicare Advantage Prescription Drug (MAPD) Plan for Part C and Part D coverage, which results in a single premium; the member must elect one payment option, i.e., withholding or direct bill.
- Beneficiary enrolls in a Private Fee-for-Service (FFS) Plan for Part C coverage and a Prescription Drug Plan (PDP) for Part D coverage, which results in enrollment in two different types of Plans and two different premiums. The member may elect to pay the Part C premium option as direct bill, i.e., self-pay, and the Part D premium option as withhold from the SSA benefit.

#### **6.5 *Reporting***

##### **6.5.1 *Premium Withholding Report***

The Premium Withholding Report contains information regarding Part C and Part D premium amounts that are withheld by the SSA, RRB, or Office of Personnel Management (OPM). This report includes such information as:

- Benefit package ID.
- Premium payment options.
- Premium start and end dates.
- Part C and Part D premiums withheld.
- Beneficiary identification total amount of premiums collected.

This report is provided to Plans on a monthly basis and in data format. Appendix F.11 contains more information on this file.

## **7 Coordination of Benefits Attributes**

---

### **7.1 Reporting Coordination of Benefits (COB) Data**

CMS provides COB information for the user's enrollees. Provided as often as daily, the COB file contains only members for whom there is COB information available. Each member on the file may have multiple records associated with primary and supplemental insurers. This section defines the order of the records in the file. Appendix F contains COB file layouts and Appendix K provides file naming information.

#### **7.1.1 COB File Data Element Definitions and Instructions for Part D Plans**

This section defines and provides instructions on the use of data elements found in the COB File Formats. The COB File contains the Other Health Insurance (OHI) information of enrollees in that Part D Plan. The OHI information contained in the COB file is collected by the COB Contractor (COBC) through its Data Sharing Agreements (DSAs), COB Agreements (COBAs), and other data exchanges with non-Part D payers, e.g. Pharmacy Benefit Manager (PBMs), Employer Group Health Plan (EGHP) sponsors, Section 111 Responsible Reporting Entity (RREs), State programs; questionnaires filled out by beneficiaries, employers, and providers; and from leads submitted from Part D Plans and other Medicare contractors. The information collected by the COBC and provided to the Part D Plan assists the Part D Plan in fulfilling its requirement to coordinate with OHI.

The COB File consists of a Detail (DTL) record identifying the Part D Plan's Contract Number, the Plan Benefit Package (PBP) number, and identifying information for the enrollee whose OHI is contained in the records attached to the DTL record. The DTL record may have two types of subordinate records attached to it: the Primary (PRM) record and the Supplemental (SUP) record. PRM records contain OHI that is primary to Part D. Primary does not necessarily refer to a single primary insurance, but to all occurrences of insurance that are statutorily required to pay prior to, i.e., primary to, Part D. It is possible to have multiple occurrences of primary insurance. Each occurrence of primary insurance is contained in PRM records subordinate to the DTL record. SUP records contain all supplemental insurance that pays after, i.e., supplemental to, Part D. Each occurrence of supplemental insurance is contained in SUP records subordinate to the DTL record.

The COB File contains full-record replacements for enrollees with newly discovered or changed OHI. The addition, change or deletion of an enrollee's OHI record triggers a full replacement of that enrollee's DTL and subordinate PRM and SUP records. The Part D Plan replaces its entire existing OHI profile for an enrollee with the most recent DTL and subordinate PRM and SUP records for that enrollee.

The Medicare Beneficiary Database (MBD) sends the COB File to Part D Plans via Medicare Advantage and Prescription Drug System (MARx). The COB File is automatically sent to Part D Plans when, at enrollment, the MBD already contains OHI information on that enrollee. For instance, if an individual has OHI, disenrolls from Part D Plan A, and then enrolls in Part D Plan B, all of the OHI that the MBD held and previously sent to Plan A is automatically sent to Plan B in the COB File.

**Note:** When the beneficiary disenrolls from Plan A, Plan A no longer receive updates for the beneficiary, unless the change is effective for a period that overlaps the Plan A enrollment.

The COB File is sent out to Part D Plans as the COBC collects OHI and applies records to the MBD. This can occur as often as daily. The Part D Plan may or may not receive the COB File daily; if it does receive a file, it only includes records for new or current enrollees with changed or newly discovered OHI. Most data exchanges administered by the COBC for CMS are monthly. Each data exchange partner has a unique submission schedule, however. The COBC can receive file submissions from data exchange partners on any given day. The COBC conducts development, i.e., phone calls, mailed questionnaires, on a continual basis. The COBC may apply records originating from development or data exchanges to the MBD any day. As soon as the records are applied to the MBD, the COB File is sent to the Part D Plan of the OHI enrollee.

The Part D Plan uses the elements contained in the PRM and SUP records to make payment determinations, recover mistaken payments, identify whether or not payments made by OHI count towards True Out-of-Pocket (TrOOP), and to populate the claim's response to the pharmacy.

Under provisions found in § 1860D-2(a) (4) of the Medicare Modernization Act (MMA), the Medicare Secondary Payer (MSP) rules were incorporated in the MMA and apply to Part D Plans as payers of Medicare benefits and to non-Part D GHP and non-GHP prescription drug payers that meet the MSP rules. The MSP rules are found at 42 U.S.C. § 1395y(b).

In some cases, the Part D Plan makes mistaken primary payments, i.e., if the COBC, CMS, and the Part D Plan are all unaware of any primary coverage. Under other circumstances, the Part D Plan makes conditional payments. These circumstances include:

- When the Part D Plan is aware that the enrollee has Workers' Compensation (WC)/no-fault/liability coverage but is unaware whether the drugs for which a bill is sent are related to the WC/no-fault/liability incident.
- When the Part D Plan learns of potential primary coverage and sends information to the COBC for development and it chooses to wait for validation before considering itself a secondary payer. This option is entirely up to the Plan; it may act as a secondary payer immediately or wait for validation, depending on its confidence of the information's validity.
- When the Part D Plan is aware that the primary WC/no-fault/liability coverage applies but the primary payer does not make prompt payment.

When these mistaken or conditional primary payments are made, the Part D Plan is required to recover the primary payment from the relevant employer, insurer, WC/no-fault/liability carrier, or enrollee. The Part D Plan is also subject to audit or reporting requirements. CMS is writing and will shortly publish further guidance on these and other MSP procedures.

### **7.1.2 PRM Record Layout Elements**

OHI contained in the PRM record is primary to, i.e., pays before, Part D. The following are definitions and instructions on the use of elements contained in the PRM record layout. Some of the PRM record layout elements are the same as elements contained in the SUP record layout. Note that \* indicates that the element is found in both, but may have slightly different definitions and instructions. Not all element fields populate, depending on the information that the COBC possesses when it applies the record to the MBD.

#### **7.1.2.1 RxID Number\***

The National Council of Prescription Drug Programs (NCPDP) standard Rx Identification Number (ID) is used for network drug benefit of the primary insurance. The Part D Plan displays this in the reply to the pharmacy and the RxID number to identify an individual in the recovery of mistaken payments. CMS provides guidance for recoveries to Part D Plans.

#### **7.1.2.2 RxGroup Number\***

The NCPDP standard Rx Group Number is used for network drug benefit of the primary insurance. The Part D Plan displays this in the reply to the pharmacy and may use the RxGroup number to identify an individual in the recovery of mistaken payments, as well.

#### **7.1.2.3 Benefit Identification Number Rx (BIN)\***

The NCPDP standard International BIN is used for network drug benefit routing of the primary insurance. The Part D Plan displays this in the reply to the pharmacy and may use the RxBIN number to identify an individual in the recovery of mistaken payments, as well.

#### **7.1.2.4 Processor Control Number Rx (PCN)\***

The NCPDP standard PCN used for network drug benefit routing of the primary insurance. The Part D Plan displays this in the reply to the pharmacy and may use the RxPCN number to identify an individual in the recovery of mistaken payments, as well.

#### **7.1.2.5 Rx Plan Toll-Free Number\***

The help desk number for the pharmacy benefit is the primary insurance. The Part D Plan displays this in the reply to the pharmacy.

#### **7.1.2.6 Sequence Number\***

The unique identifier for the PRM occurrence, the Sequence Number may identify the PRM occurrence when inquiring about a record to the COBC.

**7.1.2.7 COB Source Code\***

The code for the COBC, Common Working File, and MBD is used to identify the origin from which the COBC received primary insurance information. Customer Service may use the COB Source Code when inquiring about a record to the COBC.

**Note:** For any instances where an unknown COB Source Code is provided, Plans should contact COBC for clarification.

**7.1.2.8 MSP Reason\***

Medicare is the Secondary Payer, i.e., the other insurance is primary to Medicare, for EGHPs, MSP Reason codes A, B, G, and the Part D Plan reject Primary payment. The EGHP is statutorily required to make primary payment in those cases, i.e. A, B, and G. The Part D Plan makes conditional primary payment, as it is possible these MSP types are incident related. Without a diagnosis code, the Part D Plan cannot determine whether or not the non-EGHP insurance is primary for that particular claim, unless the Part D Plan is certain that the claim is related to the incident. If the Part D Plan is certain that the claim is incident related, and that primary insurance for this incident exists, it should reject primary payment in the same way it rejects GHP MSP primary insurance. If the Part D Plan makes a conditional primary payment, it must reconcile with the non-GHP insurance post Point-of-Sale (POS).

**7.1.2.9 Coverage Code\***

This code identifies whether the coverage offered by the primary insurance is a network drug or non-network drug benefit. When the primary insurance is a network drug benefit coverage type (U), the record includes routing information, i.e., BIN and PCN, when available. The Group and Individual Policy Number Fields may populate when the primary insurance is a non-network drug benefit coverage type (V & Z).

**7.1.2.10 Insurer's Name\***

The name of the primary insurance carrier can assist in the recovery of mistaken payments. CMS provides guidance for recoveries to Part D Plans.

The TIN of primary insurance carrier may assist in the recovery of mistaken payments. CMS provides guidance for recoveries to Part D Plans.

**7.1.2.12 Individual Policy Number\***

The Individual Policy Number used for non-network drug benefit primary insurance. Part D Plan uses this to identify non-network drug benefit primary insurance and may use the Individual Policy Number to identify an individual in the recovery of mistaken payments. CMS provides guidance for recoveries to Part D Plans.

**7.1.2.13 Group Policy Number\***

The Group Policy Number used for non-network drug benefit primary insurance. The Part D Plan uses this to identify non-network drug benefit primary insurance and may use the Group Policy Number to identify an individual in the recovery of mistaken payments. CMS provides guidance for recoveries to Part D Plans.

**7.1.2.14 Effective Date\***

The MSP start date. For MSP types D, E, and L, it identifies the date of the accident, illness, or injury, or the Medicare entitlement date, whichever is earlier.

**7.1.2.15 Termination Date\***

MSP end date, which identifies whether or not the primary insurance is terminated. If the insurance is open, the field is populated with all zeros.

**7.1.2.16 Relationship Code\***

Relationship to primary insurance policyholder used for MSP determinations.  
01=Self  
02=Spouse  
03=Child  
04=Other

**7.1.2.17 Payer ID\***

Future

**7.1.2.18 Person Code\***

NCPDP standard Person Code used by the Plan to identify specific individuals on the primary insurance policy. Used for routing of network drug benefit, the Part D Plan displays the Person Code in the reply to the pharmacy and may use the Person Code in the recovery of mistaken payments.

**7.1.2.19 Payer Order\***

The order of payment for primary insurance, the Part D Plan displays this in reply to the pharmacy in order of Payment Order Indicator. The lowest number in ascending order, i.e., 001 to 400, is the first primary insurance displayed in the reply to the pharmacy. OHI with a payment order less than 401 is displayed prior, i.e., primary to, the Part D Plan. The rules that COBCs use to assign the Payer Order are attached for reference.

**7.1.2.20 *Policy Holder's First Name***

The first name of the primary GHP (MSP Types: A, B, G) insurance policy holder. Part D Plans may use the Policy Holder's first name in the recovery of mistaken payments. CMS provides guidance for recoveries to Part D Plans.

**7.1.2.21 *Policy Holder's Last Name***

The last name of the primary GHP (MSP Types: A, B, G) insurance policy holder. Part D Plans may use the Policy Holder's last name to identify an individual in the recovery of mistaken payments. CMS provides guidance for recoveries to Part D Plans.

**7.1.2.22 *Policy Holder's Social Security Number (SSN)***

The Social Security Number of the primary GHP (MSP Types: A, B, G) insurance policy holder. Part D Plans may use the Policy Holder's SSN to identify an individual in the recovery of mistaken payments. CMS provides guidance for recoveries to Part D Plans.

**7.1.2.23 *Employee Information Code***

Not used.

**7.1.2.24 *Employer's Name***

The name of Employer sponsor of primary GHP (MSP Reason codes: A, B, G) insurance. Part D Plans may use the Employer's Name in the recovery of mistaken payments. CMS provides guidance for recoveries to Part D Plans.

Some of the SUP record layout elements are the same as elements contained in the PRM record layout, but may have slightly different definitions and instructions. Not all element fields populate, depending on the information that the COBC possesses when it applies the record to the MBD.

##### **7.1.3.1 RxID Number\***

NCPDP standard Rx Identification Number used for network drug benefit of the supplemental insurance. The Part D Plan displays this in the reply to the pharmacy.

##### **7.1.3.2 RxGroup Number\***

NCPDP standard Rx Group Number used for network drug benefit of the supplemental insurance. The Part D Plan displays this in the reply to the pharmacy.

##### **7.1.3.3 RxBIN Number\***

NCPDP standard International BIN used for the network drug benefit routing of supplemental insurance. The Part D Plan displays this in the reply to the pharmacy.

##### **7.1.3.4 Rx Plan Toll-Free Number\***

The Part D Plan displays this help desk number of the pharmacy benefit in the Plan's reply to the pharmacy. For Supplemental Insurance Type Code P, this field instead populates with contact information for the patient assistance program.

##### **7.1.3.5 Sequence Number\***

The unique identifier for the supplemental SUP occurrence, Part D Plans may use the number to identify the SUP occurrence when inquiring about a record to the COBC.

##### **7.1.3.6 COB Source Code\***

The code the COBC, Common Working File, and MBD use to identify the process from which the COBC received supplemental insurance information. Customer service may use the COB Source Code when inquiring about a record to the COBC.

**7.1.3.7 Supplemental Type Code**

The type of supplemental insurance contained in the record. The Part D Plan uses this to determine if the payments made by this supplemental insurance counts towards TrOOP. Supplemental Insurance Type Codes Q (SPAP) and R (Charity) count towards TrOOP. All other codes do not count toward TrOOP.

**7.1.3.8 Coverage Code\***

This code identifies whether the supplemental insurance drug benefit is a network drug or non-network drug benefit. When the supplemental insurance is a network drug benefit coverage type (U), the record includes routing information (BIN and PCN, when available). When the supplemental insurance is a non-network drug benefit coverage type (V & Z) the Group and Individual Policy Number Fields populate.

**7.1.3.9 Insurer's Name\***

The name of the supplemental insurance carrier, the Part D Plan uses this to identify supplemental insurance carrier.

**7.1.3.12 Effective Date\***

The supplemental insurance start date.

**7.1.3.13 Termination Date\***

The supplemental insurance end date, which identifies whether or not the supplemental insurance terminated. If the insurance is open, the field populates with all zeros.

**7.1.3.14 Relationship Code\***

Relationship to supplemental insurance policyholder. No instructions at this time.

**7.1.3.15 Payer ID\***

Future

**7.1.3.16 Person Code\***

The NCPDP standard Person Code the supplemental insurance uses to identify specific individuals on the supplemental insurance policy. Used for routing of network drug benefit, the Part D Plan displays the Person Code in the reply to the pharmacy.

**7.1.3.17 Payer Order\***

The order of payment for supplemental insurance, the Part D Plan displays this in reply to the pharmacy in order of the Payment Order Indicator. The lowest number in ascending order, i.e., 401 to 999, is the first supplemental insurance displayed in the reply to the pharmacy. OHI with a payment order greater than or equal to 401 is displayed after, i.e., secondary or supplemental to, the Part D Plan. The rules that the COBC uses to assign the Payer Order are in Table 11.3-1.

## **7.2 Additional ESRD Information**

Prospective payments are made based on the ESRD health status. The process of passing the information through the various databases may take as long as four months from the time the beneficiary is identified by the physician as having ESRD. Therefore, the Plan may not begin receiving the ESRD capitation rate of pay for the beneficiary for at least four months.

When the health status is included in the capitation/risk adjustment (RA) rate for the beneficiary already in Medicare, the MARx automatically calculates retroactively to include the first month of ESRD health status within 36 months. However, if the beneficiary is entitled to Medicare as a result of ESRD, there is a three-month waiting period before Medicare entitlement begins.

The Renal Management Information System (REMIS) automatically adjusts for the three-month waiting period and updates the Enrollment Database (EDB) system and MARx, resulting in Plans receiving payment at the ESRD capitation/RA rate of pay. The health status is based on the first date of dialysis as indicated on the ESRD Medical Evidence Report Medicare Entitlement and/or Patient Registration, Form CMS-2728-U3. In addition, the physician's clearly legible signature and signature date are necessary before the Renal Network can enter any information in the Standard Information Management System (SIMS).

The managed care staff at the Retro-Processing Contractor, the regional office, or central office cannot enter ESRD status changes and corrections into MARx. The managed care staff can synchronize MBD to the Enrollment Database if these systems' data do not match. This process may result in a change in the ESRD status and the associated positive or negative payment. The Renal Networks enter the data from the CMS-2728-U3, which is transmitted to the CMS systems through an automated process. The CMS-2728-U3 is the key source of documentation to ensure that a beneficiary is identified with ESRD health status indicator. The ESRD facility must complete the CMS-2728-U3 within 45-days of beginning a regular course of dialysis or receiving a kidney transplant, which was prescribed by a physician.

- The ESRD facility forwards a copy of the CMS 2728-U3 to its local SSA Field Office and to its respective ESRD Renal Network organization.
- For individuals diagnosed with ESRD, the SSA determines eligibility for the Medicare ESRD entitlement based on CMS-2728-U3 under the ESRD provisions of the law.
- The Renal Network organization inputs the information into its data system, and transmits the information to CMS.
- CMS updates the information in REMIS, the CMS central repository for beneficiaries with ESRD.
- Daily, REMIS updates the EDB with ESRD health status start and/or end dates for the Plan member. MARx is the source of information used in computing the monthly capitation rates that the Plan receives.

Plans may contact the appropriate Renal Network to verify specific discrepancy data. The Renal Network will only supply the following information:

- The first date of dialysis or date of transplant.
- Date the beneficiary's CMS-2728-U3 was submitted to DMS by the Renal Network.
- Current Renal Status.

**Note:** this information is not required for a retroactive adjustment.

## 8 Reporting RxID/RxGROUP/RxPCN/RxBIN Data

---

The 4Rx Notification process is a data exchange between the Plans and CMS. Plans provide CMS with Plan enrollment and claims processing information to support Point of Service (POS) and other pharmacy-related information needs. This exchange makes 4Rx data available to the True Out-of-Pocket (TrOOP) Facilitator and through the Facilitator to the pharmacy.

Pharmacies operate in a real-time processing environment and require accurate information at POS to properly adjudicate the claim with all payers that cover the beneficiary. In addition, many pharmacies' automated billing is based on eligibility data. The sooner Plans submit their 4Rx data to CMS, the faster complete data is available from the E1 eligibility query, which the transaction pharmacies submit to the TrOOP Facilitator to obtain 4Rx data. As a result, CMS requires prompt submission of 4Rx data. Plans must include 4Rx data on Plan-submitted enrollment transactions. However, for CMS-generated enrollments, for example facilitated and auto-enrollments, Plans are required to submit their 4Rx data within 72 hours of the Plan's receipt of the Daily Transaction Reply Report (DTRR) reporting these enrollments. One of the most difficult issues for CMS and the TrOOP Facilitator is collecting the 4Rx data from the Plans and ensuring a steady flow of the information to the TrOOP Facilitator.

This enables pharmacies to assist beneficiaries who are unable to identify the Plan in which they are enrolled. Pharmacists rely on the E1 eligibility query to obtain beneficiary billing information, particularly the Cardholder Identification Number (ID), which is a National Council of Prescription Drug Programs (NCPDP) mandatory field in the pharmacy billing transaction. When pharmacists are unable to obtain the 4Rx information from an E1 transaction, they must rely on dedicated phone lines at Plans and their processors to provide the required beneficiary billing information.

### 8.1 Plan Submission of 4Rx Notification Files/Record Formats

The four Rx data elements are:

- RxBIN – Benefit Identification Number.
- RxPCN – Processor Control Number.
- RxID – Identification Number.
- RxGRP – Group Number.

Plans must submit 4Rx data using Plan Transaction Code (TC) 61 for enrollment and Plan Benefit Package (PBP) changes. Plan transactions for enrollment TC 61, and disenrollment TCs 51/54 include the 4Rx fields of Primary Rx Benefit Identification Number (BIN), Primary Rx ID, Primary Rx Processor Control Number (PCN), Primary Rx Group, Secondary Rx BIN, and Secondary Rx PCN.

**Note:** The layout for disenrollment TCs 51/54 transactions includes the 4Rx fields. However, Plans are not required to submit 4Rx data as part of a disenrollment transaction. Appendix F provides detail of the layout.

The Primary Rx BIN and Primary Rx ID fields are mandatory and must accompany enrollment TC 61. Other noted fields, i.e., Primary Rx PCN, Primary Rx Group, Secondary Rx BIN and Secondary Rx PCN, are optional. Transaction files must formulate to the record formats and field definitions in Appendix F. Plans should send the files in flat file structure and conform to CMS naming conventions. Section 3 and Appendix K contain more information on naming standards.

**Note:** Detailed File/Record Formats are located in Appendix F; detailed Transactions Reply Codes (TRCs) for 4Rx Notification are located in Appendix I.

### **8.1.1 Making Changes to 4Rx Data**

Plans must use Plan Change TC 72 to submit 4Rx data changes in the following circumstances:

- Auto-assigned enrollment.
- CMS facilitated enrollment.
- Any other CMS-generated enrollments not initiated by the Plan where 4Rx data is not included in the enrollment transaction, i.e., Regional Office/Central Office (RO/CO) actions, retro processing contractor actions, reassignment, and annual rollover activity.

If any of the above three scenarios apply, the Plan must submit 4Rx Data to CMS within 72 hours of the Plan's receipt of the DTRR reflecting the enrollment. The Plan change TC 72 file layout includes the 4Rx fields of Primary Rx BIN, Primary Rx ID, Primary Rx PCN, Primary Rx Group, Secondary Rx BIN and Secondary Rx PCN. The Primary Rx BIN and Primary Rx ID fields are mandatory and Plans must submit them; the other noted fields, i.e., Primary Rx PCN, Primary Rx Group, Secondary Rx BIN and Secondary Rx PCN, are optional. When submitting 4Rx changes, Plans should only populate the following fields, required for 4Rx processing:

- Beneficiary Identification Fields, i.e., Health Insurance Claim Number (HICN), Name, Date of Birth (DOB)
- Surname
- First Name
- Sex
- DOB
- PBP # (when applicable)
- Contract Number
- Transaction Code
- Effective Date
- Rx BIN
- Rx ID
- Rx GRP (optional)
- Rx PCN (optional)
- Secondary Drug Insurance Flag (optional)
- Secondary Rx BIN (optional)
- Secondary Rx ID (optional)
- Secondary Rx GRP (optional)
- Secondary Rx PCN (optional)

Plans may submit multiple change transactions for the same beneficiary in the same transmission file. The current requirement for effective dates submitted with Plan change TC 72s are within a date range of the Current Calendar Month (CCM) minus one month (CCM-1) through CCM plus three months (CCM+3). This is referred to as the allowable range.

However, editing for allowable date range is not performed on Plan change TC 72s submitted with 4Rx data, since auto-enrollments can have a retroactive effective date of several months and facilitated enrollments can have a prospective effective date of several months. Any Plan change TC 72 submitted with 4Rx data is accepted as long as the effective date in the transaction falls within the Plan's enrollment period.

The Allowable Date Range Tables 4-3 and 4-4 provide more information regarding the allowable date range.

### **8.1.2 CMS Editing of 4Rx Data**

CMS edits against all 4Rx data fields. Any fields on an enrollment TC 61 or Plan change TC 72 transactions containing invalid information reject with an appropriate TRC.

**Note:** If 4Rx data is submitted as part of a disenrollment TC 51/54, that data is not edited for validity. CMS does not edit against any 4Rx data fields for MA-only Plans, along with other Plans that do not provide Part D benefits; these Plans should submit blanks in the 4Rx data fields.

When 4Rx data is rejected, the entire enrollment is rejected. Plans should correct and resubmit the enrollment transaction using the same transaction type as originally submitted. All Plan TCs 61 submitted for Part D Plan enrollments, i.e., any contract and PBP combination with Part D coverage that must include 4Rx data elements for enrollments are edited for 4Rx data elements. CMS requires Plans to submit the Rx BIN and the Rx ID in the 4Rx data fields. This data is required to meet the specific following criteria for acceptance:

- Rx BIN for primary drug coverage of 6 characters in length and numeric.
- Rx ID for primary drug coverage no longer than 20 characters, alphanumeric, left justified, and contain spaces in the empty positions when the value in the field is less than 20 characters in length.

Submission of data in the following 4Rx fields is optional. If not submitted, the Plan should leave the fields blank. However, if submitted, the data is required to meet the following specific criteria for acceptance:

- Rx GRP for primary drug coverage of no longer than 15 characters, alphanumeric, left justified, and containing spaces in the empty positions when the value in the field is less than 15 characters in length.
- Rx PCN for primary drug coverage of no longer than 10 characters, alphanumeric, left justified, and containing spaces in the empty positions when the value in the field is less than 10 characters in length.

Editing of the 4Rx data elements does not occur in the following situations:

- Enrollment TC 61 submitted by Plans that do not include Part D coverage.
- Plan enrollment change TC 72, unless at least one field is submitted; then all edits apply.
- 4Rx information stored in CMS files. These files are sent towards the end of the month.

### **8.1.3 CMS to Plans/4Rx Response**

CMS responses to Plan submission of 4Rx data are provided in regular transaction processing response files, including the BCSS and the DTRR. Appendix F provides file/record layouts.

### **8.1.4 CMS to Plan/Monthly NoRx File**

CMS creates and sends monthly NoRx files to Plans identifying all enrollees that do not currently have 4Rx information stored in CMS files. Typically, these files are sent the third week of the month. CMS uses the standard 4Rx Response File Format to inform the Plans of the incomplete 4Rx information. To distinguish between this file and a standard 4Rx Response File, a Detail Record Type containing a value of NRX in positions 1-3 of the file layout indicates that the record is a request for the Plan to send CMS 4Rx information for the beneficiary. The file containing this information is transmitted to the Plans using the same methodology that transmits the normal 4Rx Response File.

Appendix F contains information on the file layout; Appendix K provides information on this file's naming standards.

## **9 Establishing Low-Income Subsidy (LIS) Status**

---

To establish the correct premium, cost sharing, and deductible levels with the correct effective dates for current, prior, and prospective enrollees, Part D sponsors should refer to the Daily Transaction Reply Report (DTRR). The Health Plan Management System (HPMS) memorandum entitled “*Announcement of Spring 2009 Software Release*” dated January 9, 2009 outlined the technical changes to the DTRR related to LIS status that went into effect July 2009.

As discussed in Section 1 of the memorandum, the DTRRs provide full replacement LIS profiles to Plans in response to Part D enrollments and Plan Benefit Package (PBP) changes as well as any LIS change that impacts a Part D enrollment period. Therefore, the DTRR is the definitive source of LIS eligibility information. It is important to note that these changes represent a shift in reporting methodology. Unlike much of the data provided in the DTRR, LIS eligibility information is not based on Current Calendar Month (CCM) reporting.

### **9.1 Key Changes in LIS Data Reporting**

- LIS data is no longer returned in association with the Transaction Reply Codes (TRCs) generated in response to enrollment and PBP change transactions. Specifically, LIS data no longer accompanies enrollment and PBP change TRCs 011, 100, 117, 118, 210, and 212. Instead, LIS TRCs independently accompany enrollment and PBP change transaction responses.
- Specific LIS changes are no longer identified. Instead, Plans receive full replacement LIS profiles in response to low-income changes that accumulate over the weekly and monthly reporting cycles. Replacement profiles are established using data known to CMS at the end of each reporting cycle. Reported data spans a PBP enrollment.
- To more clearly communicate these changes, CMS eliminated TRCs 167 and 168. Existing TRCs 121 and 194 were retained but with modified definitions.
- The addition of new TRC 223 now identifies LIS periods that were removed from and are no longer affecting an enrollment. Appendix I provides more detailed information and a complete list of changes regarding these TRCs.
- An ensemble composed of one or more of the TRCs 121, 194, and 223 represents full replacement LIS profiles. Each profile returns LIS period start and end dates, premium subsidy percentage, co-payment level, enrollee type flag, and LIS source code. Low-Income premium subsidy (LIPS) percentage and co-payment level values retain their current definitions. The enrollee type flag identifies a beneficiary as a prior, current, or prospective enrollee. The source code identifies whether the LIS period is the result of CMS deeming or Social Security Administration (SSA) approval.

## **9.2 Other Sources of LIS Data**

Although the DTRR is the primary source of LIS eligibility information, Plans continue to receive a number of reports and/or data sources containing LIS information. While each of these files may contain some LIS information about sponsors' enrollees, none of these contain the comprehensive LIS profile that is provided on the DTRR.

1. **Batch Completion Status Summary (BCSS):** This report is in response to Plan-submitted transactions. Because it is not provided for CMS-generated transactions, i.e., auto/facilitated enrollments, it is not intended as a source of LIS data.
2. **LIS/ Late Enrollment Penalty (LEP) Data File:** This data file contains beneficiary level LIS and the LEP payment and adjustment details. LEP details are provided for direct bill beneficiaries only.
3. **LIS/Part D Premium Data File:** This data file displays beneficiaries from the premium profile table with a low-income designation. It is provided on a bi-weekly basis and is the reference file used to determine the LIS Match Rate.
4. **LIS History Data File (LIS HIST):** This report provides a comprehensive list of a sponsor's current LIS membership. The data on each beneficiary spans through the most recent 36 consecutive months of contract enrollment. This report also informs Plans whether a beneficiary is LIS in the next calendar year.
5. **LIS Weekly Activity History Data File (LISAHD):** This report informs Plans holding current, prior, and prospective enrollments that some element of LIS changed during the beneficiary's enrollment in the contract.

In addition to the regularly issued reports listed above, Part D sponsors should consult the Loss of Subsidy Files sent in December for those beneficiaries losing LIS status at the end of the current year. TRC 996 is used for this special file type. Appendix F provides a copy of this file record layout.

## ***10 Using the Medicare Advantage and Part D Inquiry System Online Operations***

---

The Medicare Advantage and Part D Inquiry System User Interface (UI) enables access to enrollment, eligibility, payment, premium withhold, and 4Rx information for beneficiaries.

The UI accommodates online and batch processing. Online capabilities enable viewing of beneficiary or contract information. Batch capabilities allow submission of data, such as enrollment and disenrollment transactions.

UI online operations support the following capabilities:

- Log on and view messages.
- View beneficiary information.
- View payment information.
- View premiums charged by Plans.
- Request historical reports.

Information is available for enrollments from the start of the program.

The following sections describe online processing.

The user may read this section in its entirety, but it is also designed as a reference. Each topic provides content specific to that particular topic. The majority of the general information, such as common buttons, navigation processes, and messages, is provided either in **Section 10.1.6** or in *the Guide Appendices*, and is not duplicated in the remainder of this section.

All of the beneficiary, contract, and user information in the screen snapshots in this document are fictional. The names and Social Security Numbers do not identify any person living or dead. The claim numbers start with '997,' '998,' or '999' because those numbers are never assigned.

On certain screens, if no end date displays for the subsidy period, this does not mean the beneficiary's status terminated; rather a blank Subsidy End date means that the status rolled over to the current year.

### 10.1.1 Accessing the UI and Logging onto the System

#### 10.1.1.1 How Do I Get Started Using the UI?

After obtaining a CMS user ID and password, a UI user profile is created for the user. This profile defines the user's tasks. Users are assigned one or more roles based on their job responsibilities. One of these roles is marked as the default. When a user logs on, the user may accept the default role or choose one of the other roles assigned to the user. The profile also defines which contracts the user may access.

To access the UI, users must have the following software installed on their workstation:

- Windows 98 or higher.
- Microsoft Internet Explorer with Web browser, Version 5.5 or higher.
- Adobe Acrobat Reader, Version 4 or higher, for report viewing and display of online help. If the user does not have Adobe Acrobat Reader Version 4 or higher, the user can download a free version at ([www.adobe.com](http://www.adobe.com)).

Also, the user must:

- Enable JavaScript in the browser.
- Allow pop-ups from the UI site.
- Disable script debugging, which is in the Internet Explorer's Internet Options under the Advanced tab.

#### 10.1.1.2 How Do I Log On?

The UI is accessed via the CMS Applications Portal (<https://applications.cms.hhs.gov>). A user logs on to the CMS Applications Portal and then selects the Medicare Advantage and Prescription Drug (MAPD) Inquiry System link.

### 10.1.2 Changing Password

CMS Individuals Authorized Access to the CMS Computer Services (IACS) controls password management. For more information on IACS, users may refer to the *IACS User Guide* on the MAPD Help Desk Web site: [http://www.cms.gov/MAPDHelpDesk/07\\_IACS.asp](http://www.cms.gov/MAPDHelpDesk/07_IACS.asp).

### 10.1.3 Logging out of the System

When the user exits the UI, logging out closes the browser windows. Section 10.2.4 provides the steps for logging out. Closing the browser also logs the user out of the system.

### 10.1.4 Understanding Roles and Privileges

#### 10.1.4.1 What Are the Different Roles and Privileges?

The MAPD Inquiry System is role-based, which provides a secure environment for data. A role describes a user's job by the tasks that the user performs. To fulfill the security goals, the system provides functionality and data filtering based on the needs of users and security considerations.

The roles currently defined for Plan users are as follows:

- Managed Care Organization (MCO) Representative - An individual who works for a Plan managing beneficiaries in the Medicare program via Medicare Advantage Prescription Drug System (MARx). MCO Representatives access detailed enrollment data only for their own membership and minimal current enrollment data for other beneficiaries. The representative cannot transmit batch files containing membership changes and health status corrections.
- MCO Representative UI Update - An individual who works for a Plan managing beneficiaries in the Medicare program via MARx. MCO Representatives access detailed enrollment data only for their own membership and minimal current enrollment data for other beneficiaries. The representative cannot transmit batch files containing membership changes and health status corrections. The representative can update member records in MARx.

**Note:** External Point of Contacts (EPOCs) must approve a maximum of two MCO Representative UI Update users per parent organization. CMS continues to evaluate this limit as experience is gained with the new UI Update functionality. MCO Representative UI Update users must work for the parent organization. Designated MCO Representative UI Update users that already have an IACS account must access the IACS system to modify and change their current role to the new role.


- MCO Representative Transmitter - An individual with the same capabilities as the MCO Representative role, with the additional ability to transmit batch files containing membership changes and health status corrections.

**Note:** UI screens display the term *MCO* rather than *Plan*. *MCO* represents all types of Managed Care Plans, e.g., Cost Plans, Medicare Advantage (MA) Plans, MAPD Plans, and Prescription Drug Plans (PDPs).

### 10.1.4.2 Can I Change My Role?

When the user logs on to the UI, the first screen displayed is the User Security Role Selection (M002) screen. It appears only at logon; the user cannot access this screen using the menu system. However, at logon the user is presented with the list of profile specific roles. **Figure 10-1** lists roles for the user XXXX, who is eligible to choose either of the MCO roles.

## 10.1.5 Using the Screens

### 10.1.5.1 General Properties of Screens

UI screens share many properties. Once users understand the screens' organization, they can access information quickly and easily.

There are two main types of general screen layouts: primary and secondary. The principal differences between a primary window and a secondary window are the design and content of the headers and the manner in which the screens are navigated.

There is also a third special type of screen, the log-out window, which remains in the background for the duration of the session.

### 10.1.5.2 Layout – Primary Screens

The main window contains a primary screen with a menu and submenu. Only one primary screen opens at a time. When the user navigates from one primary screen to another, the new screen replaces the previous primary screen in the main window.




Figure 10-2 : MCO Representative (View Only) Example of a Primary Window

The heading of each primary screen contains the UI main menu. See **Figure 10-2**. In most cases, there is a submenu below the main menu, which provides options based on the menu item chosen. The selected menu and submenu items are highlighted in yellow on the system.

10.1.5.3 Screen Layout – Secondary Screens

A secondary screen is opened from a primary screen to drill down for more information. It is displayed in a new, pop-up window. The user may open multiple pop-up windows simultaneously. When the user switches primary screens, any open secondary screens associated with that primary screen automatically close.




Figure 10-3 : MCO Representative (View Only) Example of a Secondary Window (Pop-Up)

Secondary screens do not have the menu/submenu headers shown on primary screens. Instead, their headers vary based on the screen. Many secondary screens have headers that provide information specific to the contents of the screen. In the example shown in **Figure 10-3**, the header information, which is indicated with a brace, is specific to the selected beneficiary and includes such information as the beneficiary’s name, claim number, date of birth (DOB), date of death (DOD) when applicable, street address, age, sex, state, and county.

In addition, some secondary screens have their own navigation; a lower-level menu system. In the example, the secondary-level menu consists of the following items: |Snapshot|, |Enrollment|, |Status|, |Payments|, |Adjustments|, |Premiums|, and |Factors|. The user moves among these screens by clicking the appropriate menu item. One feature unique to the secondary window navigation is a [Close] or [Cancel] button. Clicking one of these buttons closes that window.

**10.1.5.4 Some Common Features of the Screens**

Below the headings, most of the screens are in the same format. The top of the screen contains a title line with the following information, as shown in **Figure 10-4**.

- Screen name, which describes the screen’s purpose.
- Primary screen’s name reflects the navigation to the screen using menu and submenu.
- Screen identifier, which starts with an *M*. This identifier is useful when asking for help, reporting a problem to the help desk, or using *the Guide*.
- User ID.
- User’s current role.
- Current date.
- [Print] and [Help] buttons (and the [Close] and other buttons for secondary windows).

Many screens include instructions at the top, which are displayed on the screen with a yellow background to provide information on using the screen. Additional information is available by clicking on the [Help] button.

A screen may contain input, i.e., data entry, fields, output, i.e., information, fields, and links to other screens, tables, etc. See **Figure 10-5** for an example of a screen with links that display:

- Additional information on the same screen; the Action column link Payment in the first table.
- Other screens; the Contract column links [H6666](#) and [H9999](#) in the first table and the dates – [07/2006](#) through [03/2006](#) – in the Payment Date column link of the second table.

Some screens show information using a numerical code. When there is room on the screen, a code description also displays. When there is no room, the user places the mouse pointer over the code, which causes a description to pop up. See **Figure 10-6**.

### 10.1.5.5 Some Common Characteristics of the Screens

Screens are customized by role in several ways:

- Not all screens are available to each role. The menu and submenus include links only to the available screens. For example, the screen that orders historical reports is not available to each role.
- The fields and buttons on some screens vary by role.

Screens may carry out one or more of the following functions:

- Find specific information.
- Display information.
- Provide links/buttons to additional functions.

Many screens contain forms that the user must populate and buttons that the user must click on to carry out an action. Some fields are required and others are optional. A red asterisk (\*) appears next to a field label to indicate that it is required. A red plus sign (+) appears next to field labels to indicate that one or more of those fields are required.

Sometimes there are additional rules regarding the combination of fields that are acceptable; those rules are often indicated in instructions on the form.

There are different options for entering information into a field:

- Text entry. Most fields, such as claim number or contract, allow the user to type in the information.
- Dropdown list. Some fields, such as file type, provide a list of values from which to select. The user clicks on the down arrow next to the field to display the list, and then clicks on a value to select it.
- Radio buttons. The user chooses one of the items in a group by clicking on the circle next to that item.
- Check boxes. The user selects any number of the items in a group by clicking on the box next to each item.

Some fields are initialized with default values. For example, date fields are often initialized with the current date.

The information that the user enters on a form is validated to ensure that the request is valid, and an error message is displayed to inform the user of an error.

Information entered into a field is validated when the user exits that field, such as when the user hits tab or clicks elsewhere on the screen. The field is color coded; *yellow* for a valid field and *pink* for an invalid field.

Some validation is not performed after the user exits the field. Generally this happens when the validation involves the relationship between fields, such as checking that a start date is not after an end date. When an error is detected upon clicking a button, an error message is displayed and the requested change/action does not occur.

After validation is complete, the user's action is submitted. The buttons on the screen, except the [Print], [Help], [Close], and [Cancel] buttons, are disabled, i.e., grayed out, until the action completes, to prevent a user from clicking a button more than once, which may lead to multiple actions. Also, a message asks the user to wait until the requested action is completed. If the processing succeeds, a message indicating that the action was successfully completed displays in green. If an error occurs during processing, a message explaining the problem displays in red and the user's inputs display on the screen again.

#### **10.1.5.6 Screen Components**

A screen may contain links to other screens, in addition to the links on the menu and submenu. These links are indicated by underlined words.

When a screen displays a list of information, such as multiple beneficiaries or transactions, the information displays in a table format. When there are too many rows in the table to fit on one screen, only a portion of the table displays at one time. The screen navigation arrows at the top and bottom of the table allow the user to scroll through the list. When the first page is displayed, the back arrow is disabled. When the last page is displayed, the forward arrow is disabled. There are additional arrows for jumping directly to the first or last page. Users can access a particular page directly by selecting a page number from the list displayed at the top of the table, next to the arrows, and clicking the [Go] button. If all of the information fits on one page, there are no arrows or page numbers listed.

If a column heading in a table is underlined, the user may sort the table by the information in that column. The user clicks on the column heading to sort by that column in ascending order. Note that the column heading does not act as a toggle, i.e., clicking on the heading a second time does not return the screen to the previous sort order nor does it sort the column in descending order. Sorting is conducted for all rows in the list, not just for the rows on the current page, so the user may see different rows display on the screen after sorting.

#### **10.1.5.7 Accessibility**

Instead of using a mouse to move through screens, it is also possible to navigate, select items, and click on actions using only the keyboard. The tab keys allow users to move from one screen element to the next, including links, fields, and buttons. To move backward from one screen element to the previous one, the user holds down the <SHIFT> key when tabbing. To select a particular radio button, the user utilizes the tab keys to move to the radio button that is selected within a group of buttons, and then use the arrow keys to change which button is selected in the group. To select or deselect a check box, the user hits the tab keys to move to the check box, and then uses the space bar to toggle between selected and deselected.

In addition, buttons and fields have keyboard shortcuts that allow the user to go directly to a screen element. The underlined letter on the field or button label indicates the shortcut. Pressing the <Alt> key with that letter provides a way of accessing that button or field. For a button, using its shortcut is the same as clicking on that button. For example, <Alt F> is equivalent to clicking on the [Find] button. For a field, using its shortcut is the same as tabbing to the field; the focus is on that field, and the value in it is selected. For a check box field, the shortcut also toggles the check box on and off.


The UI meets U.S. regulations, Section 508 of the Rehabilitation Act Amendments of 1998, requiring all U.S. Federal agencies to make their Information Technology (IT) accessible to their employees and customers with disabilities. The System meets the following criteria for a user employing assisting technologies, such as screen readers:

- Text equivalents are provided for non-text elements such as graphics.
- All information conveyed with color is also available without color.
- Web-based reporting tools and Hypertext Markup Language (HTML)-generated data support the use of row and column headings.
- HTML 4 tagging format is used.
- The System is designed to allow users to skip repetitive navigation links. A link, which is only visible with a screen reader, is placed at the start of the page. When clicked, the link skips over the menu and submenu.

### 10.1.5.8 Commonly Referenced Buttons and Links

Table 10-1 describes buttons and links on many of the screens.

**Table 10-1: Common Buttons and Links**

[Print]	<b>Print.</b> Every screen contains a [Print] button. The [Print] button supports printing the entire contents of the active Web page. It displays the ‘Printer Options’ pop-up screen.
[Help]	<b>Help.</b> Every screen contains a [Help] button, which invokes a menu of topics. At the top of the menu is a link to information specific to the current screen. Below that link are topic links that display for each screen. When the user clicks on a link, the help displays in a separate window using Adobe Acrobat Reader. The help comes directly from this user’s guide, providing the user an easy way to obtain online access to this guide.
[Close]	<b>Close.</b> Closes the pop-up window without submitting the data. This button does not appear on any screens accessed directly from an item on the UI main menu.
[Cancel]	<b>Cancel.</b> Closes the pop-up window without submitting the data.
	<p><b>Screen navigation arrows.</b> When not all list items fit on a screen, navigation arrows scroll through the list. These arrows are shown at the top and the bottom of the list items on the screen. The arrows function as follows:</p> <ul style="list-style-type: none"> <li> – go to the first page of items in the list</li> <li> – go to the previous page of items in the list</li> <li> – go to the next page of items in the list</li> <li> – go to the last page of items in the list</li> </ul>
	<p><b>Go to Page Number.</b> In addition to the screen navigation arrows, [Go to Page Number] is displayed at the top of the list items. It allows the user to jump directly to a particular page. Select the page number to display, and click on the [Go] button. The page numbers in the dropdown list reflect the actual number of pages in the list.</p>
[Reset]	<b>Reset.</b> Resets the entered data to their previous values. If a button was clicked on the screen, the previous values are those displayed when the button was clicked. 10.1.5.9 Common Fields

Table 10-2 describes the formats of input fields used on many of the screens. The field labels vary among screens. For example, contract field labels include *Contract #* or *Contract*, or *Birth Date* or *Effective Date*.

### **10.1.5.10 Error Message Screens**

This section covers screens that report possible system errors. Appendix B provides contact information to report the error.

If a screen is unavailable for display, the Page Not Found screen is displayed to notify the user of the problem. See **Figure 10-7**.




Figure 10-8: Page Time-Out Screen

If a time-out occurs during an attempt to display a screen, the Page Time-Out screen appears, notifying the user of the problem. See **Figure 10-8**.

## 10.1.6 Navigating the System

### 10.1.6.1 How Do I Get Where I Want To Go?

The user functions to which users have access depend upon their role. Only those functions available to the user's role appear in the menu and submenus. The tasks within each function may also vary based on the user's role. See **Table 10-3** for the names of the main menu items and a general description of the functions under each item.

Table 10-3: Main Menu Items

Menu Item	Description
Welcome	Messages, current payment month, and calendar.
Beneficiaries	Search for beneficiaries and view beneficiary information.
Payments	Retrieve payment and adjustment information for MCOs and beneficiaries.
Reports	Request historical reports.

### 10.1.6.2 How Do I Find Specific Information?

The UI uses the drill-down system. This means that the user starts at a very high level, and drills down to more specific detailed information.

### 10.1.6.3 Navigating Menus and Submenus

The menus and submenus all work in the same way, as follows: the first view of the UI main menu appears with the |Welcome| menu item highlighted on the screen. See **Figure 10-9**.

When the user selects an item from the UI main menu by clicking on the general area, e.g., the |Beneficiaries| menu item, the screen changes. See **Figure 10-10**.

- The selected menu item; in this case, the |Beneficiaries| menu item, is highlighted in yellow on the screen.
- The associated submenu is displayed just below the main menu, the first item in the submenu is selected and highlighted in yellow on the screen as well, by default, and the associated screen; in this case, the *Beneficiaries: MCO (M201)*, is displayed in the form area.
- To view any of the other selections, click the menu or submenu item, e.g. the |Payment| menu item, to see the associated screen.

**Note:** The first level screen names are comprised of the names of the Menu: Submenu selection. This assists with navigating to a particular screen.

#### 10.1.6.4 Navigating Using the Screens

After accessing a screen, the user may conduct a search to find information about a particular beneficiary or month. After narrowing the search to this more specific level, the user may find even more detail by clicking on links and/or buttons that lead to additional screens.

#### 10.1.6.5 An Example

The following example is provided to demonstrate the drill-down navigation method used by the Medicare Advantage and Prescription Drug System (MARx) in its online processing. Note that the screens only indicate the flow. Specific information about the screens' contents is not provided here. See **Section 10.3** for this particular function detail.


This example demonstrates how to view the details of an adjustment for a selected beneficiary during a selected month:

Consider a scenario where the user wants to determine the reason a specific beneficiary has a particular adjustment. Starting at the top level on the MARx main menu, the user selects their general area of interest. The user looks at the screens that pertain to beneficiaries, and clicks on the [Beneficiaries] menu item, as in **Figure 10-9**. The *Beneficiaries: Find (M201)* screen is displayed, as in **Figure 10-10**. Because the user wants to find a specific beneficiary, they should enter the Health Insurance Claim Number (HICN), as shown in **Figure 10-11**, and click on the [Find] button.

This displays the *Beneficiaries: Search Results (M202)* screen, as in **Figure 10-12**. In this example, there is only one beneficiary who meets the selection criteria. However, if, for example, the BIC is not entered on the search, it is possible to have more than one beneficiary who meets the selection criteria.

From here, the user can view beneficiary summary information returned from the search based on the input criteria, or the user can drill down to find more detailed information about a specific beneficiary. In this example, the user wishes to view adjustment information for a beneficiary. The first step to viewing this information is to click on the linked Claim# associated with the beneficiary, **XXXXXXXXXA**. This displays the *Beneficiary Detail: Snapshot (M203)* screen, as shown in **Figure 10-13**. This is a secondary, i.e., pop-up window, which has a different header with the Beneficiary’s name, claim number, DOB, street address, age, sex, state, and county. Because this is a pop-up window, there is a [Close] button in the upper right-hand corner of the body of the window.

To view adjustment information specific to a beneficiary, the user selects the |Adjustments| menu item, located just below the header. See **Figure 10-14** for screen display.

Next, to obtain the adjustments for a particular payment date, the user enters the Payment Month, in this case, 08/2011, and clicks on the [Find] button. This displays adjustment information for that beneficiary for months up through and including the payment month, as shown in **Figure 10-15**.

Finally, the user selects a particular adjustment by clicking on the month/year link in the Adjustment Date column, in this case, 07/2011, to display **Figure 10-16**.

At this point, a display-only screen appears. There are no other links or options for drilling down, but the user has access to all the information regarding this beneficiary’s adjustments.

Again, the drill-down method enables the user to navigate from very general information to very specific information just by following a path of menu and submenu items, links, and searches. Appendix G provides more information and a complete description of the system navigational hierarchy.

Payment adjustments due to system clean-ups can be uniquely identified on the Payment/Adjustment Detail (M215) Screen by a Clean-Up Identifier, which also appears on the MMR data file. The identifiers provide a convenient reference and linkage to documentation provided via Plan communications from CMS to enhances the Plan’s understanding of a particular payment adjustment.

## 10.2 Logging On and Viewing Messages

To use the UI online, the user must log on. A screen containing messages and the calendar appears.

### 10.2.1 Logging On

#### 10.2.1.1 STEP 1: Accessing the Logon screen

Section 10.2.1 includes instructions on logging onto the CMS applications portal and navigating to the UI. If successful, the *User Security Role Selection (M002)* screen displays, from which the user selects their role. If the system is down when the user tries to log on, the browser displays a message, stating that the *page is unavailable* or the *page cannot be found*. The content of this message is dependent on the browser, not on the system.


If the system is up and logon is unsuccessful, the *Logon Error (M009)* screen displays an error message describing why logon failed. See **Figure 10-17**.

**10.2.1.2 STEP 2: Selecting a Role**

The *User Security Role Selection (M002)* screen displays the roles available to the user. Typically, a user has only one role available, and that role is selected. This screen is shown in **Figure 10-18** and described in **Table 10-4**, with error and validation messages provided in **Table 10-5**.



### **10.2.2 Viewing System Broadcast Messages**

Broadcast messages display for all users and provide information about system-wide events, such as the start or completion of month-end processing. These messages expire without any user action.

#### **10.2.2.1 STEP 1: Accessing the Welcome (M101) Screen**

From the system main menu, the user clicks on the |Welcome| menu item. This displays the *Welcome (M101)* screen.

#### **10.2.2.2 STEP 2: Viewing the Broadcast Messages**


The broadcast messages show on the *Welcome (M101)* screen under the Broadcast Messages heading. The list of messages refreshes every time the user returns to the screen.

### 10.2.3 Viewing the Calendar

From the calendar, there is a list of operational events scheduled for any month.

#### 10.2.3.1 STEP 1: Accessing the Calendar (M105) Screen

From the system main menu, the user clicks on the |Welcome| menu item. This automatically selects the *Welcome (M101)* screen. The user clicks on the [MARx Calendar](#) link to display the *Calendar (M105)* screen, as shown in **Figure 10-20** and described in **Table 10-8**, with error and validation messages provided in **Table 10-9**.

### 10.2.3.2 STEP 2: Viewing the Calendar Events

The top part of the screen shows a pictorial calendar for one month. When the screen first displays, the current month shows with the current day highlighted in blue. The bottom part of the screen, i.e., the operational calendar, shows the calendar events scheduled for that month, with the date and description of each event.

### 10.2.3.3 STEP 3: Changing the Month

To view a different month, select a different month and/or year in the pictorial calendar. The calendar for the new month is then displayed.

To view the operational calendar for the newly selected month, click on the [Re-display] button in the bottom part of the screen.


### 10.2.4 Logging Out of the Medicare Advantage and Part D Inquiry System

When the user is finished with all activities, the user should log out. If the user does not log completely out, the session eventually times out. However, logging out as soon as the user is finished with the system is a more secure process to follow and is therefore recommended.

If the browser window is closed, the user is logged out automatically. To simplify logging out, the user may use the logout screen to close all of windows in one step.

When the user logs on to the system, the logon screen is replaced with a logout screen as shown in **Figure 10-21** and described in **Table 10-10**, with error and validation messages provided in **Table 10-11**. This logout screen is behind the UI primary window and the user may access it at any time by selecting the window.

The user clicks on the [Logout] button. The browser then asks if the user wants to close the window.

### 10.3.1 Finding a Beneficiary

To find information about a beneficiary who is enrolled in a contract; either currently, in the past, or in the future, the user accesses the *Beneficiaries: Find (M201)* screen to search for the beneficiary. Once the person is located, the user can view information on that beneficiary.

#### 10.3.1.1 Validation Messages

**Table 11-12** lists validation messages that appear directly on the screen during data entry/processing in the status line (the line just below the title line, as in **Figure 10-22**).



Because any error associated with the search would display on the *Beneficiaries: Find (M201)* screen, no error messages display. If a user enters an inactive Claim Number for the Beneficiary, a message displays to that effect as shown in **Table 10-16**.




Figure 10-24: MCO Representative (View Only) Beneficiaries: Search Results (M202) Screen

From this screen, the user sees summary information about each beneficiary that meets the search criteria. The user can sort the list by claim number or by name by clicking on the Claim # column heading or the Name column heading, respectively. To see more details about any particular beneficiary in this list, the user clicks on a Claim # link in the Claim # column. This displays the *Beneficiary Detail: Snapshot (M203)* screen in a pop-up window with a menu to get

to various screens. Each screen provides specific details about the beneficiary's enrollment or payment history. These screens are described in more detail later in this section.

### 10.3.3 Viewing Detailed Information for a Beneficiary

The user finds the beneficiary on the *Beneficiaries: Search Results (M202)* screen and drills down for more information.

#### 10.3.3.1 10.3.3.1 STEP 4: Viewing Detailed Information for a Beneficiary

To see detailed information about any of the beneficiaries listed in the *Beneficiaries: Search Results (M202)* screen, the user clicks on the associated Claim #.

**Note:** Instead of seeing a screen in the same area as previously displayed, a new window with a new screen and new header appears. This is a pop-up window, with its own header information specific to the selected beneficiary. The beneficiary's latest mailing address is displayed, along with the current State and County Code (SCC). The header, by itself, is shown in **Figure 10-25**.

In addition, just below the header is a set of menu items, described in **Table 10-17**. The user can switch back and forth among the seven different screens by clicking the menu items. ### 10.3.4 Viewing a Snapshot of Beneficiary Information

A snapshot shows a summary of membership, health status, and payment/adjustment information for the beneficiary as of a specified month. If payments are unavailable for the specified month, the last available payments and adjustments information is shown.

#### **10.3.4.1 STEP 4a: Viewing the Beneficiary Detail: Snapshot (M203) Screen**

The *Beneficiary Detail: Snapshot (M203)* screen, as shown in **Figure 10-26** and **Figure 10-27** and described in **Table 10-18**, with error and validation messages provided in **Table 10-19**, provides payment, status, adjustment, entitlement, eligibility, enrollment, and premium information for the beneficiary as of the date the user specifies. When the beneficiary enrolls in two contracts, one for Part A and/or Part B and the other for Part D, information is displayed on both the contracts. On the initial display, the current date is used. To view the details as of a different date, the user updates the date in the *As Of* data entry area and clicks on the [Find] button. If the beneficiary is enrolled with an effective date in the future, no status information is available. The user changes the *As Of* date to the future date to view the snapshot information. If the beneficiary is not currently enrolled, a status message states that “the latest available snapshot information is for a payment month in the past and last available payments are adjustments”.

When the beneficiary enrolls in Part A and/or Part B and the other for Part D, two rows covering the same time period display. The screen is described in **Table 10-22**; note that the Payments section is not yet displayed, with error and validation messages provided in **Table 10-23**.

**Note:** The user can only see contracts to which the user has access. Therefore, gaps may exist in the user’s list where the user cannot see the enrollment information.




Figure 10-30: MCO Representative (UI Update) Beneficiary Detail: Enrollment (M204) Screen (Initial Display)




Figure 10-36: MCO Representative (UI Update) Update Enrollment (M212) Screen



To access the *Beneficiary Detail: Status (M205)* screen, the user clicks on the |Status| menu item. This displays a screen, as shown in **Figure 10-38**, with a list of enrollment and health status periods by enrollment period, contract/PBP/segment, for this beneficiary. The information displays as follows:

- When more than one status applies to the beneficiary during an enrollment, such as when the beneficiary is in a hospice and has ESRD status, each status appears on a separate row.
- If there are non-contiguous periods for a status, such as a break in Medicaid coverage, then each period appears on a separate row.
- If the details for a status change, such as a change in hospice provider, the contiguous status periods combine and display as one period. When requesting the period details, this combined period expands to show changes in those details. If there is no status information for an enrollment period, that enrollment period is not displayed.
- When the beneficiary is enrolled in two contracts, one for Part A and/or Part B and the other for Part D, and there is an applicable status for each contract, rows for each contract display.

This is how the screen appears when it initially displays. This screen is described in **Table 10-40**; note that the details section is not yet displayed, with error and validation messages provided in **Table 10-41**.

The premium information includes the history of basic premiums paid by the beneficiary, the penalty for late enrollment added to the premiums, and the subsidies paid by the Government that reduce the premiums.

#### 10.3.9.1 STEP 4o: Viewing the Beneficiary Detail: Premiums (M231) screen

To access the *Beneficiary Detail: Premiums (M231)* screen, the user clicks on the [Premiums] menu item. This displays a screen, as shown in **Figure 10-44**, that provides a field for entering a payment month and year. When the beneficiary enrolls in two contracts; one for Part A and/or Part B and the other for Part D, two rows for the same month are displayed. Upon initial display, the current month appears in that field. 



To access the *Beneficiary Detail: Medicaid (M236)* screen, the user clicks on the [Medicaid] menu item. This displays a screen, as shown in **Figure 10-57**, with a list of Medicaid periods for this beneficiary. The information displays as follows:

- When a beneficiary has Medicaid periods reported by multiple entities, e.g., a State Medicaid program, a Plan, each reported Medicaid period is shown on a separate row.
- If there are non-contiguous Medicaid periods, e.g., when there is a break in Medicaid coverage, then each period is displayed on a separate row.
- If there has been no Medicaid reported for a beneficiary, the Medicaid screen is empty.
- The screen does not provide Medicaid periods for dates that are not used in calculation Part C risk scores. CMS does not use Third Party Medicaid periods in calculating risk scores after Medicaid dates in 2007.





**10.3.16 View Beneficiary Residence Address**

SSA provides CMS with a beneficiary address. This is not always the address through which the Plan interfaces with the beneficiary. A Plan user with update authority may enter an address. These addresses are associated with the period of time during which each is effective. Beneficiary eligibility provides information regarding a beneficiary’s entitlement for Part A, Plan B, and eligibility for Part D, as applicable and relevant to the Plan. If the beneficiary is eligible for the Part D LIS, then the number of uncovered months is indicated, as are then the details of that subsidy. Periods when a beneficiary is covered in a Plan that qualifies for the Retiree Drug Subsidy (RDS) are shown. Periods when a beneficiary was covered in a Part D Plan are also shown. Depending upon the user’s access rights, either the current information or the complete history is shown. Plans may also submit Batch Eligibility Queries as described in Section 6 of this guide.

**10.3.16.6 STEP 5a: Viewing the Beneficiary: Eligibility (M232) screen**

From the main menu, the user clicks on the |Beneficiaries| menu item, and then clicks on the |Eligibility| submenu item to view the *Beneficiary: Eligibility (M232)* screen.

The next step is to identify the beneficiary by claim number on the *Beneficiary: Eligibility (M232)* screen, which is shown in **Figure 10-64**; note that beneficiary identification, entitlement, eligibility, number of uncovered months, employer subsidy, Part D enrollment, and low-income status are not yet shown but appear later on this screen and described in **Table 10-70**, with error and validation messages provided in **Table 10-71**.

Using the Medicare Advantage and Part D Inquiry System Online Operations

Entitlement, Eligibility, employer subsidy, and LIS display as follows:

- If a date is entered, then only the information for that date is shown.
- If a date is not entered and the beneficiary is enrolled in one of the user's Plans, then current, historical, and future information is shown.
- If the beneficiary is not enrolled in one of the user's Plans, then only the current information is shown.
- When the beneficiary was not covered by a Plan that received the RDSRDS, a message is displayed in the Employer Subsidy section.
- When the beneficiary does not receive a Part D LIS, message displays in the LIS section.

NUNCMO section displays as follows:

Tool tips display when hovering over the Indicator and Record Type columns Part D enrollments display as follows:

- The 10 most recent periods of Part D enrollment are shown, including Plans with employer subsidies.
- If there are several Part D enrollments back to back, the screen displays the start date of the first enrollment and the end date of the last enrollment.
- When the beneficiary does not have Part D Enrollment information, a message displays in the Part D Enrollment section.

Enrollment Information displays as follows:

- The Contract number, Effective date, and Drug Plan indicator of the beneficiary's current enrollment in the PBP is displayed.
- If the beneficiary is dual enrolled, the system displays the drug and non-drug Contract information for both of the beneficiary's current enrollments in PBPs.
- If the beneficiary is enrolled in a Plan that does not have PBPs, the Contract, Drug Plan indicator and the Effective date of the beneficiary's current enrollment is displayed.
- If the user enters a date in the "Date" field, the system considers the entered date as the current date when displaying the beneficiary's current enrollment information.

### 10.3.17 View Beneficiary Rx Insurance

#### 10.3.17.1 Step 6: Viewing the Rx Information for a Beneficiary

A Plan can use the M244 screen to view the Rx Insurance history, both primary and secondary, for beneficiaries enrolled in their Plans. The screen displays the beneficiary's 4Rx information as it has changed over time. The Plan only sees 4Rx information for periods during which the beneficiary is enrolled in any of their Part D Plans.

The *Payment/Adjustment Detail (M215)* screen is accessible by clicking on a [Payment Date](#) or [Adjustment Date](#) link from the following screens:

- Beneficiary Detail: Enrollment (M204).
- Beneficiary Detail: Payments (M206).
- Beneficiary Detail: Adjustments (M207).
- Beneficiary Payment History (M406).

The screen, as shown in **Figure 10-70**, provides payment and adjustment details for the selected month and contract. Adjustments are listed by adjustment reason code and are shown for the month in which they are paid, not the month to which they apply. When a blended rate displays, the demographic and risk-adjusted components used in the blending calculation also displays. Any additions and subtractions for bonuses, rebates, and/or subsidies are on separate lines. The screen is described in **Table 10-80**, with error and validation messages in **Table 10-81**.

## 10.4 View Status of Batches Submitted

When a transactions batch file is submitted, the user may track its progress through the enrollment processing. This progress information includes:

- Dates and times when the file was received, when the file was processed, and when the Batch Completion Status Summary (BCSS) Report was generated for the file.
- Counts of transactions by status.
- Counts of transactions by transaction type.

There are three possible batch transaction statuses:

- Successful - Transaction was processed with no errors.
- Rejected - An error occurred when the transaction was processed. The rejected transactions are also saved in the Rejected Transactions File.
- Failed - A failed transaction is one that has an error that is so severe the transaction is not saved.

The *Transactions: Batch Status (M307)* screen displays the status of transaction batch files that were submitted by the user. Additional information about a selected batch is shown in the *Transactions: Batch Status (M307)* screen.

For batches processed before the May 2009 software release implementation, the screen is shown in **Figure 10-73** and described in **Table 10-84**. For batches processed after the May 2009 software release implementation, the screen is shown in **Figure 10-74** and described in **Table 10-85**. 


Figure 10-72: MCO Representative (Transmitter) Batch File Details (M314) Screen (For batches processed prior to May 2009)



**10.4.4 STEP 4: Viewing Special Batch File Requests MCO Representative (Transmitter)**

Plans use the UI to request CMS approval of three types of special batch files: Plan Submitted Rollovers, Retroactive Files, and Organization Special Review. The View Special Batch File Request (M317) screen allows the MCO Representative Transmitter to view the status of these requests. The New Request button on the M317 screen navigates to the Special Batch Approval Request (M316) screen where the user may enter a new special request.

To access the *View Special Batch File Request (M317)* screen from the *Welcome* screen, select *Transactions: File Submission Request*. Once the screen is displayed, search criteria allow the user to find a specific set of requests. These requests are shown in the lower portion of the screen.

**10.4.5 STEP 5: Viewing Special Batch Approval Requests MCO Representative (Transmitter)**

The *Special Batch Approval Request (M316)* screen allows a user with the MCO Representative Transmitter role to enter the details for batch files that need special approval. These include Plan Submitted Rollover files, Retroactive files, and Organizational Special Review files. After entering the details about the special file, the user submits the request for approval. Once submitted, the user may view the approval status for the requests via the *View Special Batch File Request (M317)* screen.

To access the *Special Batch Approval Request (M316)* screen from the *Welcome* screen, select the *|Transactions| tab* followed by the *|File Submission Request| tab*. This opens the *View Special Batch File Request (M317)* screen where the user may select the *New Request* button. This screen also displays the details of previously submitted requests when a specific Request ID link is selected on the *Special Batch File Request (M317)* screen.

There are three varieties of Special Batch Approval Requests: Plan Submitted Rollovers, Retroactive Files, and Organization Special Review. The screen layouts for the Retroactive and Organization Special Review file requests are identical. An example of an Organization Special Review file is shown in **Figure 10-76**. The Plan Submitted Rollover request version includes Application Date as a file-level value, in addition to Batch File Type and Header date.

## 10.5 Viewing Payment Information

This section describes how to view MCO and beneficiary payment information.

### 10.5.1 Viewing MCO Payment Information

Total payments to MCOs are calculated as part of month-end processing. This section describes how to view the MCO payment information. These payment amounts are based on the beneficiary capitation amounts and may differ from the actual payment to the MCO due to contract-level payment adjustments, such as the Balanced Budget Act (BBA) User Fee adjustment. For the Current Processing Month, the payments reflect the transactions processed to date. This section describes the following steps for viewing MCO payment information by user role:

- [STEP 3: Viewing detailed payment information for a selected MCO.](#)

#### 10.5.1.1 10.5.1.1 STEP 1: Accessing the Payments: MCO (M401) screen

From the main menu, the user clicks on the [Payments] menu item. The [MCO] submenu item is already selected and displays the *Payments: MCO (M401)* screen.

#### 10.5.1.2 STEP 2: Viewing payment summary information by MCO

The *Payments: MCO (401)* screen is used for entering selection criteria, as shown in **Figure 10-78** and described in **Table 10-91**, with error and validation messages provided in **Table 10-92**

The user enters the month and year for the payments along with the contract number that the user wishes to view. Another option is for the user to break down the payments by PBP. If that option is not selected, the payments for a contract are summarized at the contract level. If breakdown by PBP is selected, contracts without PBPs are included on the display but summarized at the contract level. Similarly, there is an option to break down the payments by segment. If that option is not selected, the payments for a contract are summarized at the contract or PBP level, based on whether the breakdown by PBP option was selected. If breakdown by segment is selected, PBPs without segments are included but summarized at the PBP level. The user clicks on the [Find] button to access the *Payments: MCO Payments (M402)* screen showing all of the contracts that meet the criteria.

Because the results from this search can vary based on the criteria, the examples following **Table 10-92** provide alternate screen shots for various inputs.

Figure 10-79 provides an example of the *Payments: MCO Payments (M402)* screen that results when only a month/year and contract number are entered on the *Payments: MCO (M401)* screen, PBP is not entered, and Breakdown By PBP is not specified. Note that only the Contracts section is displayed on the screen; the Current Payments and Adjustment Payments sections are displayed in STEP 3. This screen is described in Table 10-93. There are no error messages for the initial display of the screen, as any messages are displayed on *Payments: MCO (M401)* screen. Table 10-94 shows the error and validation messages that may display when the screen is expanded to show sections below the Contracts section.

**Note:** To avoid possible internal server or database manager errors that can result when large plans submit a query request that takes too long to execute or runs out of resources, it is recommended that users input information in the Contract #, PBP # and the Month/Year fields on the *Payments: MCO (M401)* screen. Once this information is submitted, the *Payments: MCO Payments (M402)* displays and the user can then click on the Contract # to display the details.

10.5.1.3 STEP 3: Viewing detailed payment information for a selected MCO

From the *Payments: MCO Payments (M402)* screen, the user finds the contract or contract/PBP that they wish to view. If the list does not fit on the screen, finding the contract/PBP may require scrolling through the list using the screen navigation arrows. The user selects the contract/PBP by clicking on the contract # link. The following information displays for the selected contract and, when applicable, PBP. The information is shown below the contract summary information:

- Part A, Part B, Part D, and total payments.
- Breakdown by health status, separated into Part A, Part B, and Part D, with both the number of members and the payment amounts.
- Breakdown by adjustment reason, separated into Part A, Part B, and Part D, with both the number of members and the payment amounts. Note that this section of the screen is only included when there are adjustments.

Payments are calculated or recalculated for a beneficiary when there is a change in enrollment, demographics, health status, factors, or other information used in the calculation. Adjustments are made to previously made payments that require changes.

The steps below show how to find these payments and adjustments for a particular beneficiary. After the user finds that information, they can view the complete history of payments and adjustments.

#### 10.5.2.1 STEP 1: Accessing the Payments: Beneficiary (M403) screen

From the main menu, the user clicks on the |Payments| menu item. If not already selected, the user clicks on the |Beneficiary| submenu item to view the *Payments: Beneficiary (M403)* screen.

#### 10.5.2.2 STEP 2: Getting a list of beneficiaries

The user accesses the *Payments: Beneficiary (M403)* screen for entering search criteria, as shown in **Figure 10-83** and described in **Table 10-97**, with error and validation messages provided in **Table 10-98**.




Figure 10-82: MCO Representative (View Only) Payments: Beneficiary (M403) Screen



The *Beneficiary Payment History (M406)* screen lists the payments and adjustments for the beneficiary, starting with the month selected on the *Payments: Beneficiary (M403)* screen and going back in time. Each entry in the history includes:

- Month in which the payments/adjustments were made
- Enrollment contract and, as applicable, PBP, and segment
- Payments made that month, itemized by Part A, Part B, Part D, and combined
- Adjustments made that month for previous months, itemized by Part A, Part B, Part D, and combined
- Total amount paid in the month
- Indicator of whether a Part B premium reduction was taken
- Payment from the regional MA BSF


To view a further breakdown of the payments and adjustments, the user clicks on the month/year link, which opens the *Payment/Adjustment Detail (M215)* screen, **Section 10.3.18**.

### 10.5.4 Viewing Basic Premiums and Rebates

This section describes how to view the basic premiums and rebates for a contract, contract/PBP, or contract/PBP/segment combination. These are the premiums and rebates negotiated with an MCO, not the premiums and rebates calculated for a beneficiary.

#### 10.5.4.1 STEP 1: Accessing the Basic Premiums and Rebates (M409) screen

From the main menu, the user clicks on the |Payments| menu item. If not already selected, the user clicks on the |Premiums/Rebates| submenu item to view the *Basic Premiums and Rebates (M409)* screen, as shown in **Figure 10-86** and described in **Table 10-103**, with error and validation messages provided in **Table 10-104**.

## 10.6 Reports

This section describes how to order copies of reports and data files generated for previous months. The ordered reports deliver via Connect:Direct or Gentran. See Section 1.6.1.

There are various types of reports in MARx:

- Daily or randomly occurring reports and data files generate each day for events that occurred that day, including batch transaction file processing or report receipt.
- Weekly reports and data files are scheduled and automatically generate to reflect transactions processed that week for a contract.
- Month-end reports and data files are scheduled and automatically generate as part of monthly payment processing.
- Year-end reports and data files are scheduled and automatically generate as part of monthly payment processing.

**Note:** Only MCO Representative Transmitters may order reports. Appendices F and J provide descriptions and samples of data and report files.

### 10.6.1 STEP 1: Accessing the Reports: Find (M601) screen

From the main menu, the user clicks on the |Reports| menu item.

### 10.6.2 STEP 2: Getting a list of reports

From the *Reports: Find (M601)* screen, the user chooses the report frequency; monthly, weekly, daily or yearly. The selection criteria displayed is affected by the frequency chosen. The user enters the selection criteria that characterize the reports requested. The user clicks on the [Find] button to bring up the *Reports: Search Results (M602)* screen showing all of the reports that meet the criteria.

The *Reports: Find (M601)* screen with selection criteria for monthly reports is shown in **Figure 10-88** and described in **Table 10-105**, with error and validation messages provided in **10-106**.






Figure 10-91: MCO Representative (Transmitter) Reports: Search Results (M602) Screen for Yearly Reports
