## **CMS 2008 Enrollment and User Rates**

## for Basic Stand Alone (BSA) Public Use Files (PUFs)

This supplement includes tables showing enrollment in Fee-for-Service (FFS) Medicare programs in calendar year 2008 and user rates based on the 2008 BSA PUFs that are available for each type of claim covered by Medicare.

Table 1 provides the unduplicated number of beneficiaries enrolled in FFS Medicare in 2008 by gender, age categories, and total months of enrollment in FFS Medicare Part A and/or Part B. Table 1 includes beneficiaries who were enrolled in Fee-for-Service Medicare Part A and/or Part B for at least one month in 2008. Examples of included beneficiaries are beneficiaries who i) turned 65 in 2008 and enrolled in traditional Medicare Part A and/or Part B, ii) enrolled in traditional Medicare Part A and/or Part B for part of 2008 and in Health Maintenance Organization (HMO), or Part C, plans in other months of 2008, and iii) enrolled in traditional Medicare Part A and/or Part B for part of 2008 but died later in 2008. It **excludes** beneficiaries who were enrolled **only** in HMO Plans in 2008.

Table 2 provides the unduplicated number of beneficiaries enrolled in Medicare Part D by gender, age categories, and total months of enrollment in Medicare Part D.

Tables 3-10 provide user rates by using the available information in each of the BSA PUFs and/or the general documentation that accompany the file together with the information in Tables 1-2. For example, the user rate for Inpatient Services (Table 3) is measured by the number of beneficiaries with at least one inpatient claim in 2008 in the *CMS 2008 BSA Inpatient Claims PUF* (provided in the general documentation for the PUF) multiplied by twenty (20) to estimate the number of beneficiaries in the Medicare population divided by the number of beneficiaries provided in Table 1 for the same gender, age category, and total months of enrollment in FFS Medicare Part A.
