

MEDICARE BENEFICIARIES AT A GLANCE - METHODOLOGY

OVERVIEW

The Centers for Medicare & Medicaid Services (CMS) has developed the Medicare Beneficiaries at a Glance infographic, which provides a visual summary on Medicare beneficiaries, including types of coverage, utilization, average cost for specific services, top chronic conditions, beneficiary satisfaction and access to care, and usual source of care. The data presented in the infographic are based on CMS administrative enrollment and fee-for-service claims data from the CMS Chronic Conditions Data Warehouse (CCW), as well as statistics collected from the Medicare Current Beneficiary Survey (MCBS).

Outpatient Emergency Department Visit	CCW	The ‘visits per enrollee’ rate is based on the number of Medicare Part B fee-for-service beneficiaries who were enrolled at any point during the calendar year. Payments were calculated by aggregating the outpatient Emergency department charge along with all Part b non-institutional charges occurring on the same day, excluding Ambulance and Durable Medical Equipment (DME) services.

Doctor Visit	CCW	Average payments and ‘visits per enrollee’ are based on the number of Medicare Part B fee-for-service beneficiaries who were enrolled at any point during the calendar year with a doctor visit (includes doctor visits in any setting, e.g. office, inpatient hospital, outpatient hospital).
30-Day Prescription	Part D Prescriber Public Use File	The ‘fills per enrollee’ rate is based on Medicare Part D beneficiaries who were enrolled at any point during the calendar year.
