¹Total Part A enrollees for 2014 was 53,674,802. The 'program payments per Part A enrollee' rates are based on enrollees in Original Medicare and Medicare Advantage/Other Health Plans combined, because once a beneficiary enrolled in a Medicare Advantage/Other Health Plan elects the hospice benefit, his or her Medicare benefits revert to fee-for-service.

NOTES: The 'persons with utilization' counts do not add to totals because beneficiaries may use more than one service during the reported year. The payment amounts may not sum to totals because of rounding.
