²Service Intensity Add-On (SIA) payments are an addition to the per diem Routine Home Care rate, made for services furnished during the last 7 days of a patient's life; such services are provided by a registerd nurse (RN) or social worker. These payments became effective on January 1, 2016.

NOTES: The 'persons with utilization' counts do not add to totals because beneficiaries may use more than one service during the reported year. The payment amounts may not sum to totals because of rounding.
