



 Gross Domestic Product: Calendar Years 1980-2016






Figure 1.3 Personal Health Care Expenditures, by Source of Funds: Selected Calendar Years 1960-2005



¹Total personal health care expenditures for 1960 were \$23.3 billion (\$12.9 billion in direct-patient payments and \$10.5 billion in third-party payments).


