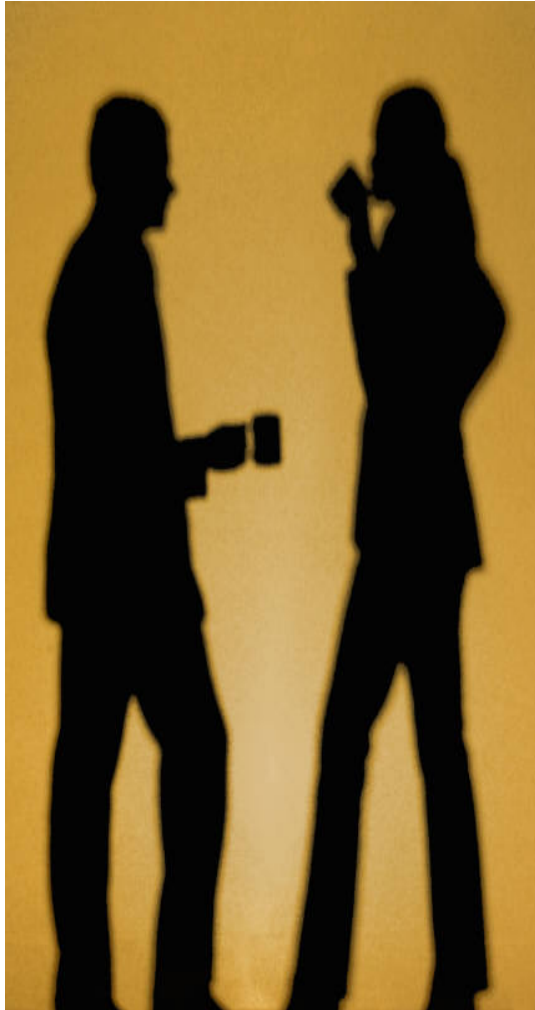

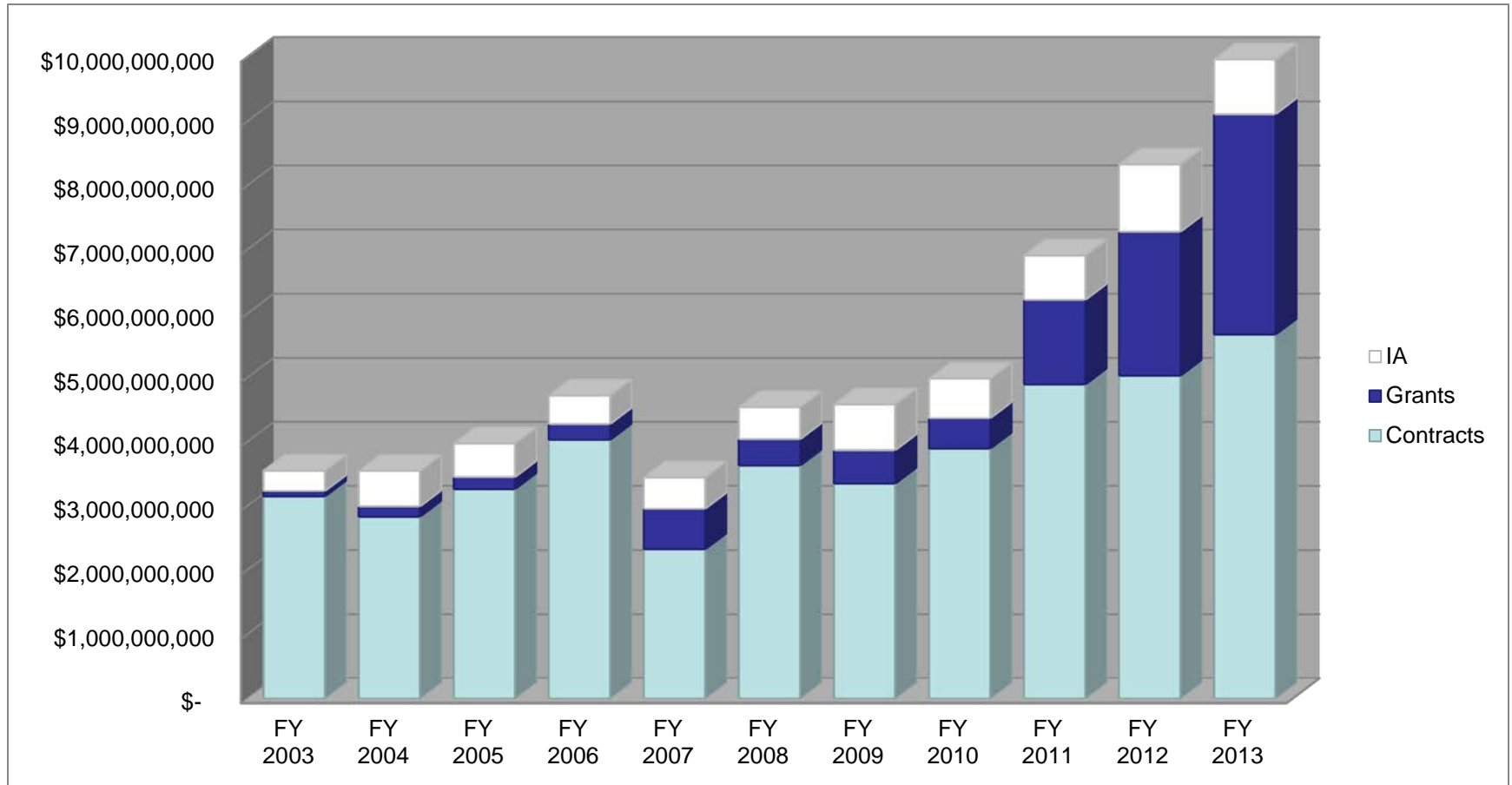

Who We Are



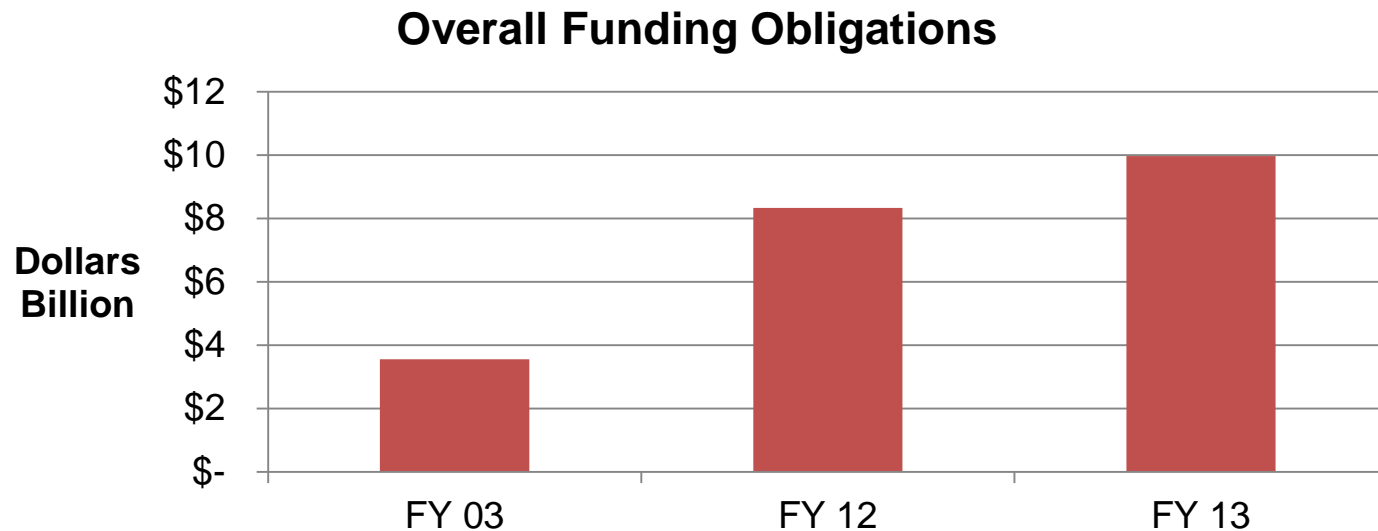

OAGM Funding Obligations

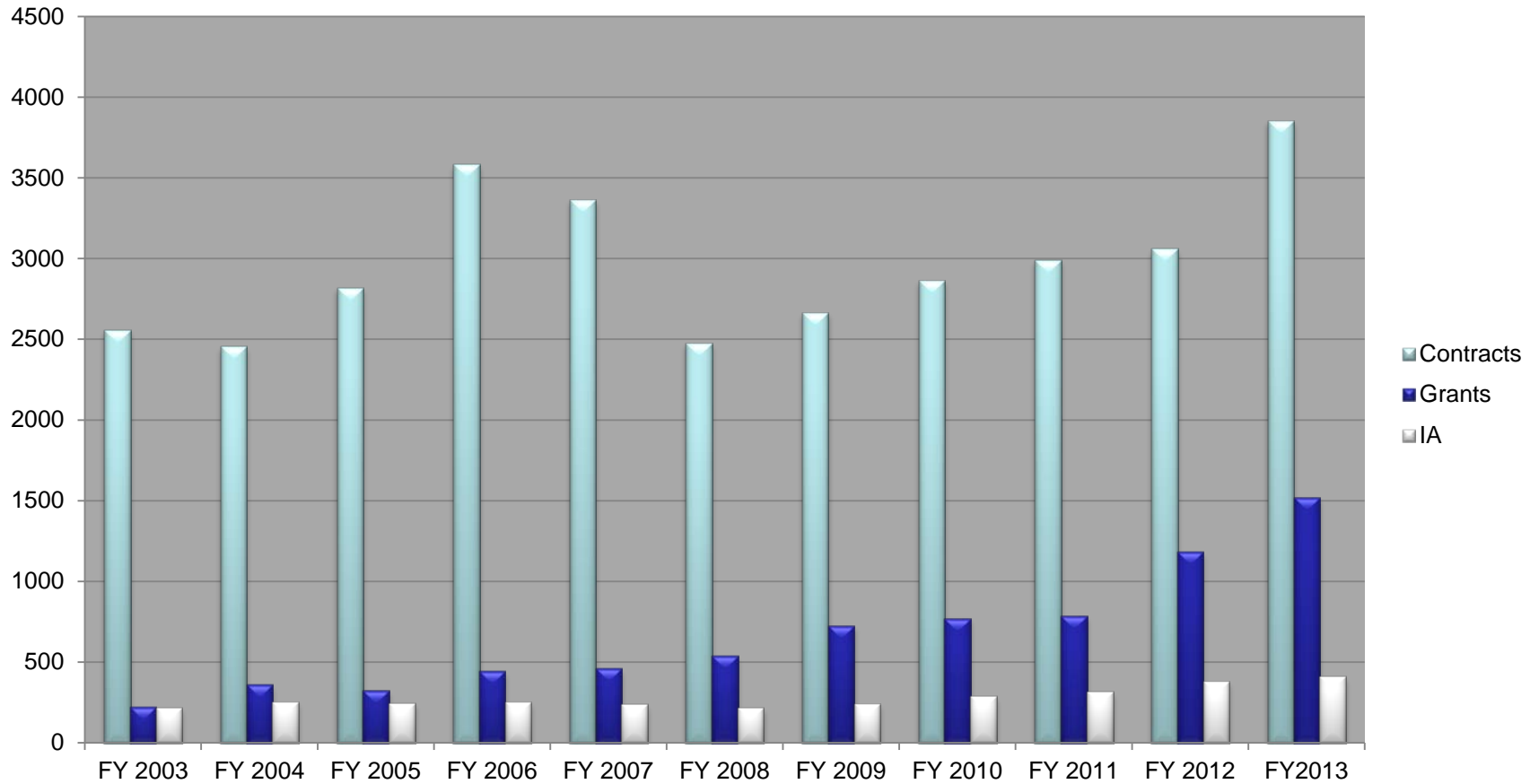


Our Overall Increase in Funding Obligations

- **Significant Increase in Contracts, Grants, and Interagency Agreements:**
 - >180% overall funding obligation increase between FY 03 and FY 13
 - >19% overall funding obligation increase between FY 12 and FY 13

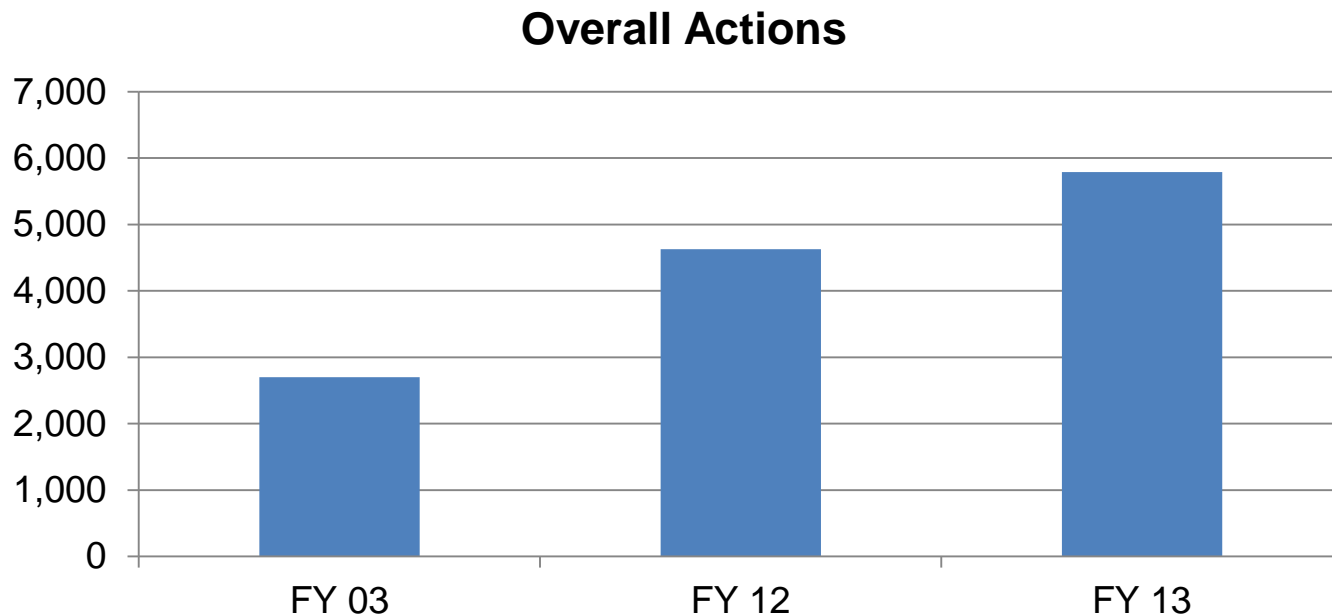


OAGM Actions



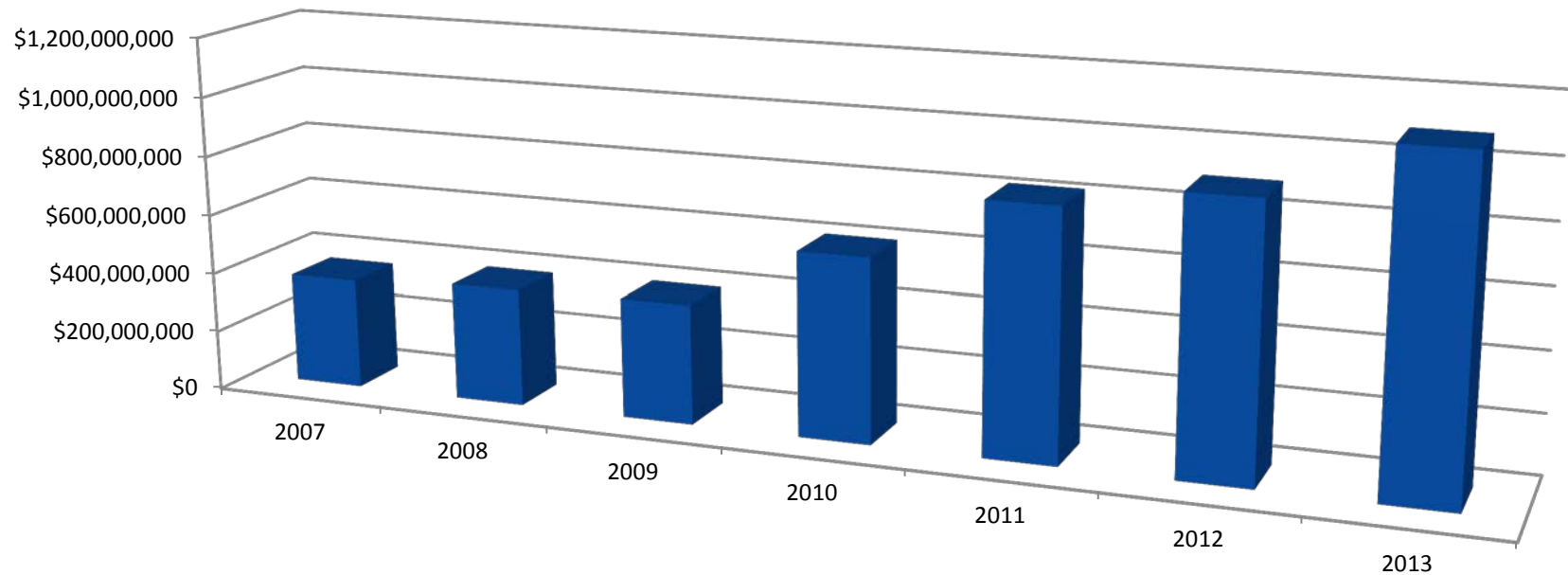
Our Overall Increase in Actions

 - >114% overall actions increase between FY 03 and FY 13
