Dear Director Butay:

On December 10, 2021, the Department of Health and Human Services and the Department of the Treasury approved Hawaii's application for an extension of its State Innovation Waiver under Section 1332 of the Patient Protection and Affordable Care Act (ACA). Hawaii's approved extension application waives the ACA's requirement that a Small Business Health Options Program (SHOP) operate in Hawaii, and other related requirements relevant to SHOP Exchanges, for plan years 2022 through 2026.

It is the Department of the Treasury's final administrative determination that, after application of sequestration at the fiscal year 2024 rate of 5.7 percent (\$2,736), Hawaii's net pass-through funding amount for calendar year 2024 is \$45,269, which must be used for purposes of implementing Hawaii's State Innovation Waiver.

Hawaii's approved extension application waives the ACA's requirement that a Small Business Health Options Program (SHOP) operate in Hawaii, and other related requirements relevant to SHOP Exchanges, for plan years 2022 through 2026.

This letter is to notify you that the pass-through funding associated with this waiver for calendar year 2024 is estimated to be \$48,005, which must be used for purposes of implementing Hawaii's State Innovation Waiver. This amount will be subject to a final administrative determination by the Department of the Treasury prior to payment. In addition, this amount will be subject to fiscal year 2024 sequestration. As a result, amounts payable in fiscal year 2024 will be reduced by 5.7 percent. The estimated amount after sequestration is \$45,268.72.
