On January 15, 2025, the Department of Health and Human Services and the Department of the Treasury approved New York's application for an extension of its State Innovation Waiver under section 1332 of the Patient Protection and Affordable Care Act (ACA). New York's approved extension application waives sections 1312(c)(1) and 1402 of the ACA, as well as section 36B of the Internal Revenue Code, to allow for the full implementation of the Essential Plan Expansion, including affordability programs such as subsidies for certain Exchange enrollees, for plan years 2025 through 2029.

It is the Department of the Treasury's final administrative determination that New York's final pass-through funding amount for calendar year 2025 is \$15,852,383,835. Due to the nature, structure, and financing of the waiver, New York was provided interim pass-through funding in the amount of \$7,000,000,000 on January 10, 2025 and \$5,000,000,000 on June 23, 2025. Therefore, New York will receive an additional \$3,852,383,835 in pass-through funding in December 2025. All pass-through funding must be used for purposes of implementing New York's State Innovation Waiver.

On January 15, 2025, the Department of Health and Human Services and the Department of the Treasury approved New York's application for an extension of its State Innovation Waiver under section 1332 of the Patient Protection and Affordable Care Act (ACA). New York's approved extension application waives sections 1312(c)(1) and 1402 of the ACA, as well as section 36B of the Internal Revenue Code, to allow for the full implementation of the Essential Plan Expansion, including affordability programs such as subsidies for certain Exchange enrollees, for plan years 2025 through 2029.

Due to the nature, structure, and financing of the waiver, and as described in New York's specific terms and conditions, New York has been provided interim pass-through funding pending a determination of the final pass-through amount for the calendar year. Specifically, on January 10, 2025, New York received an interim pass-through funding amount for the 2025 calendar year of \$7,000,000,000. However, given that a pass-through amount is still being finalized for calendar year 2025, the Department of the Treasury has determined that it is appropriate to make a second interim pass-through payment to New York in the amount of \$5,000,000,000. A determination by the Department of the Treasury with respect to New York's final 2025 pass-through funding amount will be made as soon as practicable in 2025. All pass-through funding must be used for purposes of implementing New York's State Innovation Waiver.

On September 25, 2024, the Department of Health & Human Services and the Department of the Treasury approved New York's application for an amendment to its State Innovation Waiver under section 1332 of the Patient Protection and Affordable Care Act (ACA). New York's approved amendment application waives sections 1312(c)(1) and 1402 of the ACA, as well as section 36B of the Internal Revenue Code, to allow for the full implementation of the Essential Plan Expansion for April 2024 through plan year 2028 and includes among its affordability programs subsidies for certain Exchange enrollees for plan years 2025 through 2028.

Due to the nature, structure, and financing of the waiver, and as described in New York's specific terms and conditions, pass-through funding will be made available to the state in two portions. The Department of the Treasury has determined that New York's interim pass-through funding amount for calendar year 2025 is \$7,000,000,000; a determination by the Department of the Treasury with respect to New York's final 2025 pass-through funding amount will be made by April 2025. All pass-through funding must be used for purposes of implementing New York's State Innovation Waiver.
