NOTES: "Medicare-Medicaid Enrollees" is synonymous with the term "Dual Eligible Beneficiaries" that has been used in prior reports by CMS and other organizations.

Total MMEs is the sum of "Full-Benefit MMEs" and "Partial-Benefit MMEs". Full-benefit MMEs include QMBs Plus, SLMBs Plus, and Other Full-Benefit MMEs with Medicaid.

Partial-benefit MMEs include QMBs, SLMBs, QDWIs, and Qualifying Individuals. The enrollment counts are determined using a person-year methodology. Numbers may not add to totals because of rounding.
