# Group Performance Information on Medicare Care Compare 2019 Doctors and Clinicians Public Reporting

### Overview

This document summarizes the group and virtual group<sup>1</sup> performance information and plain language measure and activity titles<sup>2</sup> that are publicly reported on <u>Medicare Care Compare</u> and in the <u>Provider Data Catalog (PDC)</u>. The Centers for Medicare & Medicaid Services (CMS) is publicly reporting 2019 Quality Payment Program (QPP) group performance information. Performance information that meets statistical public reporting standards (valid, reliable, comparable, and meet the minimum reliability threshold) is included in the PDC.<sup>3</sup> A subset of this information is published on Care Compare profile pages. Any information publicly reported on profile pages must also resonate with patients and caregivers, as shown through user testing.

The 2019 QPP group performance information that is publicly reported on Care Compare and in the PDC includes Merit-based Incentive Payment System (MIPS) and QCDR quality measures, Consumer Assessment of Healthcare Providers and Systems (CAHPS) for MIPS Summary Survey measures, MIPS Promoting Interoperability measures and attestations, and MIPS Improvement Activities attestations.
