**Title: Entities Approved to Use Enhanced Direct Enrollment**

Enhanced direct enrollment (EDE) is a new pathway for consumers to enroll in health insurance coverage through the Federally-facilitated Exchange. This pathway allows CMS to partner with the private sector to provide a more user-friendly and seamless enrollment experience for consumers by allowing them to apply for and enroll in an Exchange plan directly through an approved issuer or web-broker without the need to be redirected to [HealthCare.gov](http://HealthCare.gov) or contact the Exchange Call Center.
