SUBJECT: Notice of Accountable Care Organizations (ACOs) Participating in Performance Year 2025 of the ACO Primary Care Flex (ACO PC Flex) Model

The Center for Medicare and Medicaid Innovation is announcing that 24 accountable care organizations (ACOs) are participating in Performance Year 2025 (PY 2025), the first year of the ACO Primary Care Flex (ACO PC Flex) Model (see Table 5 for list of ACOs). PC Flex ACO Participants and ACO Provider/Suppliers have service areas in the following 37 states: AL, AZ, AR, CA, CT, DE, FL, GA, ID, IN, KS, KY, LA, MA, MD, MI, MO, MT, NC, NE, NH, NJ, NV, NY, OK, OR, PA, RI, SC, SD, TN, UT, VA, WA, WV, WY. These PC Flex ACOs serve Medicare beneficiaries in all 50 states as well as in the District of Columbia.

The ACO PC Flex Model is a voluntary model that focuses on primary care delivery in the Medicare Shared Savings Program. The purpose of the ACO PC Flex Model is to improve individuals' experience and access to care, while supporting primary care to deliver on key outcomes. The model tests how prospective payments and increased funding for primary care in ACOs impact health outcomes, quality, and costs of care. The flexible payment design will empower participating PC Flex ACOs and their primary care providers to use more innovative, team-based, person-centered and proactive approaches to care.

Participants in the ACO PC Flex Model may participate in different risk tracks of the Medicare Shared Savings Program. For PY 2025, 21 PC Flex ACOs elected ENHANCED, 2 PC Flex ACOs chose BASIC Track A and 1 PC Flex ACO is participating in BASIC Track E.
