# MEMBERSHIP RENEWAL AND PAYMENT OF YEAR 2014 DUES

We have finally been settled into our new Alumni Office, at 2520 Lord Baltimore Drive, and so we are now beginning the collection of the annual dues, this time for the year 2014, covering the period of January 1, 2014 through December 31, 2014. Members receiving this issue via email will find a renewal form attached to their e-mail regardless of whether they need to renew. Those members will also receive a complete electronic Member Directory, which will include a column labeled **EXPIRDT**, which contains the date their membership expires. Those with a date later than 12/31/13 should ignore the renewal form, as they do not need to renew at this time.

Members who receive this issue in hard **copy via the mail**, because we do not have an e-mail address for you or because you advise us that you are not computer savvy enough to handle an electronic newsletter, will receive a renewal form only if they **need one**. To facilitate keeping track of individual enrollment periods, the mailing labels used to send the HCFA/CMS Alumni News contain the member's I.D. Number and the date of expiration of enrollment, i.e., 12/31/13. Those with a date later than 12/31/13 do NOT need to renew at this time. If you have already paid your 2014 dues you should NOT find an enrollment form included with this issue.

When using the form to mail in your dues, please note any changes in information so we may update our records (i.e. address, email, phone number, etc.)

Also responding to popular request, we continue to accept membership enrollment (or re-enrollment) for multiple years. Dues are \$5.00 per year and members can sign up for any number of years. Because the dues are nominal, there are no discounts for multiple year enrollments and there is no "lifetime" membership. Multiple year enrollments are available as a convenience to members.

### **COLA COUNT**

Through three months of the counting period toward the January 2015 federal retiree cost of living adjustment, the inflation index used to set that adjustment stands at minus 0.50 percentage points below the 2013 third quarter average base index of 230.327. The current index stands at 222.174. The annual COLA count measures the change in the index's average from base period third calendar quarter to the latest. There are nine months left in the counting

period. Should the count finish in negative territory for the full 12 months, benefits would be frozen but not reduced. That happened twice in recent years.

# FEHB "UUDERSERVED" AREAS CHANGES

The list of "medically underserved" areas for FEHB program purposes is changing slightly in 2014, potentially affecting enrollment decisions for next year. States on that list are deemed to have critical shortages of primary care physicians. The designation requires FEHB fee-for-service plans to provide benefits to participants who use any health care provider licensed to perform the medical service at issue. The new list is Alabama, Arizona, Idaho, Illinois, Louisiana, Mississippi, Missouri, New Mexico, North Dakota, Oklahoma, South Dakota, and Wyoming. Montana and South Carolina are being dropped.

might be interested in hearing that I had a heart transplant on October 8. I was discharged 9 days after the surgery and am doing quite well. It is truly amazing how much better I feel!
