

# Naloxone in Nursing Facilities: A Checklist for Process Review

Naloxone is a drug that reverses respiratory depression caused by opioid overdose. Having naloxone readily available in nursing homes is a best practice that can save lives.

The Center of Excellence for Behavioral Health in Nursing Facilities (COE-NF) developed a checklist of questions to support nursing homes when using naloxone or evaluating existing naloxone policies and procedures. If you answer “No” to any of the questions below, meet with your clinical team to consider establishing a protocol or contact the COE-NF for assistance.
