Project Title: Electronic Clinical Quality Measure (eCQM) Development and Maintenance for Eligible Clinicians

Project Overview:

The Centers for Medicare & Medicaid Services (CMS) has contracted with Mathematica and its partners to develop, electronically specify, and maintain eCQMs for eligible clinicians for potential consideration and use in CMS quality programs. The contract name is Electronic Clinical Quality Measures (eCQM) Development and Maintenance for Eligible Clinicians. The contract number is #75FCMC18D0032, Task Order #75FCMC19F0004. As part of its measure development process, Mathematica convenes groups of stakeholders and experts who contribute direction and thoughtful input to the measure developer during measure development and maintenance. Stakeholders include, but are not limited to, clinicians, electronic health record vendor representatives, clinical terminology experts, quality improvement experts, health system representatives, patients and their caregivers, and patients’ representatives. The TEP’s duties include reviewing, prioritizing, and evaluating measure concepts for development. The TEP also reviews and provides guidance on the measures in response to feedback from expert work groups, public comments, and testing results regarding eCQM feasibility, usability, validity, and reliability.
