1. Overview

The intent of this Electronic Submission of Medical Documentation (esMD) Release Summary Document is to communicate information on the release timeline and content to the Health Information Handlers (HIHs) and Review Contractors (RCs) early for the Interim release development cycle for the November 17, 2025 esMD Release (AR2025.11.0).

2. Release Approach

The November 17, 2025 esMD Interim Release AR2025.11.0 consists of analysis, application, and system changes related to the following:

eChimp CR 14193 - Medicare Administrative Contractors (MACs) Operational Requirements for the Prior Authorization (PA) Demonstration for Certain Ambulatory Surgical Center (ASC) Services program.

- 1. HIHs and RCs are requested to use the Technical Release Change (TRC) documents and Implementation Guides (IGs) for additional information regarding the formats and the latest changes.
- 2. HIH and RCs must participate in the scheduled technical calls to receive information that will help them understand the enhancement to the XDR Ambulatory Surgical Center PA program, what to incorporate in the PA response, and what the expected outcomes are if any validations fail.

FHIR Assumptions:

- 1. The current Pickup, Reject, Decision & Admin Response processes shall be same and do not change for the ASCs PA Program (CTC 8.7).
- 2. All the existing requirements, validations, audit events, errors messages and associated transaction status related to the notifications remain the same.
