



## Health Insurance Exchange Public Use Files (Exchange PUFs) General Information

This document outlines important information about the Health Insurance Exchange Public Use Files (Exchange PUFs), including data source, file size, variables, key assumptions, analytic utility, and support information. A data dictionary is also available for each of the separate Exchange PUF files.

### 1. Overview of the PUFs

The Centers for Medicare & Medicaid Services (CMS) Center for Consumer Information & Insurance Oversight (CCIIO) publishes the Exchange PUFs to improve transparency and increase access to data on Qualified Health Plans (QHPs) and Stand-alone Dental Plans (SADPs) offered through the Exchanges in the individual and Small Business Health Options Program (SHOP) markets. The Exchange PUFs include data from Federally-facilitated Exchanges (FFE)<sup>1</sup> including states performing plan management functions<sup>2</sup>, and State-based Exchanges that rely on the federal information technology platform for QHP eligibility and enrollment (SBE-FPs).<sup>3</sup>

The Exchange PUFs exclude data from SBEs that do not rely on the federal platform for QHP eligibility and enrollment.<sup>4</sup> For data on SBE states, see the [State Based Health Insurance Exchange Public Use Files](#) (SBE PUFs).

The PUFs are available for plan years 2014 through 2026 to support timely research and analysis of Health Insurance Exchange data. The 2026 Exchange PUFs will be updated regularly to reflect the plan data that consumers will see when shopping for a QHP or SADP.

Twelve separate files comprise the Exchange PUFs: (1) Benefits and Cost Sharing PUF (BenCS-PUF), (2) Plan Attributes PUF (Plan-PUF), (3) Rate PUF (Rate-PUF), (4) Business Rules PUF (BR-PUF), (5) Service Area PUF (SA-PUF), (6) Network PUF (Ntwrk-PUF), (7) Plan ID Crosswalk PUF (CW-PUF), (8) Machine-readable URL PUF (MR-PUF), (9) Transparency in Coverage PUF (TC-PUF), (10) Quality PUF (Qual-PUF), (11) Nationwide Quality Rating System PUF (NatQRS-PUF) and (12) Enrollee Survey PUF (ES-PUF) .

CCIIO manages the generation and release of the Exchange PUF datasets, with the following specific exceptions: Quality PUF, Nationwide Quality Rating System PUF, and Enrollee Survey PUF. These three PUF datasets are managed by the CMS Center for Clinical Standards and Quality (CCSQ). Note that the Nationwide Quality Rating System PUF and Enrollee Survey PUF are the only two Exchange PUFs that report data on SBE issuers.

## 2. Data Source of the PUFs

The Exchange PUFs contain data submitted by health insurance issuers during the QHP/SADP certification process. In accordance with 45 C.F.R. part 155 subpart K, CMS reviews QHP/SADP applications from issuers that are applying to offer on-exchange QHPs and SADPs in FFE states including states performing plan management functions. SBE-FP states review QHP/SADP applications from issuers that are applying to offer on-exchange QHPs and SADPs in their states. The QHP/SADP application collects both issuer-level information and plan-level benefit and rate data, largely through standardized data templates.

Issuers in FFE states submit standardized QHP/SADP templates to CMS through the Health Insurance Oversight System (HIOS). Issuers in FFE states performing plan management functions or SBE-FP states submit standardized data templates through the System for Electronic Rate and Form Filing (SERFF). Issuers participating in the Multi-State Plan (MSP) Program submit templates through the U.S. Office of Personnel Management's (OPM) online application portal. CMS aggregates data from the three submission systems (HIOS, SERFF, and OPM) to create the Exchange PUFs.

Issuers submit data to CMS separately from the QHP/SADP application for the following Exchange PUFs: Quality PUF, Nationwide Quality Rating System PUF, and Enrollee Survey PUF.

## 3. Description of the PUFs

An overview of the content, format, and size of each of the files that comprise the Exchange PUFs is outlined in the tables below.

## 4. Variables in the PUFs

Each file has a separate data dictionary that describes the construction, format, and values of each variable. Users are encouraged to review the data dictionary for each file prior to conducting analysis.

## 5. Methodology and Key Assumptions

The QHP/SADP application process ensures that plans meet specific QHP/SADP certification standards. To create the Exchange PUFs, CMS extracted and aggregated data from issuers' QHP/SADP applications including information on plan design, benefits, cost sharing, rates, and geographic coverage, as these areas represent the core elements of the QHP/SADP application. Data from plans that did not complete the certification process for display on HealthCare.gov or were withdrawn from the certification process are excluded from the Exchange PUFs.

Users should note that CMS certifies SADPs even if the issuer does not intend to offer them through HealthCare.gov; these plans are referred to as off-Exchange SADPs and are included in the Exchange PUFs. CMS does not certify medical plans that are only offered outside of HealthCare.gov. Therefore, the Exchange PUFs do not include data from off-exchange only medical plans. For additional information on the QHP/SADP application, review, and certification processes in the FFEs including states performing plan management functions, please see the Letter to Issuers in the Federally-facilitated Exchanges that CMS releases before each plan year. ## 6. Further Information

The plan year 2026 Exchange PUFs will be updated regularly during the year to incorporate approved data corrections from issuers including Small Business Health Options Program (SHOP) quarterly rate updates. Note that data in the plan year 2026 Exchange PUFs may vary from the data shown on HealthCare.gov due to differences in dates between the display of approved issuer data changes and the release of updated Exchange PUFs.
