Tips of the Quarter

QM Report Changes – HCI and HVLDL

As finalized in the Fiscal Year (FY) 2022 Hospice Final Rule, effective October 1, 2021, the HQRP includes two new claims-based quality measures: the Hospice Care Index (HCI) and Hospice Visits in the Last Days of Life (HVLDL). As of September 15, 2021, you can view your hospice's scores for HCI and HVLDL in your Agency-Level Quality Measure (QM) Reports, available in the Certification and Survey Provider Enhanced Reports (CASPER). These QM Reports will include hospice and national rates for HVLDL and the overall HCI score. HCI will also include details about the ten individual indicators used to calculate the overall HCI score, including numerator, denominator, and national percentile. Hospices can use this information to deepen their understanding of the measures and initiate efforts to improve the quality of care they deliver.

Star Ratings for CAHPS® Hospice Survey

As finalized in the FY 2022 Hospice Final Rule, CMS will calculate Star Ratings for the CAHPS® Hospice Survey for public reporting on Care Compare. Prior to public reporting, CMS will have a dry run of the Star Ratings through hospice preview reports, beginning in 2022. Additional details around the timing

of the dry run and a review of the Star Ratings methodology will be discussed on a Home Health, Hospice, and DME Open Door Forum (ODF) in fall 2021.


Section 1: HQRP Updates

Fiscal Year (FY) 2022 Hospice Payment Rate Update Final Rule (CMS-1754-F)

On August 4, 2021, the FY 2022 Hospice Wage Index and Payment Rate Update, Hospice Conditions of Participation Updates, Hospice and Home Health Quality Reporting Program Requirements Final Rule was published. This rule finalizes changes to the Hospice Conditions of Participation (CoPs) and Hospice Quality Reporting Program (HQRP). The rule is effective on October 1, 2021.

As a result of this rule, the HQRP will contain four quality measures that capture care across the hospice stay. These measures are:

- HIS-based Hospice Comprehensive Assessment at Admission (NQF #3235)
- Claims-based Hospice Care Index (HCI)
- Claims-based Hospice Visits in the Last Days of Life (HVLDL)
- CAHPS® Hospice Survey

HQRP Compliance Reminders

- General Requirements: HQRP data collection requirements for both the Hospice Item Set (HIS) and CAHPS® Hospice Survey are defined for the Calendar Year (CY): January 1-December 31. To comply with the HQRP, each CY hospices must submit and ensure acceptance of at least 90% of all required Hospice Item Set (HIS) records by the 30-day submission deadline and participate monthly with the CAHPS® Hospice Survey by utilizing a CMS-approved third-party vendor, in accordance with HQRP requirements. Since administrative data is collected from claims, hospices with claims data are 100% compliant with the HCI and HVLDL claims-based measure submission requirements.
- Payment is impacted during the corresponding Fiscal Year (FY): October 1-September 30. Hospices are subject to a payment reduction in their annual payment update (APU) if they fail to comply with the HQRP requirements. Beginning in FY 2024 (CY 2022 data) the APU penalty will increase from 2% to 4%.

We are developing a new standardized patient assessment tool for the HQRP, to be proposed in future rulemaking. The hospice patient assessment instrument will be Hospice Outcomes & Patient Evaluation (HOPE).

Development of HOPE is ongoing. During the summer 2021, CMS began recruiting and selecting volunteers for the HOPE Beta Test, the final testing phase to confirm assessment item reliability and validity. Beta testing is expected to begin in late 2021 or early 2022. Additional information about the HOPE Beta Test is available on the HQRP Provider and Stakeholder Engagement webpage.

The development of HOPE is an important part of the Meaningful Measures initiative to improve outcomes for patients, their families, caregivers, and providers while also reducing burden on providers and clinicians. The HOPE assessment tool is important for developing a set of hospice quality measures, including outcome measures that reflect the needs of patients, their families, and caregivers throughout the hospice stay.

Section 3: Public Reporting Updates

The section below includes key public reporting dates. Providers should review the timeline to ensure they are familiar with important upcoming public reporting dates, and refer to the Public Reporting: Key Dates for Providers webpage on the HQRP website for more information.

Temporary Data Freeze – November 2020 Refresh through November 2021 Refresh

On March 27, 2020, CMS sent a MLN Guidance Memorandum which provided exemptions to public reporting in response to the COVID-19 Public Health Emergency. This Guidance Memorandum granted an exemption to the HQRP reporting requirements for Q4 2019, Q1 2020, and Q2 2020. Due to these

exemptions to the HQRP data submission requirements, CMS froze public reporting of hospices' data after the November 2020 refresh. This means that following the November 2020 refresh, **the data publicly reported is held constant (i.e., froze the data) through the November 2021 refresh.** Further, no new Provider Preview Reports will be issued for those refreshes that continue to display the constant or frozen data.

Although public reporting data was frozen during the 2021, reporting requirements remain in effect. Please visit the <u>HQRP Key Dates for Providers</u> webpage to view HIS and CAHPS-specific Data Correction Deadlines in 2021.

Public Reporting Dates with New Data Starts February 2022

CMS will resume public reporting of HQRP data with the February 2022 refresh period on Care Compare. For the February 2022 refresh, CMS finalized plans for resuming publicly reporting data, while excluding Q1 and Q2 of 2020:

- CMS will use fewer quarters than usual to report HIS measures—specifically using Q3 2020, Q4 2020, and Q1 2021 only.
- CMS will use the most recent eight quarters of data, excluding Q1 2020 and Q2 2020, for CAHPS® Hospice Survey measures.

We also will be posting a Second Edition of the Hospice Public Reporting Tip Sheet that explains public reporting starting in February 2022 with fewer than the standard quarters of data and including the two new claims-based measures. The next Provider Preview Report will be issued in December 2021, in advance of the February 2022 Hospice refresh.

New Quality Measure (QM) Manual

The *new* HQRP QM User's Manual v1.00, and updated Current Measures documents are now available. These documents reflect quality measure changes finalized in the FY 2022 Hospice Wage Index and Payment Update Final Rule, which was published on August 4, 2021. Among other changes, v1.00 of the *New* QM Manual includes two new claims-based measures finalized in the FY 2022 Hospice Final Rule: the Hospice Care Index (HCI) and Hospice Visits in the Last Days of Life (HVLDL).

Section 6: Questions and Answers

Q: When will hospice providers have access to their HCI and HVLDL data?

 As of September 15, 2021, confidential QM reports became available in the Certification and Survey Provider Enhanced Reports (CASPER) to include measure scores for the HCI and HVLDL claims-based measures. These QM Reports include hospice and national rates for HVLDL and the overall HCI score. HCI also include details about the ten individual indicators used to calculate the overall HCI score, (numerator, denominator) and the national percentile. The claims-based measures will also be included in the Provider Preview Reports three months before they are publicly reported, which is no sooner than May 2022.

Q: What time periods of data will be used to calculate the new claims-based HCI and HVLDL?

• If the claims-based measures are released in May 2022, the measure reporting period will include Quarters 2, 3, and 4 of 2019, Quarter 3 and 4 of 2020, and Quarters 1, 2, and 3 of 2021. Note that these eight quarters of claims data exclude Q1 and Q2 of 2020 data.

Q: What is the data source for the 10 indicators included in the new HCI claims-based measure?

The data source for the 10 indicators included in the new HCI claims-based measure is Medicare claims. Each individual indicator uses specific billing codes included in the claims. We encourage you to review the details in the FY 2022 Hospice Final Rule by visiting the Hospice Center. We also recommend you visit the CMS HQRP website, and monitor the Announcement and Spotlight page for notifications about the current measures on the HQRP Current Measures page and the new QM User's Manual v1.00 found in the Downloads section.

Q: Can you please clarify when a newly certified hospice agency needs to begin HIS reporting?

• Providers are required to begin reporting data on the date on the letter head of their CCN notification letter. The CCN number is your CMS Certification Number, or your facility ID. Please see FY 2016 Hospice Final Rule (80 FR 47142) for information on this topic. To establish your hospice to report for the Hospice Quality Reporting Program, we recommend you establish your account in the QIES (please see CMSNet Online Registration), review the CMS HQRP website, and specifically look at the HQRP Requirements and Best Practices webpage. You will find many useful documents for new and current providers at the bottom of the page under Provider Toolkit.

Q: How will CAHPS® Hospice Star Ratings be calculated? What data will be used to calculate the star ratings?

- As described in the FY 2022 Hospice Final Rule, Star Ratings will be calculated based on "top-box" scores for each of the eight CAHPS® Hospice Survey measures. A summary CAHPS® Hospice Survey Star will be calculated for each hospice by averaging the Star Ratings across the 8 measures. Only the summary CAHPS® Star Rating will be publicly reported.
- CMS plans to review the methodology that was finalized in the FY 2022 Hospice Final Rule this
 fall at one of the Home Health, Hospice, and Durable Medical Equipment Open Door Forums.
