The FY 2024 IRF PPS final rule (88 FR 50956)\*\* revised the IRF QRP measures required for collection beginning with the FY 2025 IRF QRP. Specifically three measures were removed, one new measure was adopted, and one measure was modified. Below is an updated table indicating the IRF QRP measures to be submitted for the current and final quarter of the FY 2025 IRF QRP determination.
