SUBJECT: Notice of Performance Year 2024 Participants for the Kidney Care Choices (KCC) Model

The Center for Medicare and Medicaid Innovation is announcing that 123 participants are participating in performance year 2024 (PY 2024) for the Kidney Care Choices (KCC) Model. Of these, 100 participants are in the Comprehensive Kidney Care Contracting (CKCC) options, which are accountable care organization (ACO)-style with different levels of financial risk and 23 participants are part of the Kidney Care First (KCF) option, which is a medical home-style option for nephrology practices.

The KCC Model is a voluntary payment model aimed to reduce the cost of care and improve both quality and care coordination for Medicare beneficiaries with late-stage chronic kidney disease (CKD) and End-Stage Renal Disease (ESRD). The goals of the model include slowing the progression of CKD, better dialysis starts, incentivizing home dialysis and promoting greater utilization of kidney transplants.

The KCC Model performance period started on January 1st, 2022, with 50 Kidney Care Entities (KCEs) in the CKCC options and 30 KCF Practices in the KCF option. A second cohort was added in the subsequent PY that started on January 1st, 2023. The second cohort doubled the number of participants in the model to 100 KCEs participating in the CKCC options and 30 KCF Practices in the KCF option. This vastly increased the number of aligning providers and beneficiaries that are part of the model.
