#### **Notice to Public of Involuntary Termination of Oakwood ICF/IID, Unit 2**

The Centers for Medicare & Medicaid Services (CMS) is providing notice that on November 22, 2017, Oakwood ICF/IID, 2441 South Highway 27, Somerset, Kentucky, will no longer participate in the Medicaid program. The Medicaid provider agreement between Oakwood ICF/IID, Unit 2 and the Secretary of Health and Human Services (HHS) terminated on November 22, 2017, due to their failure to meet Medicaid's basic health and safety requirements.

The facility has been notified that Medicaid will cease to pay for services furnished to Medicaid beneficiaries admitted after November 22, 2017, although payment may continue for up to 30 calendar days for patients admitted on or before November 22, 2017. CMS is committed to patient safety and quality of care. We are closely monitoring the relocation of Medicaid patients to other facilities.

CMS requires facilities to meet certain health and safety standards to be certified as a Medicaid provider. Involuntary termination of a provider agreement is generally a last resort after all other attempts to remedy the deficiencies at a facility have been exhausted. In this instance, Atlanta Regional Office, has found that Oakwood ICF/IID, Unit 2 is out of compliance with CMS basic health and safety requirements.

While we understand the relocation of residents and patients can be challenging for all parties involved, CMS prioritizes patient safety and care quality.
