^{**} As finalized in the FY 2027 IPPS/LTCH PPS final rule (91 FR 50019 through 50021), LTCHs are no longer required to report CY 2026 HCP COVID-19 Vaccine measure data for purposes of the FY 2028 payment determination (that is, LTCHs that do not report CY 2026 HCP COVID-19 Vaccine measure data would not be penalized for the FY 2028 annual payment update under the LTCH QRP).
