Confirm Your Eligibility

To participate in MDPP, you must meet these eligibility requirements:

- 1. Provide results from one of three prediabetic tests:
 - **Hemoglobin A1c** with a value of 5.7-6.4 (requires a physician referral to be covered by Medicare)
 - Fasting plasma glucose test with a value of 110-125 mg/dl (requires a physician referral to be covered by Medicare)
 - **Oral glucose tolerance test** with a value of 140-199 mg/dl (*requires a physician referral to be covered by Medicare*)
- 2. No history of diabetes, with the exception of gestational diabetes
- 3. No End Stage Renal Disease (ESRD)
- 4. No previous receipt of MDPP services
- 5. Have **Medicare Part B coverage** through Original Medicare (Fee-for-Service) or a Medicare Advantage (MA) plan
- 6. Have a body mass index (BMI) of at least 25, 23 if self-identified as Asian

🎎 Keep in mind...

- If you develop end-stage renal disease or lose Medicare Part B coverage while receiving MDPP services, you will not be eligible for any additional sessions
- MDPP is a once-per-lifetime service. By attending the first core session, you are initiating
 your 12-month set of services. Your MDPP services period ends on the "end date" you will fill
 out on page 3
- As an eligible beneficiary, you should not be asked to pay any out-of-pocket costs to participate in MDPP



Learn How to Succeed

12-Months of MDPP Services

The primary goal of MDPP is to lose 5% of your body weight. Your supplier will offer at least 16 sessions during the first six months, and at least six sessions during the last six months.

Attendance

There are no attendance requirements for the 12 months of MDPP, but you should attend as many sessions as you can. Research shows that participants who attend more group sessions have better outcomes.

If you miss a session, you can ask your MDPP coach for a make-up session. Make-up sessions can be either virtual or in-person.

Weight Loss

MDPP is available to all beneficiaries who meet the requirements listed on page 2.



Familiarize Yourself with the Timeline

There are a number of important dates you should know. Work with your MDPP coach to fill out the timeline below.

MDPP Core Sessions

Months 1-6 (Weekly Sessions)

- A minimum of 16 sessions offered at least a week apart during the first 6 months
- Available to eligible beneficiaries regardless of weight loss and attendance
- In-person and virtual make-up sessions are available and must meet specific requirements

Maintenance Sessions

Months 7-12 (Monthly Sessions)

- A minimum of 6 monthly sessions during the second 6 months
- Available to eligible beneficiaries regardless of weight loss and attendance
- In-person and virtual make-up sessions are available and must meet specific requirements



Disclosures

MDPP Supplier Standards and Requirements: In addition to this document, your MDPP coach should give you a copy of the MDPP Supplier Requirements Checklist. This document lists the rules your supplier must follow as part of MDPP. Look it over and let your MDPP coach know if you have questions at any time.

Medicare Advantage: Some information disclosed in this document may differ if you receive Medicare coverage via a Medicare Advantage plan. If you are a Medicare Advantage enrollee, you should contract your Medicare Advantage plan and review coverage documents provided by your health plan for more information on MDPP services.
