01	With the addition of ICD-10 codes beginning with “QA”, it is now necessary to end the ICD-10 format edit -3852 as of 09/30/2025 and create a new ICD-10 format edit, effective 10/01/2025.	<p>New edit -4097 will be created and read as follows:</p> <p>FORMATTING OF ICD-10 DIAGNOSIS CODES</p> <p>ICD-10 diagnosis codes must conform with the following formatting rules:</p> <ul style="list-style-type: none"> <li>a) Character 1 must be alphabetic [A-Z,a-z].</li> <li>b) Character 2 must be numeric [0-9] or alphabetic [A-Z,a-z].</li> <li>c) Character 3 must be numeric [0-9] or alphabetic [A-Z,a-z].</li> <li>d) Character 4 must be a decimal point.</li> <li>e) Characters 5 through 8 must be numeric [0-9], alphabetic [A-Z,a-z], or caret [^].</li> <li>f) If any character 5 through 8 is equal to [^], all subsequent characters must equal [^].</li> </ul> <p>Note that an entirely blank ICD code must be submitted as a single caret: [^].</p> <p>-----</p> <p>This new edit will be mapped to the following items:</p> <p>I0020B, I8000A-J</p>	This change will be made in the next version of the MDS 3.0 Data Submission Specs. 02	There is a typo in the allowed values for item S6305B. The item has a maximum length of 8, but the value for “Not yet received” is nine 9s (i.e., 999999999).	The allowed value for “Not yet received” in item S6305B will be changed to eight 9s (i.e., 99999999).	This change will be made in the next version of the MDS 3.0 Data Submission Specs. It will be included in the production release of IQIES scheduled for October 1, 2025.
03	With the addition of item B0100 to the NPE ISC, edit -3994, subedit a can now conflict with edit -3609 when the patient is comatose (B0100 = 1).	<p>Edit -3994 will be deleted and replaced with edit -4098, which will read as follows:</p> <p>B1300 skip patterns:</p> <p>NPE skip:</p> <p>(a) If A0310A=[99] AND A0310B=[99] AND A0310F=[99] AND B0100=[0], then if B1300 is active, it must not equal [^].</p> <p>Otherwise:</p> <p>(b) If B0100=[0] AND (A0310B=[01] OR (A0310G=[1] AND A0310H=[1])), then if B1300 is active, it must not equal [^].</p> <p>(c) If B0100=[0] AND (A0310B=[99] AND (A0310G=[2,^] OR A0310H=[0])), then if B1300 is active, it must equal [^].</p>	This change will be made in the next version of the MDS 3.0 Data Submission Specs.
