Medicare and Medicaid Notice to the Public

Notice is hereby given that on December 12, 2018 the agreement between the Secretary of Health and Human Services and Law Den Nursing Home, Detroit, Michigan as a skilled nursing facility in the Medicare program will be terminated.

In addition, as authorized by the Law Den Nursing Home, notice is given that the facility's agreement as a nursing facility in the Medicaid program will be terminated effective December 12, 2018.

The Medicare program will not make payment for skilled nursing facility services furnished to residents admitted to the facility on or after October 18, 2018. This date is due to a previously imposed denial of payment for new admissions. For residents admitted prior to October 18, 2018, payment may continue to be made for up to 30 days of services after December 12, 2018, the date of termination.

In addition, Federal Financial Participation will not be available to the State for any Medicaid residents admitted to the facility on or after October 18, 2018. For Medicaid residents admitted prior to October 18, 2018, Federal Financial Participation may continue to be made to the State for up to 30 days of covered services to qualified residents furnished on or after December 12, 2018, the date of termination.
