GENERAL COURSE DESCRIPTIONS

July 21-24, 2025 Evaluation and Management Coding Boot Camp ("Live" Virtual)

This interactive boot camp will focus on CMS and AMA guidelines for office visit codes and teaches how to select E/M levels based on time or medical decision making.

August 4-15, 2025 Certified Coder Inpatient Boot Camp ("Live" Virtual)

This interactive boot camp will focus on ICD-10-CM/PCS coding and MS-DRG assignment.

August 27, 2025 NAMPI Session - Strengthening Managed Care Integrity: Federal-State Coordination

This in-person training session will feature presentations from CMS, Center for Program Integrity (CPI) on the managed care dashboard, audit activities, and a state panel will provide comprehensive insights into current practices and strategies.

November 3, 2025** JustCoding's: Essential Skills for Anatomy and Physiology (Self-Paced Series)

This virtual self-paced coding series will be available until November 3, 2026. The 16-part series will provide an overview of important anatomical details and disease processes crucial for training coders and medical record reviewers. The courses, created by physicians, are divided by body system and include detailed illustrations for added context. By understanding medical terminology, anatomy and physiology, and disease processes, coders will be able to better understand physician documentation to aid coding and query efficiency. Each course tests participant knowledge throughout to ensure they are learning the material and includes a final exam that covers each section. This is an invitation-only opportunity and *prior MII coding course boot camp attendance is required.*

December 1-4, 2025 Evaluation and Management (E/M) Coding Boot Camp ("Live" Virtual)

This interactive boot camp will focus on CMS and AMA guidelines for office visit codes and teach how to select E/M levels based on time or medical decision making.

December 9, 2025 Turning Analysis into Action – Medicaid Risk Assessment ("Live" Virtual)

This session will provide information to state Medicaid agencies on recommended risk assessment practices aimed at evaluating Program Integrity risk within the Medicaid program. CPI will provide an overview of the Government Accountability Office risk assessment framework and how states could use it to improve or implement their own risk assessment processes. Further, the training will describe how CPI uses GAO's risk framework to mitigate federal program integrity risks. The training will include interactive breakout sessions to enhance exposure to the risk assessment process and how it can be a dynamic tool to address vulnerabilities in a changing program integrity landscape.

GENERAL COURSE DESCRIPTIONS

December 10, 2025 CPT Coding Annual 2026 Update ("Live" Virtual)

This training session will provide a high-level review of the calendar year (CY) 2026 additions, revisions, and deletions to the Current Procedural Terminology (CPT). With 288 new codes being added, there is so much to learn! Prepare yourself in advance for these changes that are effective January 1, 2026.

December 11, 2025 National Correct Coding Initiative (NCCI) Edits Update for 2026 ("Live" Virtual)

This training is focused on the National Correct Coding Initiative (NCCI) edits and equips coders with strategies to identify and resolve code pair conflicts. Participants will learn how to interpret column 1 vs. column 2 relationships, apply appropriate modifiers, and avoid unbundling errors. Real-world surgical scenarios and payer-specific guidance will be used to reinforce compliance.
