Action Needed

Make sure your staff knows about:

- Improved editing of claims that have interrupted stays that span 2 months
- Modified editing for occurrence span code (OSC) edits allowing for proper claims decisions

Background

CR 13149 improves current claims processing edits in the Fiscal Intermediary Shared System (FISS) and the Common Working File (CWF). These requirements apply to providers subject to SNF PPS billing on type of bill (TOB) 21X and swing bed TOB 18X.

The changes update hospital overlap edits when billing during an interrupted stay where the hospital stay extends to the next month. The modified claims processing follows current policy. The changes are:



- Your Medicare Administrative Contractor (MAC) won't set a CWF edit (UR 5601 or UR 5608) on initial, interim, or adjustment SNF (21X) or swing bed (18X) claims when they have any or all overlapping span dates on the historical inpatient (11X) claim's DOS and there's an OSC of 74 on the 21X claim
- Your MAC won't set a CWF edit (UR 5601 or UR 5608) on initial, interim, or adjustment claims for an inpatient claim when a SNF (21X) or Swing Bed (18X) claim has any or all overlapping span dates on the historical inpatient (11X) claim's DOS and there's an OSC of 74 on the 21X claim
- The current edit on occurrence code (OC) 50 says the entry start date must be 1 day after the OSC 76 thru date, and this will be changed to 8 days after the OSC 76 thru date
