Affected Providers

- SNFs
- Other providers billing Medicare Administrative Contractors (MACs) for services they provide to Medicare patients in a SNF stay

Action Needed

Make sure your billing staffs knows about:

- Updates to the lists of HCPCS codes that are subject to the CB provision of the SNF prospective payment system (PPS)
- Additions and deletions of certain chemotherapy, blood clotting factors, and therapies inclusion codes from the Medicare Part A SNF files

Background

CMS periodically updates the lists of HCPCS codes excluded from the CB provision of the SNF PPS. We may pay providers, other than SNFs, for services excluded from SNF PPS and CB for patients, even when in an SNF stay. Medicare won't pay for services not on the exclusion lists to any providers other than a SNF.

For non-therapy services, SNF CB applies only when you provide the services to a SNF resident during a covered Medicare Part A stay. However, SNF CB applies to physical and occupational therapies and speech-language pathology services whenever provided to an SNF resident, regardless of whether Part A covers the stay. To make sure we make proper payment

in all settings, Medicare systems must edit for services provided to SNF patients both included and excluded from SNF CB.
