- Other providers billing Medicare Administrative Contractors (MACs) for services

Action Needed

Make sure your billing staff knows about these coding updates in the following categories:

- Angiography, lymphatic, venous, and related procedures
- Chemotherapy
- Radioisotopes and their administration
- Certain blood clotting factors indicated for the treatment of hemophilia and other bleeding disorders
- Customized prosthetic devices

Background

CMS periodically updates the lists of HCPCS codes excluded from the consolidated billing (CB) provision of the SNF Prospective Payment System (PPS). We may pay non-SNF providers for services excluded from the SNF PPS and CB for patients, even during a SNF stay. We only pay SNFs for claims submitted to MACs or DME MACs for non-excluded services.

Non-Therapy Services

SNF CB only applies when a SNF resident receives services during a covered Medicare Part A stay. However, SNF CB applies to physical and occupational therapies and speech-language pathology services whenever they're provided to a SNF resident, regardless of whether Part A covers the stay. To ensure proper payment, our systems must edit for services both included and excluded from SNF CB when provided to SNF patients in all settings.

Updated lists for institutional and professional billing are available.

Key Updates

CR 14049 updates the lists of HCPCS codes subject to the CB provision of the SNF PPS. Changes to CPT and HCPCS codes and Physician Fee Schedule designations will be used to revise Common Working File edits, allowing MACs to make appropriate payments per SNF CB policy found in the Medicare Claims Processing Manual, Chapter 6, section 20.6.
