#### **Affected Providers**

- Hospitals
- Physicians
- Other providers billing Medicare Administrative Contractors (MACs) for chimeric antigen receptor (CAR) T-cell therapy services

#### **Action Needed**

As of June 26, 2025, we no longer require:

- Providers to administer CAR T-cell therapy in an FDA Risk Evaluation Mitigation Strategy (REMS)-approved facility
- The KX modifier on Medicare Part B claims for CAR T-cell therapy

### **Background**

On August 7, 2019, CMS started covering CAR T-cell therapy through <u>National Coverage</u> <u>Determination 110.24</u>. Among other criteria, we required you to administer CAR T-cell therapy at a health care facility enrolled in the FDA REMS. For many years, REMS was part of the FDA-approved indications for these therapies. We also required the use of the KX modifier on claims to acknowledge that you performed the service in an FDA REMS-participating facility.

On June 26, 2025, FDA <u>announced</u> the elimination of REMS and updated product labeling for CAR T-cell therapies.

### **Key Updates**

For claims with dates of service on or after June 26, 2025, we no longer require you to perform CAR T-cell therapy services in an FDA REMS-approved facility, and you don't need to include the KX modifier on Part B claims. We updated the <u>Medicare Claims Processing Manual, Chapter 32</u>, section 400 with these changes.

**Note:** Your MAC won't search their files for CAR T-cell claims; however, they'll adjust any claims that you bring to their attention.
