Note: Your MAC won't search for claims but may adjust claims you bring to their attention.

CR 14394 updates the coverage and billing requirements for NCD 230.18 in the [Medicare Claims Processing Manual, Chapter 32](#), sections 40.1 and 40.2.1.

Background

CR 14263 provides a maintenance update of ICD-10 conversions and other NCD-specific coding updates. These NCD coding changes result from newly available codes, separately released NCD coding revisions, or coding feedback received by CMS.
