CMS strives to make the NCD process open, transparent, and accessible to medical innovators and other stakeholders. CMS prioritizes NCD requests based on the magnitude of the potential impact on Medicare program and beneficiaries. CMS has leveraged operational efficiencies to streamline and standardize the evidence review process.

Open NCDs are currently undergoing a National Coverage Analysis (NCA) with opportunities for public comment on the coverage policy.

Finalized NCDs have completed the coverage analysis process and represent current Medicare coverage policy.

Under the Transitional Coverage for Emerging Technologies (**TCET Pathway**) CMS does not share the identity of specific manufacturers or devices prior to the opening of an NCD. To provide transparency, we publish the number of devices accepted into the TCET pathway and the dates when the nominations were received and accepted.

Accepted NCD requests on the **Wait List** are complete based on the [NCD Request Process](#). Given the volume of requests and our current level of resources, there are times when CMS must tell requestors that an NCD request is accepted, but we cannot immediately begin the NCD process.
