CMS strives to make the NCD process open, transparent, and accessible to medical innovators and other stakeholders. CMS prioritizes NCD requests based on the magnitude of the potential impact on Medicare program and beneficiaries. CMS has leveraged operational efficiencies to streamline and standardize the evidence review process whenever possible and we have augmented our available resources with contractor support to complete the NCD process whenever possible. However, given the ever-increasing volume of requests and our current level of resources, there are times when CMS must tell requestors that an NCD request is complete and formal, but cannot immediately begin the NCD process.

These are alphabetized lists of NCD requests accepted by CMS, open NCDs, and finalized NCDs. Accepted NCD requests on the Wait List are complete and formal based off CMS' review consistent with the [NCD Request Process](#). Opened NCDs are topics currently undergoing a National Coverage Analysis (NCA) with opportunities for public comment on the coverage policy. Finalized NCDs have completed the coverage analysis process and represent current Medicare coverage policy.
