### MGCRB 2021.05: Extension for MGCRB Applications for Louisiana & Mississippi (September 3, 2021)

Secretary Becerra used his authority in the Public Health Service Act to declare a <u>public health</u> <u>emergency (PDF)</u> (PHE) on August 30, 2021, giving CMS the flexibility to support beneficiaries in Louisiana, effective August 26, 2021 and Mississippi, effective August 28, 2021. Accordingly, CMS has granted Additional IPPS Hospital Blanket Waivers for 2021 Hurricane Ida as noted below.

### Extension for Medicare Geographic Classification Review Board (MGCRB) Applications:

CMS is modifying the September 1, 2021 deadline for applications for FY 2023 reclassifications to be submitted to the MGCRB. CMS has granted an extension to the deadline at § 412.256(a)(2) for the States of Mississippi and Louisiana. Applications for FY 2023 reclassifications from hospitals in these areas must be received by the MGCRB not later than October 4, 2021

### Extension for Inpatient Prospective Payment System (IPPS) Wage Index Revisions:

Regarding the FY 2023 wage index, CMS is modifying the September 2, 2021 deadline specified in the FY 2023 Hospital Wage Index Development Time Table for these hospitals to request revisions to and provide documentation for their FY 2019 Worksheet S-3 wage data and CY 2019 occupational mix data as included in the May 23, 2021 preliminary Public Use Files (PUFs), respectively. CMS has granted an extension for hospitals in the States of Louisiana and Mississippi until October 4, 2021. MACs must receive the revision requests and supporting documentation by this date. If hospitals encounter difficulty meeting this extended deadline of October 4, 2021, hospitals should communicate their concerns to CMS via their MAC, and CMS may consider an additional extension if CMS determines it is warranted.

## Postponement of Application Deadline to the Medicare Geographic Classification Review Board (August 21, 2020)

Per requirements at section 1886(d)(10)(C)(ii) of the Social Security Act (the Act) and 42 CFR 412.256(a)(2), September 1, 2020 is the deadline to submit an application to the Medicare Geographic Classification Review Board (MGCRB) for FY 2022 reclassifications. These provisions require applications to be filed through OH CDMS (<a href="https://www.cms.gov/Regulations-and-Guidance/Review-Boards/MGCRB/Electronic-Filing">https://www.cms.gov/Regulations-and-Guidance/Review-Boards/MGCRB/Electronic-Filing</a>) not later than the first day of the 13-month period preceding the Federal fiscal year for which reclassification is requested. Due to the COVID-19

Public Health Emergency (PHE), under the authority of section 1135(b)(5) of the Act, CMS is postponing the September 1 deadline until 15 days after the public display date of the FY 2021 IPPS/LTCH final rule by the Office of the Federal Register.

### MGCRB 2020.03: Three Year MGCRB Reclassification Data Available (August 6, 2020)

CMS posted the Three Year MGCRB Reclassification Data for FY 2022 applications. CMS ordinarily provides a 60-day delay in the effective date of final rules after the date they are issued (with the IPPS final rule issued on or around August 1 and effective October 1). Due to CMS prioritizing efforts in support of containing and combating the COVID–19, in the IPPS proposed rule CMS waived the 60-day delay in the effective date of the final rule, and replaced it with a 30-day delay in the effective date of the final rule. Usually, CMS provides the Three Year Medicare Geographic Classification Review Board (MGCRB) Reclassification Data for the FY 2022 MGCRB Applications for MGCRB reclassification concurrent with the IPPS final rule. However, in order to provide hospitals sufficient time before the September 1, 2020 deadline for the FY 2022 MGCRB Applications, CMS is providing this data prior to issuance of the final rule.

### MGCRB 2020.01: Anti-Virus Scanning (January 7, 2020)

There has been an increase in uploaded documents identified as potentially "infected" by the OH CDMS anti-virus scanning tool. A file can be falsely identified as infected for various reasons, including:

- Links Any links to files on your computer, another computer, or to a source outside of OH CDMS must be removed. The information from the link may be saved and uploaded as a separate document.
- **Embedded files** An embedded file is any file inserted into your document. Any embedded files must be removed prior to uploading your documents. The removed files may be saved and uploaded separately.
- Macros A macro is a set of instructions that expands to perform a task and could be pointing to an unverifiable source. Files may not be saved as Word or Excel Macro-Enabled Documents.
