Executive Summary

The Open Payments program is a statutorily-required, national disclosure program that promotes transparency and accountability by making information about the financial relationships between reporting entities¹ and covered recipients² available to the public.

The Open Payments data includes payments and other transfers of value made to covered recipients, along with ownership and investment interests held by physicians or their immediate family members in the reporting entities.

Payments are reported across three major reporting categories:

- <u>General Payments</u>: Payments or other transfers of value made that are not in connection with a research agreement or research protocol.
- Research Payments: Payments or other transfers of value made in connection with a formal research agreement or research protocol.
- <u>Physician Ownership Information</u>: Information about the ownership or investment interests that physicians or their immediate family members have in the reporting entities.

On June 28, 2019, the Centers for Medicare & Medicaid Services (CMS) published Program Year 2018 data, completing the fifth full year of data reported to Open Payments. In addition to the publication of Program Year 2018 data, all previous program years were refreshed and republished³ to reflect any updates made by reporting entities during the 2018 program year cycle.

In Program Year 2018, applicable manufacturers and group purchasing organizations (GPOs) collectively reported \$9.35 billion in payments and ownership and investment interests. These payments are comprised of 11.40 million payment records attributable to 627,392 physicians and 1,180 teaching hospitals. Over the course of the Open Payments program, CMS has published 64.77 million records, accounting for \$43.22 billion in payments and ownership and investment interests.

To encourage timely, complete, and accurate reporting, CMS has the authority to impose civil monetary penalties on entities that are not compliant with the Open Payments requirements. CMS did not impose any civil monetary penalties in Program Year 2018.

¹ Reporting entities refers to applicable manufacturers and group purchasing organizations (GPOs) required to report payments or transfers of value to covered recipients under the Physician Payment Sunshine Act (42 USC §1320a-7h).

² Covered recipients are any physicians (excluding medical residents) who are not employees of the applicable manufacturer that is reporting the payment; or teaching hospitals that receive payment for Medicare direct graduate medical education (GME), inpatient prospective payment system (IPPS) indirect medical education (IME), or psychiatric hospital IME programs during the last calendar year for which such information is available.

³ Refreshed and republished data includes data corrections made to reported payments since the initial publication of data that were submitted by applicable manufacturers and GPOs.

The Secretary of the Department of Health and Human Services (HHS) is required to submit an annual Report to Congress summarizing the information reported to the Open Payments program, aggregated by reporting entities, as well as any penalties imposed by HHS that are directly related to the Open Payments program.

This report summarizes the financial transaction information and provides an overview of key program activities and achievements that occurred in Fiscal Year 2019 (October 1, 2018 – September 30, 2019), with a focus on the most recent Open Payments data publication of Program Year 2018 data.

Open Payments Program Overview and Implementation

The Open Payments program is a statutorily-required, national disclosure program that promotes transparency and accountability by making information about the financial relationships between reporting entities and covered recipients available to the public.

Reporting entities report payments or transfers of value made to covered recipients, and ownership and investment interests held by physicians or their immediate family members in the reporting entities. Payments are reported across three main categories: general payments, research payments, and ownership and investment interests.

- General Payments: Payments or other transfers of value made that are not in connection with a research agreement or research protocol. General payments may include, but are not limited to, honoraria, gifts, meals, consulting fees, and travel compensation.
- Research Payments: Payments or other transfers of value made in connection with a formal research agreement or research protocol.
- Physician Ownership Information: Information about the ownership or investment interests that physicians or their immediate family members have in the reporting entities.

Detailed guidance on reported payment categories is available in the Open Payments Final Rule (CMS, Transparency Reports and Reporting of Physician Ownership or Investment Interests, 78 FR 9458, at 9477 (Feb. 8, 2013)) and in regulations at 42 CFR § 403.904.

Since the inception of the Open Payments program, reporting entities have cumulatively reported \$43.22 billion⁴ in payments and ownership and investment interests.

⁴ All (cumulative) Open Payments data are calculated by totaling all program years' general payment and research payment values with the current program year's ownership and investment interest values. (Ownership and investment values represent current market value of ownership as of the last feasible valuation across applicable manufacturers and GPOs.)




Figure 1. Total Reported Value of Each Program Year⁵

The Secretary of the Department of Health and Human Services (HHS) is required to submit an annual Report to Congress summarizing the information reported to the Open Payments program, aggregated by reporting entities, as well as any penalties imposed by HHS that are directly related to the Open Payments program.

This report summarizes the financial transaction information and provides an overview of key program activities and achievements that occurred in Fiscal Year 2019, with a focus on the most recent Open Payments data publication of Program Year 2018 data.

Program Year 2018

The Open Payments program functions on a yearly cycle consisting of four key activities: (1) Data Collection; (2) Data Submission; (3) Pre-publication Review, Dispute and Correction; and (4) Data Publication. The following is an overview of the Program Year 2018 timeline, projects, and achievements.

 Data Collection: Reporting entities collect data pertaining to payments made to covered recipients from January 1 through December 31 of each year, along with any ownership or investment interests held by physicians or their immediate family members in the reporting entity during that time. Data collection for Program Year 2018 took place from January 1, 2018 to December 31, 2018. On January 1, 2019 reporting entities entered a new program cycle and began collecting data for Program Year 2019 which will be published in June 2020.

⁵ Individual program years' Open Payments data are calculated by totaling the individual program year's general payment, research payment, and ownership and investment interest values. (Ownership and investment values represent current market value of ownership as of the last feasible valuation across applicable manufacturers and GPOs.)

- 2. **Data Submission:** Reporting entities submit the data that they have collected during each program year to CMS. The Program Year 2018 data submission period was February 1, 2019 through March 31, 2019.
- 3. **Pre-publication Review, Dispute, and Correction of Data:** Prior to data publication, covered recipients are provided an opportunity to review the payments and other transfers of value that have been attributed to them. If they believe a record is inaccurate or incomplete, they may initiate a dispute and work directly with the reporting entity to reach a resolution. Covered recipient review of the data is voluntary, however CMS encourages data review in an effort to ensure data accuracy. The review and dispute period for Program Year 2018 data began on April 1, 2019 and was available through May 15, 2019.

Reporting entities have an additional 15-day correction period to ensure they are able to accurately respond to inquiries or disputes initiated during the covered recipient prepublication review and dispute period, and make any necessary updates prior to the annual data publication. This additional 15-day correction period continued through May 30, 2019.

The pre-publication review, dispute, and correction period provides an opportunity for data to be reviewed and if necessary changed prior to its initial publication. Covered recipients may review the data through the end of the calendar year in which data is initially published and, if necessary, dispute payments they believe to be inaccurately reported. Updates to records that occur outside of the pre-publication review and dispute period are reflected in subsequent data refreshes or data publications.

4. <u>Data Publication:</u> CMS is required by statue to publish the data annually on or by June 30th. The data is displayed on the CMS public website at https://openpaymentsdata.cms.gov On Friday, June 28, 2019 CMS published Program Year 2018 data along with the refreshed data⁶ from previous program years (2013 – 2017).

In Program Year 2018, reporting entities collectively reported \$9.35 billion in publishable payments and ownership and investment interests made to covered recipients. This amount is comprised of 11.40 million total records attributable to 627,392 physicians and 1,180 teaching hospitals.

Payments in the three major reporting categories were:

- \$3.00 billion in general payments
- \$4.93 billion in research payments
- \$1.42 billion of ownership or investment interests held by physicians or their immediate family members.

Over the course of the Open Payments program, CMS has published 64.77 million records, accounting for \$43.22 billion in payments and ownership and investment interests.

Engagement and Outreach Efforts

CMS actively engages with program participants in a variety of ways, including electronic listserv distributions, webinars, monthly stakeholder calls, working groups, and mail campaigns. During Fiscal Year 2019, the Open Payments team utilized these forms of communication to strategically promote the program and educate stakeholders.

- CMS hosted webinars for reporting entities and attended multiple reporting entity
 focused conferences and working groups. The events provided an opportunity for the
 Open Payments team to present timely program information and responded to
 questions that attendees had regarding an array of topics including, but not limited to,
 reporting requirements, data submission, and review, dispute and correction actions.
- CMS strengthened the relationship with covered recipients in a variety of ways such as
 increased listserv distributions, discussion forums, a National Provider Call, participation
 on monthly Physician Open Door Forum calls, a provider focused Special Open Door
 Forum, a physician-centric mail campaign, and personal phone calls. Through these
 communications CMS educated covered recipients about Open Payments and supplied
 the necessary resources to ensure efficient and effective participation in the program.
- Throughout the course of Fiscal Year 2019, the Open Payments team maintained regular communication with stakeholders via Open Payments email distributions. These emails were distributed via the CMS Open Payments self-subscribe listserv and to Open Payments system users consisting of reporting entities and covered recipients.
 Emails provided program timeline reminders and deadlines, as well as general operational updates. In Fiscal Year 2019, 44 emails were distributed.

 The Open Payments Help Desk supports the program by responding to program related questions and providing technical assistance. The Help Desk consistently receives positive feedback from those who have utilized it. Table 3 outlines the volume the Help Desk experienced throughout Fiscal Year 2019.

• In the summer of 2019, the Help Desk completed a pilot outreach project targeting physicians who attempted to register within the Open Payments system, but failed the vetting process. The Help Desk attempted to contact 827 physicians who met this registration criteria. This outreach was very successful with 268 physicians successfully completing their registration process. The Help Desk is planning to complete ongoing outreach of this nature during the Program Year 2019 review and dispute period in an effort to reach physicians in 'real time' and assist with successful vetting and registration.

CMS is dedicated to making the program accessible to all program participants. While it is often noted that physicians view the registration process challenging there are various outreach endeavors to physicians to help ease this process. The Help Desk outreach proved to assist physicians and received positive feedback from those that were successfully contacted.

CMS recognizes the importance of communication with program participants and stakeholders, and works diligently to maintain communication with all parties involved in the Open Payments program. These efforts strengthen CMS's relationship with program participants and positively impact the Open Payments program.

Compliance Initiatives

In Fiscal Year 2019, Open Payments continued compliance efforts focused on improving the timeliness, accuracy, and completeness of the reported data. These outreaches mirrored successful efforts from prior program years and additional, new projects originated from novel data analyses. The compliance team conducted fifteen compliance-centric outreaches to approximately 1,000 applicable manufacturers and applicable GPOs. In addition, CMS conducted outreach to over 35,000 physicians to increase physicians' awareness of the reporting requirements pertaining to physician-owned distributorships (PODs).

These compliance outreach efforts encouraged timely submission of reportable data and resulted in the inclusion of previously unreported data and the correction of errors in the reported data. Approximately 2.97 million records with the associated value of about \$679 million were updated as a result of the Fiscal Year 2019 outreaches.

CMS has the authority to impose civil monetary penalties for late, inaccurate, and incomplete reporting. CMS did not impose any civil monetary penalties during Fiscal Year 2019.

Open Payments Enhancements

In Fiscal Year 2019, various enhancements were implemented to increase usability of the Open Payments system and the public facing Open Payments website.

Open Payments System Enhancements

Open Payments system enhancements are designed to ensure users' experience in the Open Payments system is simple and seamless.

CMS continuously analyzes direct user feedback to make system enhancements based on user needs. With the consideration of user feedback and internal observations, the Open Payments system was updated with numerous enhancements in Fiscal Year 2019. The results of the enhancements were additional user friendly features impacting various program activities from data submission to general communication.

Some highlights of the Fiscal Year 2019 system enhancements include updated matching processes, streamlined data submission and review and dispute processes, as well as additional system performance, navigation, and usability enhancements. These updates were received favorably from the user community.

Open Payments Search Tool Enhancements

The Open Payments search tool is a crucial component of the program as it is the vehicle that provides the public access to the Open Payments data. CMS continues to maintain the search tool and make updates to it for optimal user experience and accessibility. The following are the notable enhancements to the search tool throughout Fiscal Year 2019.

- Query Builder Tool —The new Query Builder tool allows users to build their own queries
 to search the vast Open Payments data. Users are able to enter criteria into a simple
 form which produces the payments records in both summary and detailed views with
 links to download the files for offline use. Like the main Open Payments site the Query
 Builder Tool is mobile responsive making it available for use on a variety of devices
 including smartphones and tablets. See Figure 3.
- Homepage Autocomplete Search Update An auto-complete function was added to
 the homepage search to enable faster and more successful searches. When a user
 begins typing a search the closest results appear with each key stroke to include the
 name, specialty and address. If the user selects one of the pre-populated results they
 will be taken directly to the specific profile page of the entity, physician or teaching
 hospital that they selected. This enhancement allows users to get to their search
 destination more quickly.





Figure 4. All Years Data View

- All Years Data View An "All Years" view of the data was added to entity profiles and
 across several applications for users to see a sum of data for all available years instead
 of only viewing data for a single year at a time. See Figure 4.
- Search Tool Survey A simple question survey was added to the search tool site during
 designated periods of time. The purpose of this was to gain a better understanding of
 who is accessing the site, what users are looking for, and the overall user experience
 and satisfaction. The survey was available three different times throughout Fiscal Year
 2019. According to the survey results, while there are multiple reasons users are on the
 site, they are able to find what they are looking for and are pleased with their site
 experience.

Open Payments Program Expansion

SUPPORT Act and Additional Proposed Changes

In the fall of 2018, President Trump signed the Substance Use-Disorder Prevention that Promotes Opioid Recovery and Treatment for Patients and Communities Act (SUPPORT Act) into law. The SUPPORT Act expands the Open Payments definition of a covered recipient to include: physician assistants, nurse practitioners, clinical nurse specialists, certified registered nurse anesthetists, and certified nurse midwives. The SUPPORT Act also phases out the exclusion of making National Provider Identifiers (NPIs) publically available; therefore, the Open Payments program will be allowed to include NPIs in the publically published data.

The provision in the SUPPORT Act that expands the definition of an Open Payments covered recipient was proposed for implementation in the Calendar Year (CY) 2020 Physician Fee Schedule proposed rule. In addition to this change required by the SUPPORT Act, CMS proposed three additional changes, which were also included in the CY 2020 Physician Fee Schedule proposed rule.

The additional proposed changes are:

- Updates to the Nature of Payment categories
 - o The addition of three new nature of payment categories:
 - Debt forgiveness
 - Long term medical supply or device loan
 - Acquisitions
 - Consolidating the medical education program nature of payment categories into one single payment category
- Standardizing data on reported products
 - Additional reporting requirements for the 'device identifier' component of the unique device identifier for devices and medical supplies

Implementation of the Proposed Changes

The expanded definition of a covered recipient implemented in the SUPPORT Act applies to information required to be submitted on or after January 1, 2022. CMS proposed that this change, as well as the other proposals, and the publication of NPIs be effective for data collected beginning in calendar year 2021 as this is the data that will be reported to CMS in 2022.

The CY 2020 Physician Fee Schedule proposed rule was published in the Federal Register on August 14, 2019¹¹. CMS solicited feedback via public comment on the proposed rule with comments due September 27, 2019. The final rule will be published in the fall of the 2019 calendar year (Fiscal Year 2020).

Appendix A. Aggregate Data by Applicable Manufacturer/Group Purchasing Organization

The aggregated data included in this report contains data from Program Year 2018 on the public display site. This data set has undergone review and dispute for 45-days as per the final rule. As a result, CMS has confidence in the accuracy of the data provided in this Report to Congress. Any data that was found to have inconsistencies regarding the covered recipient of the payment or other transfer of value were rejected at the time of data submission and returned to the industry for correction and resubmission.
