## Welcome

### Annual Payment Update Reminders

#### FY 2027 Hospice Quality Reporting Reminder

For hospices to meet the Hospice Quality Reporting Program (HQRP) requirements, both the Hospice Item Set (HIS) (01/01/2025-09/30/2025) Hospice Outcomes and/or Patient Evaluation (HOPE) (10/01/2025-12/31/2025) and the Consumer Assessment of Healthcare Providers and Systems (CAHPS®) Hospice Survey must be submitted on time each year. Data collection for Calendar Year (CY) 2025 began on January 1, 2025, and impacts the Annual Payment Update (APU) for the Fiscal Year (FY) 2027. Beginning in FY 2024, hospices that fail to meet HQRP requirements are subject to a 4% reduction in their payments.

- **Hospice Assessment:** The reporting threshold for HIS is set at 90%. This means that 90% of all HIS and/or HOPE assessments must be submitted to, and accepted by, the Centers for Medicare & Medicaid Services (CMS) within 30 days of the patient's admission or discharge date. For HIS assessments, the reporting period is based on the submission of HIS admission or discharge assessments between January 1, 2025, and September 30, 2025. In contrast, HOPE admission, discharge, and/or HOPE Update Visit (HUV) assessments began reporting in October 1, 2025.
- **Consumer Assessment of Healthcare Providers and Systems (CAHPS®):** All Medicare-certified hospices that are required to conduct the CAHPS® Hospice Survey must contract with an approved CAHPS® Hospice Survey vendor and conduct the survey over a 12-month period during each calendar year. The data collection quarters for CAHPS® are based on patient deaths occurring between January 1, 2025, to December 31, 2025, inclusively.
- **Claims:** Administrative data collected from claims and hospices are automatically considered 100% compliant upon successful submission of this data.

#### **Provider-initiated requests for exemption or extension for extraordinary circumstances:**

If a hospice experiences an extraordinary circumstance, it can initiate a request for an extension or exemption. *Requests must be initiated within 90 days of the extraordinary circumstances event* and must be sent to CMS via email following the instructions provided on the [Extension and Exemption Requests](#) webpage.

## **CAHPS® Hospice Survey**

The CAHPS® Hospice Survey continues to collect data. The data submission deadlines for the CAHPS® Data Warehouse are on the second Wednesday of the month in February, May, August, and November. Vendors must receive patient/caregiver lists on time to meet the requirements for the HQRP.

## **HOPE**

### **HOPE Resources**

CMS is excited to announce that the HOPE assessment submission and reporting functionality was launched within the Internet Quality Improvement and Evaluation System (iQIES) on October 1, 2025.

All Medicare-certified hospice providers should note significant changes to the HQRP effective from October 1, 2025:

- The HOPE tool replaced the current HIS as of October 1, 2025. HOPE includes a combination of existing HIS items, revised items, and new items.
- HOPE records must be submitted to CMS via iQIES instead of QIES.
- Hospice providers will be required to submit up to two HOPE Update Visits (HUVs), each at specified timeframes, depending on the length of the hospice stay.

Note that: HIS records submitted before October 1, 2025, will be available for modifications and in-activations within the QIES system through February 15, 2026.

### **Fiscal Year (FY) 2026 Hospice Wage Index and Payment Rate Update, Hospice Conditions of Participation Updates, Hospice Quality Reporting Program Requirements, and Hospice Certifying Physician Provider Enrollment Requirements Final Rule (CMS-1835-F)**

On July 31, 2025, CMS issued a final rule (CMS-1835-P) that provides updates to the fiscal year (FY) 2026 HQRP. This rule corrects a technical error in the regulations text at § 418.312(j). This rule also reinforces updates on the HQRP and the HOPE instrument and public reporting, future quality measures (QMs), and the transition of hospice providers from the Quality Improvement and Evaluation System (QIES) to the Internet Quality Improvement and Evaluation System (iQIES).

## **Introducing the HOPE Tool Web-Based Training**

## **Data Submission and Provider Reports Web-Based Training**

## **iQIES**

The Quality Improvement and Evaluation System (QIES) has been upgraded to make the system more reliable, scalable, secure, and accessible. The enhanced system, referred to as the Internet Quality Improvement and Evaluation System (iQIES), aims to reduce the provider's burden and enhance the CMS' ability to serve our customers. CMS is excited to announce that the HOPE assessment submission and reporting functionality was launched within iQIES on October 1, 2025.

iQIES will require a new user management system because the virtual private network (VPN) and CMSNet are not needed to access the iQIES system. All users will have to create an account and establish credentials in the HCQIS Access Roles and Profile system (HARP), which is a secure identity management portal provided by CMS.

## **Provider Security Official Recruitment**

Through HARP, the level of access for iQIES will be similar to the roles that exist in QIES but with the addition of a Provider Security Official (PSO). The individual designated as the PSO must work for the provider and will be responsible for approving or rejecting iQIES user access requests for their respective organizations, including vendors.

At a minimum, at least one PSO needs to be selected, but CMS highly recommends that at least two PSOs be designated so that there is a higher likelihood that there will be someone available to approve/reject iQIES access requests. A user will not be granted access unless a PSO approves

the request. If possible, please utilize your work email address (associated with your provider) when requesting roles in iQIES to limit delays with the approval process.

*For your organization to receive access to iQIES, your organization must have completed the steps below prior to September 10, 2025:*

1. Identify at least one individual who will be the Provider Security Official (PSO), though CMS recommends at least two.
2. Register the PSO for iQIES login credentials within the Healthcare Quality Information System (HCQIS) Access Roles and Profile (HARP) system at: <https://harp.cms.gov/register>. Note: CMS recommends utilizing the work email address associated with your provider to expedite the approval process.
3. After Identity proofing and your MFA (Multi-Factor Authentication) is complete, you can access iQIES at the following URL: <https://iqies.cms.gov/> using your HARP ID and password (completed in step 2 above) to initiate your Provider Security Official role request for YOUR specific provider CCN.
4. Once the PSO role request has been submitted AND approved, you will receive notification via email. At this point you will be one of the designated PSOs for your CCN and have the authority to approve/deny subsequent requests for access of various role types to your provider's CCN.

To comply with federal security mandates, CMS is initiating new security requirements for access control to CMS Quality Systems through Remote Identity Proofing (RIDP) via the Healthcare Quality Information System (HCQIS) Access, Roles, and Profile Management system. Users will create accounts in HCQIS Access Roles and Profile Management (HARP) to gain access to the iQIES system.

### **How to Update Hospice Demographic Data**

  - Hospice providers should regularly review their reports to verify the accuracy of demographic data. The **Provider Preview Reports** reflect the quality measure data and hospice demographic information that will be posted to [Care Compare](#) in the next quarter.
  - If any demographic information is incorrect, the hospice provider must complete the CMS-855A form in PECOS with the updated demographic information. After completing the form, the provider should contact their Medicare Administrative Contractor (MAC) and request that the completed form be forwarded to the appropriate State Agency along with a request to update the demographic data in the Internet Quality Improvement Evaluation System (iQIES). All PAC providers are responsible for ensuring their latest demographic data is updated and available in both the iQIES (Hospices) and PECOS systems.



**Note:** Demographic data does not occur in real time and may take up to 6 months to reflect on Care Compare.

### **HQRP Quarterly Q&A**
