Annual Payment Update Reminder

We are reaching out to remind you of the upcoming reconsideration period for the Fiscal Year (FY) 2021 HQRP. If your hospice is non-compliant with the HQRP, you will be notified in two ways. You will receive a notification from your Medicare Administrative Contractor (MAC) and a notification in your facility's Certification and Survey Provider Enhanced Reports (CASPER) folder. Either notification is an official notice. We anticipate that letters notifying hospices of non-compliance will be distributed in early- to mid-July 2020. The letter will include instructions for submitting a reconsideration.

If you receive a letter of non-compliance, you will have 30 days to file a reconsideration request. The start and end of the reconsideration period will be shared on the HQRP Spotlight & Announcements web page.

Note: If you submit a reconsideration, please be advised CMS will not review any reconsideration requests that contain protected health information (PHI).

Hospices that are compliant for APU will not receive any notification. Please note that this outreach message is not an official notification of APU compliance. We encourage all Hospices to check for a notification from your MAC and within your CASPER folder regularly in July.

HQRP Requirements:

- HQRP data collection requirements for both the Hospice Item Set (HIS) and CAHPS® Hospice Survey
 are defined for the Calendar Year (CY): January 1-December 31. To comply with the HQRP, hospices
 must submit and ensure acceptance of their HIS and CAHPS® Hospice Survey data, in accordance
 with HQRP requirements, each CY.
- Payment is impacted during the corresponding Fiscal Year (FY): October 1-September 30. Hospices are subject to a 2% reduction in their annual payment update (APU) if they fail to comply with the HQRP requirements. Hospices must be compliant with both HIS and CAHPS® in the CY to receive the full APU for the corresponding FY.

Table 1. Compliance Criteria for the HQRP

| Reporting Requirement | Sample for FY 2021 APU Determinations | Compliance Criteria |
|--------------------------|---|--|
| HIS | HIS records with a target date CY Data 1/1/19 – 12/31/19 | At least 90% of all HIS records must be submitted and accepted by QIES ASAP within 30 days of the target date. |
| CAHPS® | Patient decedents CY Data 1/1/19 – 12/31/19 | Vendor submits data quarterly – each submission must be complete (have 3 months' worth of data) and must be submitted and accepted by the quarterly deadlines (second Wednesday of February, May, August, and November). |

HOPE Tool Update

CMS is developing a new patient assessment tool to be proposed in future rulemaking. As finalized in the <u>Fiscal Year 2020 Hospice Wage Index and Payment Rate Update and Hospice Quality Reporting Requirements Final Rule</u>, the hospice patient assessment instrument is identified as the Hospice Outcomes & Patient Evaluation (HOPE).
