CORRECTIONS

Section X Update

On page 37 of the Agenda packet, a typographical error was noted in the title.

QUESTIONS & ANSWERS

Below we provide the CMS responses to questions or comments submitted for the procedure code topics using the “Q&A” feature during the September 14, 2021 virtual ICD-10 Coordination and Maintenance Committee Meeting.

Question:

It seems as though the second topic in the agenda, Administration of broad consortium microbiota-based live biotherapeutic suspension, hasn't been reviewed. Will it be presented next?

CMS Response:

The Administration of broad consortium microbiota-based live biotherapeutic suspension topic is a new technology add-on payment (NTAP) related ICD-10-PCS procedure code request that involves the administration of a therapeutic agent and was not presented during the virtual meeting.

procedure code requests that involve the administration of a therapeutic agent. As was done for NTAP related ICD-10-PCS procedure code requests that involved the administration of a therapeutic agent for the March 9, 2021 C&M meeting, CMS displayed the meeting materials for this topic in advance of the September 14, 2021 meeting. We solicited public comments regarding any clinical questions or coding options included for this procedure code topic in advance of the meeting, and continue to solicit comment through the end of the public comment period.

The deadline to submit comments for topics being considered for April 1, 2022 implementation is October 15, 2021 and the deadline to submit comments for topics being considered for an October 1, 2022 implementation is November 15, 2021.

OTL-103, an investigational ex vivo autologous hematopoietic stem cell gene therapy, currently being investigated for the treatment of Wiskott Aldrich Syndrome (WAS) and OTL-200, an investigational ex vivo autologous hematopoietic stem cell gene therapy, currently being investigated for the treatment of metachromatic leukodystrophy (MLD) were presented at the March 9, 2021 ICD-10 Coordination and Maintenance Committee Meeting. CMS Response:

Yes, the ICD-10-PCS code proposals presented on September 14, 2021 being considered for implementation on April 1, 2022 are noted in the Agenda packet. All other ICD-10-PCS code proposals presented on September 14, 2021 are being considered for implementation on October 1, 2022.

As a reminder, October 15, 2021 is the deadline for receipt of public comments on proposed new procedure codes and revisions discussed at the September 14, 2021 ICD-10 Coordination and Maintenance Committee meeting being considered for implementation on April 1, 2022.

November 15, 2021 is the deadline for receipt of public comments on proposed new procedure codes and revisions discussed at the September 14, 2021 ICD-10 Coordination and Maintenance Committee meeting being considered for implementation on October 1, 2022.
