SUBJECT: Deadline for Submitting Risk Adjustment Data for Use in Risk Score Calculation

Runs for Payment Years 2021, 2022, 2023, and 2024

This memo is to notify Medicare Advantage Organizations, PACE Organizations, Medicare-Medicaid Plans, Section 1833 Cost Contractors and Section 1876 Cost Contractors, and any demonstration plans that submit risk adjustment data of upcoming deadlines to submit risk adjustment data for use in calculating riskscores for Payment Years (PY) 2021, 2022, 2023, and 2024. All risk adjustment data (Risk Adjustment Processing System (RAPS) Data and Encounter Data System (EDS) Data) that will be included in the listed risk score runs need to be submitted by 8pm ET of the "Deadline for Submission."

As mentioned in the January 15, 2021 HPMS memo, Deadline for Submitting Risk Adjustment Data for Use in Risk Score Calculation Runs for Payment Years 2020, 2021, 2022, and 2023, we are conducting an Interim Final Run with data submitted as of the usual final risk adjustment data submission deadline for a PYs 2021 and 2022. We will use these Interim Final risk scores in a reconciliation payment run on the same schedule as we typically use for final reconciliation payments for a year. We will then, later, conduct a final payment reconciliation, using data submitted as of the final risk adjustment data submission deadline noted below.

The following table lists all initial, mid-year, and final risk score runs through the final PY 2023 risk adjustment data submission deadline, with relevant dates of service, and risk adjustment data submission deadlines in the order of future deadlines.
