Qualified Health Plan Directory Pilot Overview - Newsletter Article

The Qualified Health Plan (QHP) Directory Pilot in Oklahoma is now live!

To reduce provider burden and increase administrative efficiencies, the Centers for Medicare & Medicaid Services (CMS), in partnership with the state of Oklahoma, began work last year on a first-of-its-kind QHP Directory Pilot (“the pilot”). The goal of this pilot is to develop an automated, one-stop shop, statewide directory of providers and facilities participating in QHPs (including Stand-Alone Dental Plans) in Oklahoma, which will be accessible through the [Qualified Health Plan \(QHP\) Directory Pilot Portal](#) (“the portal”).

The pilot aims to improve data accuracy, lessen the burden on providers and payers, lower administrative costs, support interoperable data exchange, and ultimately improve patient and provider experiences. CMS intends this pilot to serve as a learning opportunity to inform a potential future National Directory of Healthcare.

We are excited to announce that the portal is officially open for use as of June 30 at [cms.gov/QHPDirectoryPilot](#)!

If you are a provider or represent a health care facility (organizational administrator) participating in a QHP in Oklahoma, we need your help to make this pilot a success! On average providers were able to **verify and update information in 8 minutes!**

Action Requested

Participating providers and organizational administrators (and/or their delegates) can log in to the [portal](#), review their prepopulated data, and either verify the data or correct any inaccuracies. Please complete this review no later than 30 days after pilot launch. Users should also be prepared to routinely update their data in the portal within 30 days of any change and verify all provider directory information at least every 90 days, in accordance with federal and state guidelines.

Issuers will be using data from the portal to update their respective websites, so those sites reflect the latest data for participating providers. This one-stop approach is designed to minimize the need for providers to update information in multiple locations across multiple plans during the pilot.
