I. SUMMARY OF CHANGES: PRMNAPRO in the FISS online parameter screen (MAP1171) is used to add providers to the Bundled Payments for Care Initiative (BPCI) and BPCI Advanced models. When the FISS batch job runs, the data in the online parameter screen is not cleared out. The Medicare Administrative Contractors (MACs) have to manually clear all fields before they can begin to enter new data on the screen. The UCR will modify FISS to clear the data from the enterable fields on PRMNAPRO during the batch process. This change will reduce errors by ensuring the MAC always starts entry without data that was previously updated.
