I. GENERAL INFORMATION

A. Background: The purpose of this change request is to update the Edit/Audit/Procedure Processing Criteria Report H99RBSCC that was initially designed with the implementation of UECR 10659 implemented with the July 2019 release.

Currently, the single or multi-state processor indicator on the H99RBSCC report is displaying a value of 'A' in the field titled ST and defined as field number 47. This does not match the value of 'Y', in which the MAC enters on the Edit Audit Maintenance - Edit/Audit AA/AB/AB2/Segment screen accessed with the use of mnemonic EA.

The H99RBSCC currently does not indicate if the information is extracted from the MACs User Acceptance Testing (UAT) region verses the production region.

The H99RBSCC report currently does not display the value of asterisks (**) representing that the edit or audit applies to all places of service submitted on a claim. This is an existing field on the report identified as field name Place of Service (POS) in field number 69.

The H99RBSCC report, currently, does not include a section that displays the information from the Related Procedures/Diagnosis Segments screen, accessed with the use of mnemonic DS.

The H99RBSCC report, currently, does not indicate if a Common Working File (CWF) error code, tied to an MCS audit, has System Control Facility (SCF) logic associated.

The field length of the edit/audit description in the header of the H99RBSCC report does not match the field length edit/audit description, in which the MAC enters on the Edit Audit Maintenance - Edit/Audit AA/AB/AB2/Segment screen, accessed with the use of mnemonic EA.

The heading sections of the H99RBSCC are not displaying in bold font.

B. Policy: There are no new policy changes associated with this instruction.
