## I. GENERAL INFORMATION

**A. Background:** The purpose of this Change Request (CR) is to modify the process to create and authorize overridable reason codes in FISS.

Currently, FISS has to hard code all overridable reason codes. The Medicare Administrative Contractors (MACs) authorize specific users to override a reason code in the Operator Control File, MAP1256 and MAP1257. The MAC enters each overridable reason code on MAP1256 with some exceptions that can be entered as a range on MAP1257.

The number of overridable reason codes now exceeds the number of fields in the Operator Control record. CMS and FISS determined that this is an opportunity to redesign how the overridable reason codes are created and authorized. The new process will reduce work for FISS and minimize MAC effort to authorize users for new overridable reason codes.

**B. Policy:** There is no policy impact.
