Memorandum Summary

- **Commission on Office Laboratory Accreditation (COLA) Action:** COLA notified the Centers for Medicare & Medicaid Services (CMS) of voluntary withdrawal from the full specialty of Pathology, effective June 30, 2010. COLA sent notification letters to their accredited laboratories on July 2, 2010 to inform them of alternative options for compliance.
- **CMS Central Office Action:** A Federal Register notice (CMS-2363-N) will be published on August 27, 2010.
- **Laboratory Role:** Each affected laboratory will need to contact their CLIA State Agency to declare their choice of the compliance options indicated in this memo.
- **State Agency Role:** Follow specific instructions provided by in this memo on how to handle laboratory requests for new applications or CLIA certificate changes in the data system and monitor and prioritize associated activities for these laboratories based on survey and enforcement status, outstanding deficiencies, complaints, or certificate expiration.
- **Regional Office Role:**

Background

In a Federal Register notice (CMS-2221-N), published February 23, 2007, COLA was granted deeming authority as an accreditation organization (AO) for laboratories in the following

specialty and subspecialty areas under the Clinical Laboratory Improvement Amendments of 1988 (CLIA):

- Microbiology, including Bacteriology, Mycobacteriology, Mycology, Parasitology, Virology
- Diagnostic Immunology, including Syphilis Serology, General Immunology
- Chemistry, including Routine Chemistry, Urinalysis, Endocrinology, Toxicology
- Hematology
- Immunohematology, including ABO Group and Rh Group, Antibody Detection, Antibody Identification, Compatibility Testing
- Pathology, including Histopathology, Oral Pathology, Cytology.

COLA recently provided official notice to CMS of its intent to voluntarily withdraw from the full specialty of Pathology effective June 30, 2010. A Federal Register notice (CMS-2363-N) is scheduled for publication on August 27, 2010.

If a laboratory performs only Pathology testing, it must either:

- Select another CMS approved AO for Pathology. The Joint Commission (JC), College of American Pathologists (CAP) or American Osteopathic Association (AOA). Once another AO is selected, the laboratory will need to apply to the new AO and contact the CLIA State Agency (SA) where the laboratory is located concurrently. The Certificate of Accreditation (CoA) will remain; or
- Contact the CLIA SA to obtain a Certificate of Compliance (CoC). A new CMS-116 will be required and a Certificate of Registration (CoR) will need to be issued.

If a laboratory performs testing in both Pathology and non-Pathology specialties, the laboratory may remain with COLA for accreditation of non-Pathology specialties. The laboratory must seek Pathology accreditation services from another AO or request a CoC for all specialties and subspecialties. It is not permissible to hold a Certificate of Accreditation (CoA) and a Certificate of Compliance (CoC) under one certificate. The SA receiving inquiries and requests from these affected COLA laboratories should ask the caller whether the laboratory currently holds a CoA or CoC.

Any COLA laboratory performing testing in the specialty of Pathology that fails to contact the CLIA SA and inform them of their accreditation or compliance decision prior to the expiration date of its current certificate will have its certificate terminated in the CLIA database. The certificate may not be renewed, and the laboratory will no longer be affiliated with any CMS-approved accrediting organization.

Process for CLIA SA

As discussed above, laboratories accredited by COLA, testing in the specialty of Pathology, must call the CLIA SA to declare their choice for alternate inspection services for compliance with CLIA.

When the lab calls, determine the existing CLIA number, verifying the demographic and specialty information in ASPEN. Laboratories may not hold multiple certificates, i.e., a lab at the same address under the same director may NOT hold a CoA for certain specialties and a CoC for other specialties.

If the lab chooses a second AO (JC, AOA or CAP) for pathology testing, or chooses a different AO that covers all testing, it will keep its accreditation certificate. As described in the Nov. 26, 2008 S&C Admin Info: 09-09, *Procedural Guidance for Clinical Laboratory Improvement Amendments (CLIA)* 1) *Form CMS-116 Changes that Require a New CMS-116 or Written Notification* and 2) *Potential Fraudulent CLIA CMS-116 Applications*: At a minimum, written notification from the laboratory must be obtained by the SA in an email, fax, or hard copy letter. The written notification must include laboratory name, CLIA number, name of the Laboratory Director and/or Owner, the change(s) being made, and the signature of the Laboratory Director or his/her designee. In lieu of written notification, a new CMS-116 form is also acceptable. Please note the CMS-116 must be completed in its entirety.

- The SA must indicate the laboratory's choice of AO and the corresponding specialties in ASPEN.
- On the Accreditation tab, add the second or replacement AO by clicking on the "Add" button and selecting the AO from the drop down list.
- On the Specialty tab, change the AO code on the corresponding 116 specialties to the replacement AO's code by clicking on the drop-down list.
- The survey specialty information will be updated by COLA and the replacement AO.

If the lab chooses to be certified by CMS for all testing, it will require a status change to a CoC. As described in the Nov. 26, 2008 S&C Admin Info: 09-09, *Procedural Guidance for Clinical Laboratory Improvement Amendments (CLIA)* 1) *Form CMS-116 Changes that Require a New CMS-116 or Written Notification*, and 2) *Potential Fraudulent CLIA CMS-116 Applications*: a new form CMS-116 MUST be obtained for this status change.

- The laboratory will first be issued a Certificate of Registration (CoR) as a result of the status change. This certificate is valid for up to 2 years.
- To process the status change in ASPEN, click on the "Status Change" button and enter the required information.
- Answer "no" to the correction question, and enter a new app type of 1 in the new app type field.
- The effective date will be determined by the date the lab contacts the SA requesting the change.
- On the specialty tab, remove the AO code designation on the 116 specialties.
- The survey specialty information will be closed out when the registration certificate becomes current.
- Once the State surveys the lab and determines compliance, the lab will receive a CoC.

Monitoring

Attached to this Admin Memo, is a copy of COLA's Pathology withdrawal notice to its laboratories and a list of all currently identified COLA laboratories performing testing in the specialty of Pathology sorted by State and region.

At this time, priorities for the SA include making the CLIA certificate changes as requests are received and survey each COLA laboratory that changes its status to a CoC. Priority should be given to any COLA laboratory changing to a CoC and identified by COLA with enforcement issues, outstanding deficiencies, complaints or expiring certificates. CMS Central Office will assist the ROs and SAs with identifying these laboratories. The RO, along with each SA affected, is responsible for ensuring all surveys and follow-ups are performed on these laboratories.

The reason for this change is that with only three percent of COLA laboratories enrolled in our Pathology program, it has become increasingly difficult to provide these services with patient care as our unwavering focus.

As I am sure you can appreciate, it is important for our surveyors and technical consultants to maintain their proficiency in Pathology in order to maintain the highest levels of expertise, and to ensure patient safety. Maintaining a required level of expertise is not feasible given the low number of laboratories in our current Pathology program.

At the same time, the cost to maintain the highest levels of quality and patient care for this small number of laboratories has become prohibitive. In order to ensure the accuracy and quality of the work performed under Pathology, COLA increased its staff and programs, hired a pathologist and cytotechnologists, and made other enhancements to our program. Rather than continue to raise our rates to offset these additional costs, COLA's Board of Directors made the difficult decision to withdraw from accrediting the specialty of Pathology.

YOUR OPTIONS IN LIGHT OF COLA'S DECISION

Please note, if you choose to continue testing in the specialty of Pathology, you must seek alternate inspection services by contacting your State Agency within sixty (60) days of July 1, 2010. (See enclosed list of State Agencies). Any COLA laboratory performing testing in the specialty of pathology that fails to contact the State with their pathology decision prior to the expiration of their current certificate will have its certificate terminated in the CMS CLIA database, per CMS policy.

1. If you perform only Pathology testing (including cytology, histopathology and oral pathology) you must seek CLIA inspection services from either:
 - a. Another CMS approved accrediting organization (AO) for Pathology (see enclosed list of approved providers). Once you have selected another AO, you will need to contact the CLIA State Agency where the laboratory is located and provide a written request of the change and apply to the new AO; or
 - b. The CLIA State Agency to obtain CMS certification where the laboratory is located (see enclosed list). You must file a new CMS- 116 application with the CLIA State Agency where the laboratory is located. You can obtain a CLIA application at the following link: www.cms.gov/cmsforms/downloads/cms116.pdf.
2. If you perform testing in both Pathology and non-Pathology, you may choose to remain with COLA for accreditation of non-Pathology testing; if you do so,
 - a. You must seek accreditation services for Pathology from another private CMS approved accrediting organization (AO). You may not combine both accreditation and CMS certification if you remain with COLA. You must notify your CLIA State Agency in writing of your AO choice for Pathology testing and apply to the new AO.
 - b. If your Pathology testing is performed at a separate location from your non-Pathology testing, or grossing is performed at a separate site, you must:
 - i. Apply for and obtain a separate CLIA number for Pathology from the State Agency where your laboratory is located, AND
 - ii. Seek inspection services from EITHER a CMS approved accrediting organization OR the State for CLIA certification for all Pathology testing at that location..
3. Alternately, if you perform testing in both Pathology and non-Pathology and choose not to remain with COLA, you may seek CLIA certification from either another CMS approved accrediting organization (approved for all of your testing categories) for a certificate of accreditation or from your CLIA State Agency for a certificate of compliance.

LABORATORIES COMPLETING THEIR ONSITE SURVEY OR DUE FOR SURVEY

For post-survey laboratories that have not yet completed their Plan of Required Improvement process, COLA will complete all follow-ups and review of all Plans of Required Improvement with your laboratory.

If you are currently scheduled for a COLA survey for Pathology testing, your COLA survey has been cancelled. Based on your decision of available options, you will receive further communication regarding the scheduling of a survey. In all cases your CLIA certificate will not expire and nor will you lose Medicare payment in the interim.

AFFECT ON OTHER TESTING SPECIALTIES

No other COLA CLIA specialties or subspecialties are affected by this decision. We will continue to promote excellence in laboratory medicine and patient care in all other areas of our accreditation operations through our program of voluntary education, consultation, and accreditation. A refund may be applicable, if qualifying conditions are met.

We sincerely regret any inconvenience that this change may cause. The COLA team stands ready to assist you throughout this repositioning. To underscore our commitment to facilitate a smooth transition of your pathology services, COLA will be contacting you to discuss your options.
