

# UNIFORM DATA SYSTEM (UDS)

## Years Data System Included Sexual and Gender Minority (SGM)-Related Data Elements 2016 - Present

### Data System Description

The Uniform Data System (UDS) is an annual reporting system that provides standardized information about the performance and operation of health centers delivering health care services to underserved communities and vulnerable populations. Its core components include patient demographics, staffing and utilization, selected diagnoses and services rendered, quality of care indicators, health outcomes and disparities, and finances and revenues of awardee health centers. UDS data on patient characteristics and clinical conditions are used to evaluate and improve health-center performance, ensure compliance with legislative mandates, and identify trends in health centers' impact on expanding access, addressing health disparities, improving quality, and reducing health care costs.

The UDS report is required for the following health centers:

- Health Resources and Service Administration (HRSA) awardees that receive federal funds under the Health Center Program authorized by section 330 of the Public Health Service (PHS) Act (42 U.S.C. 254b), which include the Community Health Center (CHC) (330(e)) program, the Migrant Health Center (MHC) (330(g)) program, the Health Care for the Homeless (HCH) (330(h)) program, and/or the Public Housing Primary Care (PHPC) (330(i)) program.
- Health Center Program look-alikes, which are health centers that do not receive federal funding but meet the requirements for designation under the program.
- Certain health centers that are funded under the Health Resources and Services Administration (HRSA) Bureau of Health Workforce (BHW).

### Reporting Methodology

The UDS report is completed annually by health centers, including Health Center Program awardees (under section 330), Health Center Program look-alikes, and BHW sites operating in all 50 states, the District of Columbia, Puerto Rico, the Virgin Islands, and the Pacific Basin. These health centers are required to report UDS data for the entire calendar year via the HRSA Electronic Handbook system.

### *UDS Report Components*

All health centers (Health Center Program awardees [under section 330], Health Center Program look-alikes, and BHW sites) complete the UDS report, which includes two components: the Universal Report and the Grant Report.

The Universal Report provides data on patient demographics, services, staffing, and financing for the entire scope of services. It is the source of unduplicated health center data for the reporting year, and includes 12 tables and 2 additional forms on health information technology (HIT) and other data elements (see Table 1 below).

The Grant Report consists of all or part of the data elements of the Universal Report tables (see Table 1 below for overlap between the reports). Grant Reports are only required from entities that receive funding under section 330. Health centers with dual designations are required to complete two UDS reports (awardee UDS report and the look-alike UDS report or the BHW UDS report) covering the approved scope of each service site separately. See Table 2 below for details on reporting requirements by health center designation.

The HRSA Bureau of Primary Health Care (BPHC) has responsibility for administration and oversight of the Health Center Programs under Section 330. HRSA aligns the selected quality of care and clinical health outcome and disparity measures in the UDS with the CMS electronic Clinical Quality Measures (eCQM), which are updated annually.
