*March 26- [OCR Settles Eighteenth Investigation in HIPAA Right of Access Initiative](#). The Office for Civil Rights (OCR) at the U.S. Department of Health and Human Services announces its eighteenth settlement of an enforcement action in its HIPAA Right of Access Initiative. OCR announced this initiative to support individuals' right to timely access of their health records at a reasonable cost under the HIPAA Privacy Rule.

*March 29- [HHS to Expand Access to COVID-19 Vaccines for Older Adults and People with Disabilities](#). As part of President Biden's announcement today that the administration will take further action to expand access to COVID-19 vaccines, the U.S. Department of Health and Human Services (HHS), through a partnership between the Centers for Disease Control and Prevention (CDC) and the Administration for Community Living (ACL), will provide nearly \$100 million to help increase vaccinations among older adults and people with disabilities. This effort will help advance the key goals of protecting those most vulnerable and advancing equity within President Biden's National Strategy for the COVID-19 Response and Pandemic Preparedness.

*April 1- [U.S. Department of Health and Human Services Launches Nationwide Network of Trusted Voices to Encourage Vaccination in Next Phase of COVID-19 Public Education Campaign](#). Today, the U.S. Department of Health and Human Services (HHS) is announcing additional measures to encourage vaccinations and increase vaccine confidence as part of the next phase of its COVID-19 public education campaign. The Administration is launching the COVID-19 Community Corps – a nationwide, grassroots network of local voices people know and trust to encourage Americans to get vaccinated. As part of the launch of the Community Corps, Vice President Kamala Harris and Surgeon General Vivek Murthy will meet with founding members on Thursday, April 1, as she begins championing the next phase of the public education campaign from the White House.

*April 1- [HHS Secretary Becerra Announces Reduced Costs and Expanded Access Available for Marketplace Health Coverage Under the American Rescue Plan \(Spanish version\)](#). Today, U.S. Department of Health and Human Services (HHS) Secretary Xavier Becerra announced that additional savings and lower health care costs are available for consumers on HealthCare.gov. The American Rescue Plan (ARP) has increased tax credits available to consumers, helping to reduce premiums and giving consumers access to affordable health care coverage.
