^ HCP COVID-19 vaccination rates and HCP Influenza vaccination rates for swing-bed providers are submitted by the parent facility in which the swing beds reside. For example, if the swing-bed exists within a Long Term Care Hospital or Acute Care Hospital, the measure data for that parent hospital type includes the swing beds within that facility.
