Statement of Work (SOW) June 7, 2018

1.0 Scope

1. DCCM needs to replace the existing CMS Stage Curtain with inherently flame retardant materials in accordance with industry standards. This SOW is to provide the replacement cost of the stage curtain.

1.1 Background

DCCM uses the Auditorium to host large conference for internal and external customers. Replacing the stage curtain is part of the LCF upgrades for the large conference rooms at central office. Replacing the curtain will enhance the over appearance of the auditorium and provide a better backdrop for video recording.

1.2 Objectives

Replace the existing CMS Stage Curtain with inherently flame retardant materials in accordance with industry standards.

1.3 Requirements

The contractor will remove the existing curtain and replace with a new stage curtain made of 25oz IFR velour charisma material. Raise the battens and tracks, connect all hangers and adjust to the proper height. After the curtain is replaced, reconnect the remote cable system adjusting the curtains stopping points to ensure the curtain will stop at the correct points. The black curtain will stay connected to the old track and not be moved except by hand. The job includes new track, pulleys, travel cable and all hardware as needed. The contractor will be bringing a tall ladder or scaffolding and will also have access to the CMS power lift if needed.

2.0 CODES AND STANDARDS

- (e) For every EIT product or service accepted under this contract by the Government that does not comply with 36 CFR 1194, the contractor shall, at the discretion of the Government, make every effort to replace or upgrade it with a compliant equivalent product or service, if commercially available and cost neutral, on either a contract specified refresh cycle for the product or service, or on a contract effective option/renewal date; whichever shall occur first.
